## CANNIBALISM

### CIA PRESS SPREADS CANNIBALISM FILTH

Oct. 5 (IPS)--As predicted in New Solidarity, the cannibalism propaganda campaign initiated by Rockefeller cabal spokesman Aurelio Peccei of the zero-growth Club of Rome, is spreading to the counterculture sewer. The Yippie rag Yipster Times has devoted its most recent centerfold to recipes for "eating the rich," while a Boston area anarchist sheet called Chomp has called on the American "movement" to found a new religion based on the culinary delights of cannibalism. This follows an article on cannibalism in the Museum of Natural History Magazine, written by a subhuman named Raymond Sokolov (previously employed by the New York Times), which compares human flesh to beef and features a recipe for cooking the brains of "any higher mammal."

As the Rockefeller cabal builds for the November World Food Conference in Rome, tens of millions of people are starving to death right now because of David Rockefeller's manipulations of world credit, fuel, and fertilizer. The cabal's psywar message to the working class is clear: no gas ovens this time; use your teeth instead.

FLASH: As reported by the CIA's Far Eastern Economic Review, a West Bengali Indian woman, desperate from famine, killed and ate her only child recently. CIA journals are determined to force cannibalization on the world as acceptable.

### NATURAL HISTORY MUSEUM PUBLISHES PLUG FOR CANNIBALISM

NEW YORK, Oct. 3 (IPS)--IPS investigators have uncovered the first instance where the Rockefellers' Zero Growth campaign for cannibalism is being subsidized by workers' tax dollars.

The current issue of Natural History, a magazine published under the auspices of New York's Museum of Natural History, carries an article entitled "One Man's Meat is Another Man's Person," written by one Raymond Sokolov. Under a thin veneer of super-civilized "wit", intermixed with pretensions to "objective" pseudo-anthropological investigation of "other cultures' eating habits," Sokolov implies that "true cannibals" are morally superior to the inhabitants of modern industrial society because "we hide from our killing." He concludes the article with a recipe specifically recommended for the preparation of "the brains of any higher mammal."

A call to Museum of Natural History public relations personnel today confirmed readily that the museum and its subsidiaries receive public funds, and also confirmed that publication of the article was in line with museum policy. The magazine's book review editor stated that she and Dr. Camera of the museum's anthropology department "helped out on the article for authenticity," and defended the article on the grounds that "we never advocated cannibalism as a food practice, we were just covering different food habits of different societies." She hung up when asked the purpose of the recipe.

The Labor Committees will demand of all Federal, state and city public officials directly or indirectly responsible for the funding of the Museum that they immediately repudiate the contents of the article and conduct a thorough public investigation of the Museum's function as a "cultural relativist" propaganda outlet for the Rockefeller family's stated intention to wipe out at least one billion people worldwide as the price of continued capitalist rule. The Museum is well.

known as a nesting place for subhuman creatures masquerading as scientists, such as former OSS operative Margaret Mead. Its emergence as a conduit for the Rockefellers' cannibalism line, as outlined by Club of Rome president and leading Zero Growth spokesman Aurelio Peccei last month, is prima facie evidence that payment of public funds should be withheld until an investigation is completed.

#### A Restaurant Parity

The article's author, Raymond Sokolov, is a former food columnist for the New York Times. A flabby, overweight, effeminate form of lower life, Sokolov is despised even by his former colleagues at the Times, who are themselves accustomed to printing filth on orders from Rockefeller without a murmur. When IPS called the Times in an effort to reach Sokolov and said "We're looking for a man who wrote an article called 'One Man's Meat is Another Man's Person'--do you know who that might be?", a reporter at the Food Desk replied "That must be Raymond Sokolov; he's the only one I can think of around here who would write something like that." Expressing her horror at the article, the reporter then informed IPS that Sokolov was no longer employed at the Times. Strenuous efforts are being made by the NCLC to indict Sokolov on behalf of the working class.

#### ONE MAN'S MEAT IS ANOTHER MAN'S PERSON (EXCERPTS FROM RAYMOND SOKOLOV'S CANNIBALISM ARTICLE)

*Like all forbidden fruits...cannibalism fascinates us.*

*The enigma basically remained until 1972. Survivors of a Uruguayan plane crash in the Andes, who were cut off from the outside world for weeks, in desperation ate fellow passengers killed in the accident. After their rescue, the survivors told Piers Paul Read who set down their story in the current bestseller Alive!--that after cooking the meat briefly (they tried it raw first) "the slight browning of the flesh gave it an immeasurably better flavor--softer than beef but with much the same taste."*

*This kind of testimony one can believe, especially from Uruguayans, who know their beef. It is also good news that human taste goods alternatives to soy-burgers are always welcome, and we can at last exonerate cannibal societies of the charge of unrefined savagery. Instead they were gastronomes.*

*...But who are we with our kill ratios and My Lais to question the civility of, say, Tupinamba warriors? To begin with they captured prisoners live, led them back through the great forest of the Amazon, and then allowed them to live for months in virtual freedom until the final blood rite. Prisoners were given wives, and thus shared their genes with the victorious village before they gave up their bodies in a ceremonial war game they were doomed to lose. The quartered body, according to an eyewitness account, was barbecued. Women and children rushed to drink the blood. Mothers smeared their nipples with it so that babies could taste it...*

*...the simple act of consuming human flesh, even when enshrined in ritual, is obnoxious to most people...It seems to arise from a fundamental sense of solidarity with one's species...*

*The real difference between us and the Tupinambas, however, is that we are more adept at making our cannibalistic acts and impulses into metaphor or else hiding them from view. We certainly enjoy the fruits of warfare, not in the form*

of flesh, but as territory, wealth or influence. True cannibals are less civilized only in degree.

Unfortunately (human) organ meats cannot be so easily disguised. Brains look, almost inevitably, like brains. The sight of those convoluted lobes forces us to admit that we are about to dine on mammal, and so we prefer less obvious cuts. Unlike the Tupinambas, we hide from our killing.

The recipe below takes account of this propensity. It is a supercivilized approach to brains, something like a souffle but sturdier...Serve it to picky eaters...

(A recipe for Pain de Cervele follows, which includes "1½ pounds of brains from any higher mammal.")

## AGRICULTURAL REPORT

### SPD AGENTS DETONATE CAP

Sept. 27 (IPS)--West German Chancellor Helmut Schmidt's Cabinet has decided to torpedo the agreement of the EEC (European Economic Community) Agricultural Ministers to raise European farm prices by 5 per cent. This decision by Rockefeller agents within the West German Social Democracy (SPD) has detonated political chaos and confusion throughout Europe, paving the way for establishing fascist labor-recycling institutions. Right on cue, NATO counterinsurgent Francois Mitterrand of the French Socialist Party has emerged, calling for "indexation" of workers' savings and the placement of these savings in an "Industrial Development Bank"--a policy direct from Hitler's Finance Minister Hjalmar Schacht.

The West German cabinet has laid down two conditions for its acceptance of the farm price increases: the removal of the unilateral national support measures with which France and Belgium undertook to aid their farmers this summer, and the "restructuring" of the entire Common Agricultural Policy (CAP). This German ultimatum on national subsidies is aimed squarely at the vulnerable French economy, whose banking system rests on the \$60 billion farm debt.

A preview of the CAP "restructuring" that Schmidt intends was contained in a Sept. 17 London Times article, which called for dismantling the EEC system of guaranteed minimum prices to facilitate the removal of "non-essential" farm population. The displaced farmers will then be recycled along with laid-off industrial workers into the "full employment" slave labor projects called for by Mitterrand, the West German metal workers' union head Loderer, and other social fascists.

The collapse of CAP also is expected to set off another round of frenetic peasant demonstrations, which will be crushed easily unless they link up with the industrial working class population. The German time-bomb was set to go off just hours before French Prime Minister Chirac's scheduled meeting with peasant organization leaders, whose base recently demonstrated for increases much greater than the offered 5 per cent. The new peasant upheavals will, according to the Rockefeller gameplan, rapidly "Italianize" the French government, at the same time that the fearful French Communist Party is lured into the arms of Mitterrand.

In West Germany, the cabinet decision will de-stabilize the government by furthering the ability of "Brown Maoist" Christian Social Union leader Franz Josef Strauss to incite Bavarian peasants against "greedy" SPD-led industrial workers. Rumors already have spread about the possible resignation of Agriculture Minister Ertl, a Free Democratic Party member whose base is peasant Bavaria. Should Ertl resign, the governing SPD/FDP coalition would be weakened severely. The new European crisis thus has been skillfully engineered to appear as a fight between farmers and workers, obscuring the real issue--Rockefeller's fascistization of the entire West European economy.

### FAMINE IN INDIA

UNITED NATIONS, NEW YORK, Sept. 26 (IPS)--Indian Foreign Minister Swaran Singh, in a speech to the United Nations General Assembly today, attacked

what he called the "limitless" appetites for consumption of some countries while more impoverished nations starve. Singh's speech, coming at a time of severe famine in India, indicates just how the Indian government can be manipulated to build support among other third world countries for Rockefeller's fascist food control and "development" schemes at the upcoming UN World Food Conference in Rome. The impending mass starvation in India has received daily coverage in the New York Times this week, in an effort to terrorize the U.S. working class into accepting further food consumption cutbacks while blaming the cuts on a "world food catastrophe."

India's food shortage is indeed serious: This summer's rice and coarse grains production is expected to fall 10 million tons short of the target set by the Indian government, necessitating imports. The New Delhi power supply has been cut severely in order to overcome acute drought in the two chief grain-producing regions, Punjab and Haryana. In Punjab itself, factories are closed three days a week to divert power for agriculture. Efforts have been made to transfer foodgrains from "surplus" to "deficit" states like West Bengal, Bihar, and Assam, where famine deaths already are reported, but there is clearly not enough to go around. The drought now has affected even formerly fertile regions of Northern India, such as Uttar Pradesh. This has compelled the government to treat Uttar Pradesh as a deficit state as well, restoring 20,000 tons cut from its monthly wheat quota so as to feed its urban population. Starving farm laborers from neighboring states are pouring into Punjab and Haryana, putting additional strain on the food distribution system.

#### Unnatural Disaster

Contrary to the New York Times psywar coverage, the Indian famine is not simply a product of "bad weather:" The already ravaged economy was pushed off the brink by Rockefeller's Great Oil Hoax of 1973. The effects of the drought would have been minimal if not for the power shortage resulting from the closing of Indian coal mines earlier this year. India's oil bill for 1973-1974 is expected to swallow up 60 per cent of its exports, even though oil imports were cut back from 3.7 million tons to 2.8 million. Furthermore, the Oil Hoax was directly responsible for raising Indian fertilizer prices 90 per cent, putting fertilizer out of the reach of many farmers and drastically reducing crop yields.

The Oil Hoax also furthered the de-mechanization of Punjab and Haryana, where cash-strapped farmers are now selling their tractors. This latter development coheres with Rockefeller's global policy of replacing the more expensive, mechanized farming with labor-intensive methods, in this case employing the slave labor of displaced farmworkers from other states.

#### FOOD PANIC HITS CANADA

Oct. 1 (IPS)--Montreal newspapers have been carrying daily scare headlines predicting grain shortages this winter throughout the Eastern Provinces. Due to a series of "accidents," including provoked strikes, lock-outs, and missing railroad boxcars, the grain in Montreal elevators is now down to three million bushels. This is enough for only three weeks of local consumption. Although the Canadian deck officers' strike affecting

Great Lakes shipping finally has been settled, ships will have to make several return trips to carry the grain; and by Dec. 15, the St. Lawrence Seaway will be closed. The Montreal press is quick to place the blame for the shortage and rising local bread prices: Canada did not fail to meet its export commitments.

The purpose of these newspaper scare stories is to divert Canadian workers from the real source of the food shortage this winter: Rockefeller-directed sabotage. To blame the crisis on "foreigners" is ludicrous considering the historical position of Canada as a major net exporter of grain. The food panic generated will be used in preparation for the UN's World Food Conference to convince workers that Rockefeller's food control measures - "world food security system" are their only protection from future "natural disasters."

The real story behind Canada's grain shortage dates back to the 1970 Canadian-American Committee report entitled "North American Agriculture in a New World." Long regarded by the Rockefeller family as their own private hunting preserve, Canada has served as the experimental testing-ground for the dismantling of agriculture throughout the advanced sector. The Canadian-American Committee is the Rockefeller's corporatist planning agency. It includes leading labor lieutenants (Trilateral Commission member and United Steel Workers President I.W. Abel; the Secretary-Treasurer of the Canadian Labor Congress (CLC) William Dodge; former CLC president Donald MacDonald; present CLC president Joseph Morris; and CNTU head Marcel Peptin) together with representatives of Rockefeller's own Chase Manhattan, First National City, Gulf Oil, Standard Oil, and other multinationals. Warning of so-called over-production of wheat in 1970 (in a world wracked by starvation and malnutrition!), the Committee produced its report calling for "alternative forms of production for part of the wheat acreage in the Prairie provinces." The plan immediately was implemented through the LIFT (Lower Inventories for Tomorrow) Program, which cut wheat acreage in half. Subsequent programs continued the switch away from wheat production, although higher yields increased production back to the previous level.

#### *Food for Slave Labor*

However, the crux of the Canadian-American Committee report is not its endorsement of Zero Growth in Canadian production, but is explicit call for third world labor-intensive projects: "While for some years the developed countries could produce enough extra food to meet the growing requirements of the developing world, the time is not too far distant when their requirements could not be supplied at reasonable costs." These kind-hearted Rockefeller agents agreed that Canada should extend food aid but only in cases where the food was used as payment in kind to slave laborers working on "public projects"!

This year, possibly one-sixth of Canada's grain crop has been destroyed, blamed by the press on the "mysterious" flooding which occurs annually due to lack of flood protection, in the Prairie Provinces. The flooding which delayed planting was followed by drought; and most recently crop losses were due to autumn frost hitting the late harvest. Even more suspect are the unending snafus in transporting the old crop. These include most recently: (1) A government-fostered labor dispute at Vancouver grain elevators, pitting workers against farmers who pay for grain storage; (2) A Canadian deck officers' strike against the Rockefeller-linked Great Lakes Carrier Association; and (3) the sudden lifting of a U.S.-Canadian agreement on allocation of shipping among U.S. and Canadian pilots in the Welland Canal, setting off a series of strikes.

## CANADIAN EGG SCANDAL

Sept. 27 (IPS) - Ontario egg producers have just announced plans to reduce their flocks by 500,000 birds. The announcement comes on the heels of a supposed "egg glut" and a heavy round of "watergate"-style exposes of Canadian egg-marketing boards which set prices for farmers. The marketing boards are blamed for the dumping of millions of eggs which rotted due to poor storage. Because Quebec and Ontario poultry farmers depended on the marketing of these eggs for payment, many of them have suffered severe losses. The press campaign is geared to eliminate the price controls, effectively wiping these farmers out. A similar operation was performed with the wheat board this summer, as government elimination of fixed prices plunged many farmers into bankruptcy.

## ONTARIO VEGETABLE FARMERS ENTRAPPED

Sept. 28 (IPS) - The frost which damaged corn and soybean crops in northern Illinois and Iowa also damaged several million dollars of fruits and vegetables in Southern Ontario. The farmers blame the government for reducing the migrant labor necessary to finish the harvest before the frost. At the same time, the government set up the farmers to get completely enraged at the hundreds of welfare recipients who refused to work in the fields despite government threats to throw them off the welfare rolls if they did not. Arriving on the scene of this contrived chaos and food supply destruction, the Ontario Labor Federation head demanded trade union participation in the government's Manpower and Immigration Board, ostensibly to insure "proper treatment" of migrant workers. This is a paper-thin coverup for the role which Rockefeller's labor lieutenants will play in the formation of corporatist institutions - overseeing the slave labor recycling of welfare recipients, laid-off workers, and bankrupted farmers.

## ROCKY'S FED PUTS SQUEEZE ON FARM CREDIT ADMINISTRATION

Sept. 22 (IPS) - The Rockefeller-controlled Federal Reserve System moved last June to discipline the Farm Credit Administration and cut its flow of loans to farmers, the Sept. 15 issue of Forbes magazine reveals. Several months ago, IPS reported that the Fed's "tight money" policies had crippled the ability of regional banks to provide credit to farmers. Farmers turned instead to the Farm Credit System which is owned 100 per cent by farmer-borrowers and is a traditional source of funds when private sources dry up.

As a banker for Chicago's Continental Illinois Bank put it: "They have been willing to make loans where more commercial banks were more timid. As farmers, they understand farmers. Their track record so far has been quite good."

During the fiscal year ending June 30, 1974, loans through the Farm Credit System (FCA) totalled \$25.4 billion, a 27 per cent increase over the previous year, accounting for one-quarter of all farm lending. Under the command of David Rockefeller who is strategically positioned on the board of its New York branch, the Fed acted to remove this obstacle to Rockefeller's planned destruction of North American agriculture. According to Forbes, sometime in June "concerned Federal Reserve Bank officials called in E.A. Jaenke, governor of the Farm Credit Administration, for a heart-to-heart talk. Jaenke immediately told his regional branches to simmer down and begin "to scrutinize loans more intensively to see that they were going strictly for productive purposes," rather than for speculative land and

commodity futures deals." After this, FCA lending began noticeably to contract.

### Oil Hoax Inflation

As any farmer knows, the expansion in farm-lending earlier this year had nothing to do with speculation; it reflected the spiralling operating costs set in motion by Rockefeller's Great Oil Hoax. Following the U.S. Department of Agriculture's elimination of government subsidies for farm acreage "set aside" (and lured by the speculator-fed high prices of 1973), farmers went all out to expand production, borrowing heavily in hopes of boosting their income. Then the Oil Hoax was detonated, tripling fertilizer and fuel prices and setting off inflationary price hikes for every item used by farmers. By mid-July 1974, the index of prices paid by farmers for production items was 15 per cent above the level of a year earlier. Farmers' expectations of high prices were dampened as livestock and grain prices tumbled below year-earlier levels on the commodity markets.

Even the Federal Reserve Bank of Chicago in its August 1974 report on "Business Conditions" attributes the increased lending not to "speculation" but to rising operating expenses and the financial losses of livestock producers, necessitating in some cases "renewals and extensions of existing loans and, in others, a refinancing of farm real estate to pay off operating loans." The Federal Reserve report also points out that the growth in short-term loans represents the "tightening credit practices of merchants and dealers," forced by the "tight money" policies of the Fed itself.

### U.S. NET FARM INCOME DOWN 17 PER CENT INDEBTEDNESS UP

Oct. 1 (IPS)—The Department of Agriculture's latest prediction that net farm income will decline 17 per cent this year from last year's \$32.2 billion high is a misleading statistic, covering up the true extent of the loss to farmers. As the New York Times and other Rockefeller press were quick to point out, if judged by net income figures alone, 1974 would be the "farmers' second best year." Actually, in the last three years, the total farm indebtedness in the U.S. has risen from \$62 billion to \$95 billion—a figure almost equalling the total gross farm income for 1974. Average farmer indebtedness has risen from \$21,000 in 1971 to \$33,000 today. Under these conditions, the impending second Oil Hoax and the related collapse of working class consumption levels will be enough to push thousands of small farmers over the brink.

Overall net income figures also mask the damage done to the livestock, poultry and dairy sectors targetted by Rockefeller to be destroyed first. A combination of artificially high feedgrain costs and the collapse of livestock commodity prices resulted in some cattle feeders losing as much as \$200 on each steer they fattened. The Department of Agriculture estimates that the total losses on cattle placed in feedlots during the last half of 1973 and first half of 1974 amount to \$1.3 billion out of the total \$2.8 billion equity capital employed to fatten those cattle. The catastrophic decline in the numbers of cattle placed in feedlots means that these farmers' withdrawal from production will show up as a shortage of grain-fed beef for working class consumers in the months ahead.

## SERIOUS FOOD SHORTAGES DUE IN U.S.

Oct. 1 (IPS)--Confirming IPS predictions, the latest Department of Agriculture statistics reveal that cutbacks in pork, poultry, egg and milk production will create serious shortages in the U.S. by this winter. Pork supplies will be down 10 per cent from year-earlier levels during the first half of 1975, with even greater shortages to follow. Heavy slaughtering by cash-strapped farmers has produced a four per cent decline in the numbers of hogs and pigs on farms. These herds will not be replaced, as sow farrowing intentions in September were down 10 per cent. Broiler placements for October-December 1974 have been cut by 10 per cent and egg output will decline three to four per cent this fall. Heavy production costs have discouraged hatchery activity for replacement of flocks. Finally, milk production in 1974 will fall below last year by two per cent, hitting the lowest level since 1948.

### THE PRESS

#### THE PRESSE KAPELLE: CIA PRESS AGENTS IN WEST GERMANY

Oct. 5 (IPS)--In the space of one year's time, West Germany has been transformed from the shaky last bastion of the postwar economic boom into the economically disarmed kingpin of the NATO/Rockefeller financial network's strategy to destroy traditional capitalist democracies in Europe by the middle of 1975. This rapid transformation threatens not only to throw more than one million German workers out of work by January, but already signals the internal disintegration of German workers' major weapon against the Rockefeller strategy: the mass-based German Social Democratic Party (SPD).

The death blow for West Germany's famed "economic miracle" was the Middle East war of October, 1973. Willy Brandt, then Chancellor and the world's most prominent spokesman for the policy of detente with the Soviet Bloc, suddenly found himself outside world political events. As the German "liberal" press network gleefully noted at the time, the devastating consequences foreshadowed by Rockefeller's Mideast War, and the consequent skyrocketing of petroleum prices, plunged Brandt into a passive state of depression as he sensed that his political career was under attack.

The reaction of tens of thousands of SPD workers to Brandt's resignation--moping confusedly outside of factory gates the next morning, waiting in vain for a word from their own party about what had really happened--pinpoints the striking organizational weakness of the postwar SPD. Forbidden by Allied Occupation forces in 1946 from starting their own national newspaper, the SPD, to this day, does not have a single significant propaganda tool directly at its disposal. For the entire postwar period, millions of Social Democratic workers were delivered into the hands of one of the most tightly controlled national press networks in the West. The political influence which this circumstance affords German-based collaborators of the Rockefeller financial-political network only is apparent in a period of profound social crisis, such as that introduced in West Germany by the Watergating of Brandt.

Superficially "democratic," apparently covering the spectrum of left to right wing opinions, the West German press is a smutty sewer of scandal-mongering, lies, dressed-up politics, and pornography. The strongest odor of sewage does

not emanate, however, from the right wing empire of the internationally infamous Springer. Rather, students of the British and American psychological-warfare schools found their nesting places in the less conspicuous self-proclaimed "liberal" press. While the mass-membered SPD must crawl for press coverage, the tiny Free Democratic Party, the direct successor of the Liberal Party of Hitler's Finance Minister Hjalmar Schacht, controls the bulk of internationally respected non-right wing publications. Only when seen in the context of the extensive propaganda and political organizing activities of the "liberal" press network does the significance of Springer's "loony" jamboree of mass consumption anti-Communist tabloids and weeklies become clear: Springer is the countergang to the "liberal" sewer. Thus in calculated fashion Rudolf Augstein, editor of Der Spiegel and little darling of British intelligence officers during the occupation, runs repeated "exposes" and "polemics" against his public arch-enemy Axel Springer.

### The Trilateral Connection

The West German liberal press network is a low-key hierarchical apparatus whose tentacles extend into every pore of society. Each node of the finely tuned network has its assigned special task and characteristic "style." Peddling hip pomography and sexual bestiality (partner-swapping, homosexuality) to petit-bourgeois, government and student layers, the "liberal" press swings around with union-busting demands and proposals for deindustrialization in the advanced sector in its mass-circulation dailies read by political workers.

The pyramid as a whole is controlled by a team screened by press cards and journalist certificates: The pyramid is dominated by active NATO and CIA-connected operatives. A hint of the organizing activity of this top layer is given by the success of Der Spiegel magazine, run by a specially trained team pulled together by British intelligence in 1946 under Spiegel editor Rudolf Augstein, in toppling the Adenauer government in 1963 on the basis of concocted "military information" forwarded to the Spiegel team by the Hamburg head of the German equivalent of the CIA.

The highest level of this Presse Kapelle (press orchestra) is in the hands of the editorial board of the more select, lower-circulation weekly Die Zeit, run by Theo Sommer, a member of David Rockefeller's supranational fascist shadow government, the Trilateral Commission. Sommer, trained out of NATO's Institute of Strategic Studies, worked "under" Helmut Schmidt during the latter's stint as head of West Germany's defense ministry. During that period Sommer's actual role as Schmidt's control agent materialized in Sommer's authorship of a 1970 White Paper on domestic military reform. In this document Sommer lays out, indirectly, his own relationship to the Rockefeller supragovernmental conspiracy by admitting that West Germany's land troops would be of no use in a confrontation with the Soviet Bloc. Reformation and expansion of a West German land army—the White Paper implies—is necessary to meet head-on Western European working-class ferment.

### The Press and The Military

The West German Defense Ministry and related intelligence agencies were the favorite hang-out of these "journalist-politicians" under the Brandt SPD coalition government. Their initial motivation for abandoning their low-key cover is clear: Analogous to the SPD's small coalition partner, the Schachtian Free Democratic Party, these "journalists" saw their immediate goal as a "bulwark

against socialism."

Operating out of the military machine, their sights were already set on the longer-range goal of preparing the successor to the SPD-run government. During Sommer's tutorship of Schmidt, a reorganization of the Bundes Nachrichten Dienst (Federal Intelligence Service) was proposed. The SPD candidate for Vice President of the BND, Dieter Eloetz, was emphatically rejected by the national Presse Kapelle as "too political for the job." Their own candidate? Sommer recommended Hans Detlev Becker for the position, a long-term associate of former Nazi Intelligence Chief Gehlen, who capped his intelligence career by working for the West against the Soviet Union. Becker's official employment address remains to this day the Chairman of the publishing house of Der Spiegel. Becker's own training prior to Allied Military Occupation was in the Nazi High Command, Radio Counterespionage Division.

Explicit domination by the "journalist-politicians" of the Defense Ministry eventual led to the appointment of former Spiegel editor Schmelz to the deputy chairmanship of the military planning staff in early 1974. The control which the Presse Kapelle has over the government was best expressed by Sommer when his junior partner, Helmut "Judas" Schmidt, found his way into the Chancellery. While Spiegel played low, Sommer greeted his underling with a three thousand-word open letter, explicitly describing their long-term cooperation in the British military establishment's (with NATO connections) Institute for Strategic Studies, and warning the new Chancellor that everyone recognized that he was "transitional."

#### First Detente; Then Cold War

The Spiegel-Die Zeit pyramid expands on the bottom with two mass circulation dailies, the Frankfurter Rundschau and Munich's "liberal" Sued-Deutsche Zeitung. In the name of "sane" international capitalist economic policy, these mild-mannered, open-minded dailies transform into a coven of furies at the sight of French politicians attempting to hold off the Rockefeller onslaught. As Sommer's own membership on Rockefeller's Trilateral Commission demonstrates, the long tradition of anti-French slanders in the Frankfurter Rundschau and the Sued-Deutsche Zeitung are a significant part of the contribution they have been making over the 1960s to the destruction of national bourgeois parliamentary government in Europe. With "progressive" contempt for the "disruptive" (to Rockefeller) character of French nationalism in bourgeois and pro-Communist layers, these journals write homilies to "internationalism," providing a "sane" popular image of Sommer and the Trilateral Commission's plans to turn Europe into a cluster of banana republics. The nationalist content of this propaganda becomes clear whenever these "liberals" project their horror at the "chaos" in Italian politics, or the "trade-union state" of Britain, countering to that the relative "good will" of such German "working-class leaders" as the Metal Workers' president and Trilateral Commission member Eugen Loderer.

Screaming above the chorus of protest against former French Foreign Minister Jobert for his holding action at last January's U.S.-controlled energy conference ("he didn't know how to read until he was 14" was the way the Rundschau put it), these two sewers overflowed with applause ten days ago when Helmut Schmidt's cabinet decided on an onslaught against the French at the Agricultural Ministers' meeting. The Zeitung was in the forefront of

an early 1960s press assault on the cooperative relationship which Chancellor Konrad Adenauer had developed with the one consistent voice of opposition to American domination of Europe, that of Charles de Gaulle. One of the greatest points of attack against de Gaulle was his support for a greater Europe, including the Soviet Union, to hold off American domination.

Rockefeller's international political strategy now necessitates a strong wave of anti-detente editorials and commentary from the West German press pipelines. Preparations for this have been made. The Sued-Deutsche Zeitung, for one, ran an initial Brown Mao endorsement of Red China, praising the simple, labor-intensive work ideology of the Chinese workforce. Aware of the fear which every endorsement of Mao produces in the Soviet Union, the Zeitung has shown its readiness to copy the line of the two-pronged strategy of Germany's biggest Maoist, Franz-Josef Strauss: Pro-Chinese means an anti-Soviet assault on the living conditions of the advanced industrial working class. The Rundschau, maintaining its slovenly "lefty" tendencies, has had a hey-day, publishing a rash of articles by its Washington-based correspondent Monika Metzner on the disclosures of CIA involvement in Chile. Metzner's articles, tedious cribs from the Washington Post and the New York Times, are simply funnels for the CIA's own self-destruct plans, as it disperses into such supranational agencies as the Trilateral Commission. There is no question that Metzner herself understands the actual content of the recent rash of CIA "exposures": she attempted to perform service for that dirty laundry outfit in the beginning of 1974 when she posed for three months at the National Headquarters of the Labor Committees as an interested reporter who wanted a scoop on an American left group which was making claims about the CIA. Her final product, a cheap slander job printed five months later when she had dropped all contact with the Labor Committees, attempted to discredit the Labor Committees as hysterical paranoiacs who insanely believed that the CIA was engaged in a massive assault on their tiny forces. Contrary to Metzner's swinish pose as an SPD sympathizer, the rag which she furnishes has been primarily under FDP influence since the 1950s.

The Rundschau's history provides an excellent example of how well the "liberal" press and its political allies in the FDP understand their task as anti-working class controller of the SPD. In 1952, Herbert Wehner, leading SPD parliamentary figure and political organizing expert, approached Rundschau editor Gerold (an SPD member), attempting to get a commitment from him to use his paper as a nationally influential SPD propaganda organ. Promoting the disgusting "liberal" mask of journalistic "objectivity," Gerold used Wehner's proposal as a pretext to quit the SPD and publicly slander Wehner, employing that all encompassing eyebrow-raising liberal insult "Stalinist."

The major preparation for the current anti-detente onslaught was the rumor-mongering campaign organized by Der Spiegel against Willy Brandt months before his resignation over the "spy scandal." Attuned to Brandt's demoralized response to the Mideast War, Spiegel began speculating about a Brandt resignation at that early date. The impunity with which the non-elected "journalist-politicians" proceed on their course of formulating government policy is ironically demonstrated by their earlier role in setting up the initial basis for the policy of detente itself! Conscious of Soviet susceptibility to soft line Social Democratic types, and absolute Soviet dependency on East-West trade for economic development, Theo Sommer was in the vanguard of the turn away from cold war to a policy of reconciliation! At that early date the main collaborator in the SPD who worked with Sommer was not Brandt, but junior Helmut Schmidt.

For the real masters of the press pyramid, the pharaohs of the U.S. conspiracy and NATO, detente was a necessary phase in lulling the Soviets to sleep in preparation for the more significant hard-line no-compromise demands already in the works for the 1970s. The SPD was well located as the singularly qualified political force to court the somnolent Russian bear. In 1965, in a book describing his personal visit to East Germany, Sommer announced the inevitability of a period of detente. One year later, Helmut Schmidt also took his vacation on the other side of the wall, gaining much coverage and praise from the CIA's own New York Times.

By 1974, however, the courtship was over and the phase of deception and abuse of the Russian bear was scheduled to begin. Willy Brandt, a consciously created symbol of detente, long associated by European workers with their fervent desire for peace and trade with the Soviet Bloc, had to be removed --fast. Suddenly, Gunter Guillaume, a member of Brandt's staff for no less than three years, was discovered to be an "East German spy." (See IPS No. 5, "Double Agent: IPS Cracks CIA's Network in Europe," for full exposure of this CIA operation.)

Theo Sommer aptly described his own conception of the role he has to play from the top of the pyramid in a lead Die Zeit editorial soon after the CIA's removal of Poor Richard Nixon. Sommer, batting his eyes at close associates in the U.S. press cabal, specifically praised the New York Times and Washington Post as "the defenders of democracy in the U.S." Reflected Sommer, "If it hadn't been for the New York Times and the Washington Post, Nixon might still be in power."

#### FUSION REPORT

##### AEC TO MAKE NOMINAL FUSION DECLASSIFICATION IN RESPONSE TO NCLC CAMPAIGN

Sept. 26 (IPS)--IPS has just learned from informed sources that the Atomic Energy Commission plans to declassify some aspects of laser and electrical beam fusion research. Scientific papers submitted to the American Physical Society Plasma Physics Division for their upcoming conference in Albuquerque, New Mexico October 28-31 contain the information to be declassified. Previously, the AEC had classified as "top secret" the most essential data on laser and electrical beam fusion under the Sigma Weapons Rules. While the AEC's move has political significance, the scientific data to be released is of nominal value. The only "secret" of laser and electrical beam fusion research is that no meaningful research was being done; the Sigma top secret classification was simply to cover up the AEC policy of suppressing research and development of controlled fusion. The AEC's planned liberalization is an obvious attempt to stem the successful Labor Committee campaign--creating ferment among scientists and engineers--for the crash development of controlled fusion.

Controlled thermonuclear fusion would furnish humanity with a virtually inexhaustible source of safe, clean energy together with a revolutionary new technology capable of producing abundant supplies of essential raw materials and industrial chemicals--all at a fraction of their present social cost. By making readily available a cheap, abundant supply of

energy, thermonuclear power would provide the material basis for rapidly accelerating the standard of living of the world's population beyond that currently experienced only among the most skilled layers of capitalist society.

Initial expenditures on the order of 15 to 20 billions of dollars will be necessary in order to maximize the rate of progress during the primary five year research and development phase. Based on the knowledge of leading physicists and other specialists collaborating with the Labor Committees, there is no reasonable doubt that with the mobilization of industrial and scientific resources on a world-wide scale, pilot fusion power plants will become operational by the end of this decade and find significant application to the world economy throughout the 1980s. The mere co-mitment to such a development program removes the need to restrict current consumption of existing energy resources.

The same Rockefeller-led multinational interests, who have imposed a Malthusian crisis of shortages and de facto technological stagnation on the peoples of the world in order to insure their continued dominance of the world economy, systematically have sabotaged the development of controlled thermonuclear fusion.

#### Fusion Suppressed Since 1952

Ever since the first hydrogen fusion device was exploded at Eniwetok Atol in 1952, scientists have known that energy could be produced with fusion. The only method to produce net energy, high density inertial confinement--the same system used in the H-bomb--has been totally suppressed with respect to its peaceful applications. To produce controlled fusion with this approach, the atom bomb (which is used to spark the fusion process in H-bombs) would be replaced by an electrical spark or burst of laser light. Since the largest conceivable spark or light burst could "burn" only less than a milligram of fusion fuel (enough to create the equivalent impact of a fire cracker), such a system does not have weapons applications.

Three areas of scientific information important to developing laser or electrical beam fusion have been kept classified: (1) The computer program used at Lawrence Livermore Lab to simulate hydrogen bombs and based on the Monte Carlo method; (2) The actual data from H-bomb explosions and the theoretical implications of the results; (3) Target design of the pellet of fusion fuel which would be compressed and then ignited by the spark or burst of laser light. The minute amount of research on target design is what will be declassified at the Albuquerque meeting.

#### NORTH AMERICA

#### UAW GOONS ATTACK LABOR PARTY; WORKERS RESPOND NATIONALLY

NEW YORK, Oct. 4 (IPS)--Yesterday 18 United Auto Workers goons led by the president of UAW local 1435 attacked a Labor Party electoral rally outside the Toledo Chrysler plant in Perrysburg, Ohio. One Labor Party member is in the hospital with a broken nose and three broken teeth.

ALSO yesterday at a select meeting of newspaper and wire service editors in San Francisco, Nelson Rockefeller ripped off his mask with his declaration of war against the Soviet Union. Violently attacking the Soviets, Rockefeller lied that the Soviets "conned the United States" on the 1972 wheat deal, and he encouraged the assembled press to explore for ways to "make capitalism work" and foist the 1974 Oil Hoax on the world.

Rocky's hired hand Leonard Woodcock, President of the UAW, is following Rockefeller's lead with the most vicious attack on the United States working class since the McCarthy era. Six weeks of intensifying harassment coordinated against the International Caucus of Labor Committees and the working class both here and in Europe were capped by yesterday's Toledo attack. Woodcock is trying to launch another red-scare witchhunt in the labor movement, trying with this assault to terrorize the working class away from politics and into submission to Rockefeller's slave-labor mills.

This effort to gear up an anti-communist witchhunt is being directed out of the Trilateral Commission, the Rockefeller family's supranational fascist shadow-government, on which sit David Rockefeller, I. W. Abel of the United Steel Workers, several European trade union officials--and Leonard Woodcock.

#### National Pattern

The nationally coordinated scope of this attack is obvious: Yesterday at the same time as the Labor Party rally in Toledo was attacked, three Labor Committee members were arrested during a Labor Party electoral rally near Buffalo at the Ford Hamburg auto plant in Hamburg, New York on a "parking violation." Incredibly, bail was set at \$150 and one organizer was held in jail overnight!

Sept. 25 at a UAW "Health and Safety" conference in Cleveland, Ohio UAW subregional representative Yates and three goons assaulted Labor Committee members during a press conference given by Woodcock, hitting the organizers in full view of the press and Leonard Woodcock. Yesterday the Perrysburg-Toledo police illegally refused to accept charges pressed by the hospitalized Labor Party member against the UAW goons in this most recent attack.

#### UAW Blunder

In yesterday's Toledo attack the UAW made a serious blunder. While TV cameras from WTOL-TV (a CBS Toledo affiliate) ground away and with a legal observer on hand, UAW local 1435 president John Sedlock and his 18 goons--all with UAW local 1435 badges prominent on their jackets--charged a legal electoral rally of Labor Party members which included one autoworker. Throughout the attack, although police were nowhere to be found, Perrysburg police chief McGriffin was watching the episode from inside the plant on the in-plant security camera! UAW bureaucrats around the country are growing painfully aware of the magnitude of this mistake as angry workers call them to demand that they stop interfering with the political rights of the working class.

Exactly one week before the Toledo attack, Labor Committee National Chairman Lyn Marcus testified before the Senate Rules and Administration Committee opposing the confirmation of Nelson Rockefeller as Vice President.

Despite tight press black-out of the testimony, orchestrated by CBS-TV, American workers understand fully that the National Caucus of Labor Committees/U.S. Labor Party is the only organizing force fighting to stop Rockefeller. The UAW's blunder yesterday is a frantic effort to prevent industrial workers from linking up with this political movement.

### Press Black-Out

National network CBS-TV is leading the centralized press black-out of the internationally significant Toledo news story. WTOL-TV, a CBS affiliate, aired its film of the attack twice. The first time the coverage was honest and straightforward; the second time, a few hours later, the coverage began with local president Sedlock declaring: "The UAW has been fighting communism for 30 years." Although WTOL sent the film to CBS national headquarters in New York City last night--and CBS in New York has acknowledged to Labor Party callers its receipt of the footage--CBS refuses to air the film nationally, despite intense worker demand. The Associated Press is following the CBS lead, refusing to run the story on the wires, although WTOL sent it to AP's Columbus bureau and calls from workers have forced AP in Columbus to forward the story to New York. The major national press is complicit in Woodcock's terror drive against the working class--and American workers know it.

### Working Class Counterattack

The extraordinary level of working-class motion and worker response to yesterday's assault stems from political workers' identification of the attacks on the Labor Party with the vicious slave-labor drive against the entire class in factories, ghettos, and unemployment centers across the country. Industrial workers grasp the relation of Woodcock's implementation of concentration camp conditions in the plants. The American working class knows that an attack on the Labor Party is Rockefeller/Woodcock's attack on the political rights and right to exist of the entire class in this depression.

Workers across the country are demanding of the press that this international news be covered. Five CBS affiliates in the Midwest have complained to New York CBS that they are being "harassed" by scores of calls from angry workers. The press and UAW bureaucrats are feeling the heat of working-class anger as never before. Today local 1435 president Sedlock is "sorry" about the assault--abjectly apologizing to workers throughout the region and state calling him! One UAW official has his lawyer answering his home phone! Workers are putting the heat on any member of the press, police, or UAW bureaucracy conspiring to revive witchhunt terror against the working class.

In Toledo the Labor Party is seeking injunctions and damages against the UAW and the police. The local ACLU is taking the case. Although to date the police have refused to accept assault charges against the goons, Monday, October 7, the Toledo prosecutor will view the film footage of the incident and the Labor Party will demand acceptance of the charges.

In Buffalo the Labor Party is petitioning for an extension of the injunction already won against the Buffalo police to apply to Hamburg, New York and Tonawanda, New York, sites of yesterday's harassment and arrests.

Successful Labor Party rallies are in progress throughout the Midwest--since yesterday, numbers of workers have joined the Labor Committees.

Last night a worker on the night shift at the Toledo Chrysler plant where the attack occurred called the Labor Party office to report that the plant was buzzing and to ask for a briefing on Labor Party "plans to take over." Wednesday, Oct. 9, the Labor Party will hold another electoral rally outside the plant at the site where yesterday's attack took place.

ROCKY RIPS OFF DETENTE MASK;  
BLAMES SOVIET UNION FOR FOOD CRISIS

Oct. 5 (IPS)--This week Nelson Rockefeller ripped off his mask, unleashed his full "Critical Choices" fascist program, and tore the tattered cover off the charade of Soviet-U.S. detente. Speaking Oct. 3 to a select audience of United Press International editors in San Francisco, Rocky lied that the Soviets "conned the U.S." on the 1972 wheat deal because the Soviet system of Communism "doesn't work, but capitalism does." Now, Rockefeller said, "we have to figure out how it (capitalism) is going to keep on working; we have to learn to make the necessary critical choices that are necessary."

The UPI editors don't have to guess at these critical choices. Rocky treated them to a parade of his flunkies from the Commission on Critical Choices:

\*Henry Diamond, the Executive Director of the Commission, ranted: "The era of cheap energy is over, the era of cheap food is over, the government in the wings must come forward." Diamond flatly instructed the assembled editors to brainwash the public into choosing fascism.

\*Wilson Riles, California Superintendent of Education and Critical Choices Commissioner, added: "The era of educating our children is over." Then one of Rocky's pet physicists laid out Rocky's slave-labor program for primitive coal gassification, saying that energy and "national defense" are inseparable.

Rockefeller's speech itself was significant for his vicious attempt to pin the starvation of millions on the Soviets. This deliberate "news leak" was designed to brief UPI on Rocky's revival of cold war sabre-rattling.

Because of the scheduled collapse of world finance during September and October, and the scheduled turnover of governments throughout Western Europe in the coming weeks, Rocky is bringing his gameplan for world rule into the open. He is targetting the enemy—the Soviet Union and the international working class.

In a press conference following his speech, Rockefeller bared his fangs at American workers: "I don't care how many letters and calls come into Congress opposing my nomination, just so long as I get to be Vice President."

Outside the hall a few hundred countergang CIA-"leftists" demonstrated. A New Solidarity reporter casually asked one of the six policemen on guard whether he thought a half-dozen cops were enough to hold back the demonstrators if they rushed the hotel. "Don't worry," the cop replied, pointing to the crowd, "half of them are cops, too."

## WHO GOVERNS CANADA?

Oct. 4 (IPS)--Canada's Federal Parliament convened in Ottawa last week for the first time since May 8 as deepening economic catastrophe overwhelms the country. Vital transport lines for Canadian exports and food supplies have been blocked for over a month. Large development projects have been proposing "ultimate solutions" for increasing masses of unemployed; food prices have skyrocketed this summer, coupled with soaring electrical rates, gas price hikes, and threats of shortages.

The fact that there has been no Federal government activity for months has intensified the crisis atmosphere in Canada. Far from calming Canadians' fears, the opening of Parliament is actually raising doubts as to whether there will be any Federal government at all.

### Military in the Wings

Last week the Toronto Financial Post revealed that the Canadian military has been gearing up to take over many of the functions normally performed by elected government. For example, Commanding Officer W.H.D. Hughes of Summerside Military Base recommended last week that the military take over Canada's transportation system. The Financial Post also announced that training of government and business officials is now being handled by the military's National Defense College, where they are trained in brainwashing techniques, with field trips to the Arctic and Latin America.

Canadians have gotten a taste of things to come if Rockefeller is not prevented from destroying bourgeois democracy in the country altogether. The opening of Parliament was marked by an Indian rights demonstration outside the Parliament building. Provoked by police agents in the Marxist-Leninist Party and special tactical police, the demonstration became a bloody police riot. While chaos reigned without, Prime Minister Pierre Trudeau brought chaos inside. He dumped 68 new legislative proposals on the members of Parliament--enough to keep them bogged down until next spring. In a press conference Oct. 2 Trudeau acknowledged this, expressing concern that Parliament was fast becoming irrelevant, spending "too much time on trivia."

### CORPORATIVIST MANPOWER BOARDS TO RUN CANADIAN SLAVE LABOR

Oct. 4 (IPS)--Sept. 17 David Rockefeller announced to a meeting of Canadian bankers that \$500 billion will be invested in Canadian slave labor energy development projects in the next 10 years. This week the Canadian government and the Ontario Federation of Labour moved toward corporatist control of manpower policy to ensure a profitable return on this investment.

Government officials, using the plight of migrant farmworkers in Ontario as a cover, are now advocating increased use of government manpower boards for setting work standards and finding jobs. This would totally eliminate all union control of work conditions and hiring halls.

Despite this weakening of union influence, the head of the Ontario Federation of Labour, representing 600,000 workers in Canada's industrial heartland, echoed this policy with a left cover demand that the Federation should co-determine manpower policy on the government's board.

The impetus for this chorus of "concern" about unemployment is a chaos and confusion operation contrived by the government to disrupt the Ontario harvest. Immigration boards have shut off the flow of migrant labor while promising that conscripted Canadian welfare recipients would work off their checks in the fields--knowing that many will refuse.

Combined with Rockefeller's strangulation of agricultural credit, this squeeze on farm labor is forcing many farmers to sell out to government or Rockefeller-controlled food processors. Farmers' holdings are slated to be combined into giant plantations worked by newly unemployed industrial workers and enslaved welfare recipients. The manpower boards are intended to oversee precisely this vast recycling operation.

#### AFRICA REPORT

##### ROCKEFELLER ALLIES PLAN "TOTAL ONSLAUGHT" ON AFRIKANER WORKING CLASS

Oct. 5 (IPS)--A combine of white Afrikaner businessmen and professionals under Rockefeller's control intends to demolish vicious white notions of racial superiority and self-sufficiency, only for the purpose of making the Afrikaner submit to the Rockefeller mass-murder blueprint.

The staged anti-Frelimo counter-coup attempt Sept. 7 in neighboring Mozambique provided an occasion for such dirty work by manipulating the whites' fears of "raging black hordes." As a wave of controlled chaos and panic engulfed the Mozambique city of Lourenco Marques, South African newspapers Vaderland and Transvaler of the ruling Afrikaner party printed ludicrously exaggerated scare headlines that blared "2000 DEATH TOLL" and "2500 MAY BE DEAD"--lies designed to crack the "fearless" Afrikaner exterior to reach the fear within. The South African Broadcasting System "declined to reverse its report of 30 deaths in Beira at a time when no one could find more than five deaths in all Mozambique," according to the Johannesburg Star.

Such deliberate terrorizing of the working class is part of a strategy whose "acceptable" side now is acknowledged boldly by the new Chief of the Army whose rise to the top has been unusually rapid. In the words of Army Chief Magnus Malan, it is "important to develop beyond the purely military, to educate the population...it's got nothing to do with apartheid...We must make a total onslaught on the large uncommitted majority not by weapons but by changing the true disposition of the population. We must ask if we are providing enough opportunities in the Homelands. The things that matter are educational opportunities, communication between Black and White, upgrading the social structure."

Malan must have been deeply satisfied with those psywar headlines and the activity of the very same newspapers in indicating what terrified Afrikaners are now supposed to do. Die Vaderland opened its pages to a group of Afrikaner academics who announced the necessity for "an order in which the urban African, the Coloured and the Indians are included with White South Africa, and the emphasis should fall on full human rights for all." Die Transvaler's editor wrote that "a whole revolution in thinking and living patterns must come in a short time...the picnic is over." Under

the guise of "full human rights for all," Africans, Indians, and Coloureds are soon to be given a major share in ruling the country.

### Multi-Racial Slave Labor

The secret is that only such a multi-racial government will have sufficient credibility to get away with imposing on all race groups the policies of slave labor (ever-increasing labor intensity) and selective outright starvation which the Rockefeller-Mellon-Morgan ghouls have announced publicly. "Full human rights for all" no doubt be written over the entrance to every mine and field. While the Hitler period cannot yet be referred to openly, Professor D.J.J. Botha of the liberal Wits University has explained that South Africa's "accelerated development" should be accomplished by following the path of postwar West Germany. (There the Allies applied Hitler's methods of food control and labor intensity to accomplish the "German miracle.")

The psywar "total onslaught" described by Army Chief Malan also is being pushed through the Afrikaner universities. The Institute of Urban Studies at Rand Afrikaans University is using "highly personal" questionnaires to construct psychological profiles of the population. When they ask, "In which respect do you disagree with the political party you support?", the question behind the question is: How can attitudes be manipulated to pry the Afrikaner working class loose from its traditional, liberal-hating leadership? Stellenbosch University now is practicing the psywar art of futurology -- "predicting" the very developments Rockefeller seeks to engineer, as a way of softening up the population. Under the sponsorship of Afrikaner capitalist Anton Rupert and with the blessing of the criminally Zero-Growth Club of Rome, Stellenbosch has installed a Unit for Futures Research. Demoralized, directionless Afrikaners are meant to submit to an oracle "more scientific" than the patriarchal volk leaders in their past.

One key operative pops up on every front -- Simon Biesheuvel, protege of fascist psychiatrist John Rawlings Rees. Biesheuvel has spent years in studies designed to help select and manipulate African "boss boys" to extract the last drops of sweat and blood in the mines. Recently exposed by New Solidarity, Biesheuvel now is turning against the Afrikaner unions the arts of manipulation he sharpened to a fine point at the expense of blacks. Afrikaner workers will be jarred rudely from the infantile illusion that their privileged existence was a matter of divine decree. Working hand-in-glove with Biesheuvel is C.P. Grobler, secretary of the Confederation of Labour, who leads the onslaught against the Afrikaner unions from within. Unable to provide any working-class leadership himself, Grobler invites parliament to bring black and white labor together by some unknown alchemy. The predictable result, as in the U.S. "affirmative action" program, will be black and white at each other's throats -- preferential hiring of blacks and firing of whites.

### Trojan Horse

The strategy of the Rockefeller cabal in South Africa outlined above is that of the Trojan Horse. Until the end of World War II, the majority of Afrikaners were farmers, while the English South Africans controlled finance and industry. For the sake of greater profit, the English usually were willing to make certain concessions to the African majority, while Afrikaners winced at the thought of sacrificing the principles of race purity for mere lucre. Because of the hostility between English and Afrikaner, it was not possible to "modernize" South Africa through the influence of the English alone. The rise of some Afrikaners to importance in finance and industry after World War II, aided by

Afrikaner control of government from 1948, was therefore of special interest to the Rockefeller cabal.

By building relations with the emerging Afrikaner businessmen, the Rockefeller cabal was then able to win over Afrikaners in government, the universities and the trade unions who were willing to destroy Afrikaner values. For example, Jan Marais of the Federale Group of Companies founded the Trust Bank in 1954 and made it into one of the big five, using the most advanced business methods. He was courted and won by the Rockefeller establishment. This proud holder of the 1966 Harvard Business Statesman Award sits on the board of Rocky's Goodyear Tyre and Rubber in South Africa. Anton Rupert, who began as a university lecturer, founded the Rembrandt Group which is today a massive multi-national. David Rockefeller made him a personal friend.

#### Democracy a "Luxury"

To most Afrikaners, such men are heroes. As one commented on Rupert, "He began with nothing. Here we were, a country that was feeling rather persecuted for our (racial) politics, and finally one of us was making it." Here are precisely the men who can bust the Afrikaner working class while appearing to lead it in the name of "racial justice." While maintaining impeccable Afrikaner political connections and keeping clear of too close association in public with English business, they use the Anglo-American counterinsurgency arsenal of John Rawlings Rees and Frank Kitson. Rupert's leading role was reaffirmed to big business by his recent appearance on the cover of Business Week. His contacts with the more powerful English magnate Harry Oppenheimer are far more significant than he will admit. Ruthless Rupert maintains a low profile. A great believer in boardroom democracy, he thinks dictatorship is desirable beyond the boardroom doors: "Democracy is a luxury only the rich countries can afford."

#### ETHIOPIA: MILITARY TUSSELES WITH LABOR MOVEMENT

Oct. 5 (IPS)--Ethiopia's Armed Forces Coordinating Committee (AFCC) is experiencing growing pains as it advances from the CIA's script for a progressive military coup to the more complex CIA scenario for consolidating a fascist society. Although the New York Times adopts a motherly tone in editorializing that "they (AFCC) have not yet recovered the sure touch that marked their revolution for the task of coping with the soaring expectations aroused by that revolution," the Rockefeller attempt to ram a "new era" down the Ethiopians' throats in fact run into a temporary snag.

Setbacks in organizing students and worker support have brought about a staccato-like series of governmental crises in which officials are appointed and then removed at an amusingly rapid pace. Rumors to the effect that current leader Aman Andam had been arrested were spreading so quickly throughout Addis Ababa that the AFCC had to initiate threats against "forces of internal dissension," and Andam had to make the rounds of government employees to convince them that he was still alive and kicking.

Organizing "constituencies" to accept fascism, even with the CIA's help, is never easy; and the military originally attempted to bypass the dilemmas they now face by convincing Haile Selassie himself to put on a new, modern fascist face. One Ethiopian Colonel, Abaderash Tessema, braved the fresh air of non-secrecy long enough to spill the beans to the Sunday London Times. Noting that the AFCC had tried to deal with Selassie, Tessema explained, "We reminded him of the Shah of Persia who made a 'revolution from the top' when his throne and his country was endangered by 'revolution from the bottom.'"

But the Lion of Judah didn't bite.

The AFCC alternative to a fascist Selassie proceeded at first without a hitch. From February until the overthrow of Selassie in mid-September, the students and workers organized in the Confederation of Ethiopian Labor Unions (CELU) helped usher in the CIA's new age, despite occasional brute military suppression of strikes. Only recently have these groups begun to balk at the obvious slave labor aspects of the AFCC's fascist austerity program. Students have questioned the idea of a year of free national service; and the trade union chiefs have not relished the banning of strikes and public demonstrations.

#### AFCC Attacks Labor

While student discontent has gone only so far as to hold inconsequential mass meetings in public stadiums in the face of military bans, the "threat from organized labor" spurred AFCC immoderation. The so-called Provisional Military Administrative Council of AFCC arrested the president, vice-president, and secretary-general of CELU Sept. 24 for agitating organized labour to disrupt the peaceful change in Ethiopia." CELU President Ato Beyene Solomon was accused of "having been handpicked by the former regime," and of threatening to "ruin the economy of the country which has already been deteriorating even without any industrial unrest....conniving...to suppress the aspirations of organized labour in Ethiopia.... diverting for personal use part of a half a million dollars donated by a foreign organization for the construction of CELU headquarters in Addis Ababa." The Washington Post identified this "foreign organization" as the African-American Labor Center, the AFL-CIO's organizing body for Africa.

#### The CIA Exposes Itself

Whatever the truth of the charges of personal corruption against Solomon and his two cronies, the overall import of the accusations is precisely on target --even if the AFCC has a topsy-turvy understanding of them. For example, in March and April of this year, CELU sparked demonstrations and stoppages in the various transport and dockworker affiliates which crippled an economy already ravaged by astronomical oil import bills and a spreading drought. Without the slightest understanding of even a regional economic program, CELU acted only to sweep duped workers under the CIA-AFCC's rug.

An initial investigation of handpicked labor leaders leads to the conclusion that the Ethiopian labor movement itself virtually was conjured up by Selassie in cooperation with the CIA. Before 1958 when loot-hungry capitalists began to turn their eyes seriously to the African continent, Ethiopian wage workers (who comprised just a tiny portion of the feudally structured, subsistence agriculture economy) came together only in traditional, self-help arrangements and had no legal rights to organize. But capitalist infrastructural modernization required a higher skill level and modern institutions -- including trade unions -- in order to have a small portion of the overall population expedite the beginnings of development.

A mass strike in miniature among textile and sugar workers in 1961-62 gave Selassie the excuse he was looking for to make his kingdom more attractive to Rockefeller. Labor relations codes were introduced to cover both the newly formed CELU and a parallel employers' federation. Thus, corporatist forms existed from the beginning.

In the 1962-65 period, practically the entirety of the CELU leadership -- 400 men in total -- were trained in seminars conducted by the UN-related Interna-

tional Labour Organization, the CIA-infested International Confederation of Free Trade Unions, and the counterinsurgent Friedrich Ebert Foundation from West Germany. In the later 1960s, the African-American Labor Center (AALC), the entry point to Africa for top-level CIA labor agents like Irving Brown, set up shop "to suppress the aspirations of organized labour in Ethiopia." In an interview with IPS, a top-level spokesman for the AALC, pooh-pooed both the extent of AALC activity in Ethiopia and the validity of the AFCC's accusations. Yet the AALC's own publications list an impressive and growing range of activities in Ethiopia, including the building of CELU headquarters not only in Addis Ababa but in the northern city of Asmara!

#### Viable Fascists

The significance of these accusations is the CIA's attempt to separate viable fascists from the old-style pro-democrats. Most Ethiopian union heads were educated in the mythologies of bourgeois democratic promises to labor and obviously they find it difficult to internalize Rockefeller-determined "necessity." Potential splits within CELU were denied strongly by the AALC spokesman, who also claimed that the Brussels-based ICFTU was "dead set" against the military, and that the AALC itself didn't care overly much for the AFCC honchos.

Although the general strike of its 100,000 members called to protest the arrest of the CELU leaders was a dismal failure, lasting only two hours and attracting few members, CELU remains a thorn in the side of the AFCC, which must choose between further repression or a pullback into some type of military-labor "peoples' government."

#### MOROCCO'S KING HASSAN USES SAHARA ISSUE TO CREATE POP FRONT FOR CIA

Oct. 5 (IPS)--For the past several months King Hassan of Morocco, aware that his political existence could be snuffed out at any instant, waged a propaganda and diplomatic campaign aimed at "liberating" the Spanish Sahara from Spain's control and making it part of Morocco. In trouble at home, Hassan's real aim was to take the heat off himself by uniting with his CIA-controlled "democratic" opposition against a "common enemy." In maneuvering to save his neck, he consolidated the disparate political forces of Morocco--to prepare the country for the slave labor "development" projects in line with the Rockefeller cabal's plans for the Third World. If Hassan had not paved the way for such "reforms," the CIA would have initiated a classic "progressive military" coup to accomplish the same goal.

Since independence in 1956, one of the recurring demands of the Moroccan opposition has been the liberation and annexation of the Spanish Sahara. While the throne (King Hassan and his predecessor King Mohammed V) usually was able to defuse ferment around this issue, in general the political history of Morocco is one of unrest. Now, caught in the most severe political crisis of his life, Hassan decided to turn the tables and push for annexation of the Spanish Sahara. Thus he began a series of belligerent speeches announcing Morocco's intention to "liberate" the Spanish Sahara militarily. These were accompanied by the deployment of official emissaries to capitals all over the world, making it appear that Hassan was deadly serious.

Militarily, the Moroccan army had no chance of defeating the well-equipped Spanish army. In addition, Hassan would have needed the support of neighboring Algeria and Mauritania for the effort to have even a semblance of success. Predictably, neither country went along with it; Mauritania saying, as she always has, that the Spanish Sahara should be part of Mauritania, and Algeria saying that the Spanish Sahara's fate should be decided by a UN-administered referendum (similar to Spain's proposal).

#### Hassan Backs Down

Several non-Moroccan publications talked of a probable or imminent war, but when the day came (Sept. 17) when Hassan was to announce what steps he would take, he had to back down. At a press conference, Hassan lamely declared that the issue was to be left up to the International Court of Justice.

Nevertheless, Hassan's anti-colonialist sabre rattling created a popular-front style political alignment, uniting the opposition with the King. Hassan even had Ali Yata, a member of the outlawed Communist Party, construct a "radical socialist" party pushing land reform and resource control to suck radicals and socialists into Hassan's scheme.

The prestigious French newspaper Le Monde felt compelled to label Hassan a "statesman" for successfully pulling off this caper. However, the New York Times went to the other extreme, indicating that the CIA could have used the situation to dump Hassan if he had not "cooperated." Contemptuously painting Hassan as a fool insulting his people, the Times quoted him as saying that he had backed down to spare the world a catastrophe: "I tell you frankly that I know the Moroccans too well...I follow Moroccan sentiment too much to risk setting fire to a powder keg." Hassan added that 16 million Moroccans might "go as far as genocide" against the Spaniards, "happy to do it and certain of winning."

While this farce is proceeding, the massive phosphate reserves of the Spanish Sahara and Morocco are underutilized at the same time that Rockefeller is engineering a fertilizer shortage and massive starvation.

#### PRESS BEGINS TO WATERGATE KENYATTA

Oct. 5 (IPS)--Fresh from its success in aiding the dethronement of Ethiopia's Haile Selassie, the CIA vanguard of the international press has moved one country south to focus on Mzee Jomo Kenyatta, President of Kenya.

Preliminary probing action came in the Washington Post Sept. 28, in the usual form of "exposing" corruption. In a self-proclaimed courageous article, David B. Ottaway revealed that there is corruption among high government officials in Kenya (no news to Kenyans), implying that Jomo himself is involved. The particulars have to do with the expulsion of the Kenya Exxon head for trying to collect on Kenyatta's personal oil bill and the expulsion of two ruby prospectors who had just discovered a deposit that corrupt officials wanted for themselves. Ottaway modestly pointed out that other journalists were afraid to print these damaging truths for fear of reprisals. The next day, the London Times chimed in with the news that Mrs. Kenyatta was involved heavily in the ruby caper.

Even Kenyans, said intrepid reporter Ottaway, are complaining of the "spreading cancer of corruption" in their country. This was emphasized

further by a report in today's New York Times that copies of the London Times' Kenya article are selling for \$4.90 in Nairobi and that photocopies of the article are being distributed privately. But, the cancer in question is not corruption; it is the CIA hands-for-hire like Ottaway who are moving systematically across the continent to help replace obsolete satrapies with CIA whiz kids. Lest anyone doubt the CIA's intentions, the London Times made a point of noting that Kenyatta and Selassie are exactly the same age.

Until recently, dependable agents like Selassie and Kenyatta have been left in office, and corruption was just part of the payment for services. These old-style rulers were valuable because they had their own genuine social bases: Selassie with the aristocracy and the church, and Kenyatta with the Kikuyu, as well as a certain amount of general support, including that from whites.

Now, however, the old order is over. Kenya and Ethiopia are not suppliers of any strategic raw materials and therefore are not among the lootable countries (such as Nigeria) slated for massive "development" projects. Instead, they face starvation as the Rockefeller cabal uses them to supply food for the "development" projects in North or South Africa. Kenya is strategically placed for this operation. Food can be exported and shipped up the Red Sea to the "Free Industrial Zone" proposed by Sadat around Port Said or from Mombasa south, by sea and rail to the projects being planned for southern Africa from the Zambia-Zaire copper belt to the Republic of South Africa.

If Kenyatta decides to resist the McNamara plan for Africa—which is to encourage the present unproductive and ecologically destructive iron-age methods of agriculture—he is politically in a position to do so. This possibility was indicated in the Oct. 4 speech to the U.N. General Assembly by the Kenya representative to the U.N., who commented that Kenya intended to propose to the U.N.-sponsored World Food Conference in Rome the transfer of agricultural technology to Africa as the way to solve the world food crisis. He made no mention of the World Bank's plans to invest in labor-intensive small-holdings—farming by hoe and machete on ten acres of barren land apiece.

#### UNITED NATIONS REPORT

#### CHINA HAILS "ARABS' OIL WEAPON"

Oct. 2 (IPS)—The People's Republic of China has once again come out in support of Rockefeller's current oil hoax. Chinese Deputy Foreign Minister Chiao Kuan-Hua, speaking at the UN General Assembly, called the "oil battle" an "historic pioneering action taken by the Arabs" for the Third World. By saying such nonsense, the Chinese are giving a left cover to Rockefeller's plunder of the world, including the planned starvation of 900 million people in the Third World.

The rest of Chiao's speech was devoted to anti-Soviet diatribes. Chiao blamed the Soviet detente policy, in effect, for the Cyprus situation, which was actually a NATO move against the Soviets. Following this attack on detente, Chiao had a cozy dinner meeting with Secretary of State Henry Kissinger.

## IPS BLOWS UN DIPLOMATS' COOL

UNITED NATIONS, NEW YORK CITY, Oct. 3 (IPS)--A cold blast of reality from New Solidarity International Press Service correspondents has blown the cool of the United Nations. Multilingual diplomats are suddenly losing their mastery of the English language, experienced politicians are tumbling into public confusion, and hardened reporters covering the UN beat are tittering like embarrassed schoolgirls.

These phenomena occurred at a series of UN press conferences last week when IPS reporters interrupted the droning ritual of "Ask me no questions, I'll tell you no lies" with some hard questions about the real world.

One of IPS's most prominent targets was West German Foreign Minister Hans-Dietrich Genscher, in town to subject the UN General Assembly to a sabre-rattling speech about the "indivisible German nation." At Genscher's Sept. 25 press conference an IPS correspondent stated, "You have been slated for Watergating on the basis of your identification with the policy of Ostpolitik (referring to a recent series of vituperative attacks on both detente and Genscher in the West German press). Are you prepared to adopt the only policy capable of saving detente and yourself--vast expansion of East-West trade? Or will you continue to do just the opposite--cave in to austerity belt-tightening and the anti-Soviet 'Maoism' of fascist Franz Josef Strauss? My question is: In which direction is your foreign policy going--Ostpolitik or Maoism?"

While other reporters present squirmed uncomfortably at such unwelcome candor, Genscher's face twisted into a dumbfounded smile. After a long silence he finally mustered himself to reply that he would continue to emphasize "the continuity in our foreign policy--strong alliances with freedom, detente--clearly and unequivocally. Our foreign policy cannot be characterized as Maoist!" After the press conference Genscher eagerly took a copy of New Solidarity; upon seeing an article on Strauss and Mao he gurgled happily.

### "It's Greek to Me"

The reaction of Greek Foreign Minister George Mavros was more extreme. In the midst of tear-jerking histrionics about the "Turkish invasion of Cyprus," Mavros suddenly was confronted by the following question from IPS: "In view of widespread revelations that the American CIA has been manipulating Greek politics since the postwar period, how can we believe that such influence has suddenly vanished? In particular, how do you account for the sudden so-called anti-American turn by the Karamanlis regime--a regime composed of dozens of longtime CIA/NATO collaborators, including Premier Karamanlis himself?"

Mavros sat stunned for a full minute. Then, he conferred in whispers with his aides while the assembled press giggled nervously. At last Mavros, whose command of English is known to be excellent, complained that he could not understand the meaning of the question. "We established democratic rule," he whined. "There are no concentration camps, no political prisoners; the press is free. Why are you asking me these questions? None of the Communist newspapers in Athens have asked these questions, and they are free to print anything they want..."

When Mavros said "there are no political prisoners," a couple seated behind the IPS reporter hissed, "Not even Communists!" IPS later learned that they were Mavros' son and daughter-in-law.

### "Only Following Orders"

Mario Soares, Socialist Party member and Foreign Minister of Portugal, also experienced sudden difficulty in comprehending plain-spoken English at his press conference. An IPS reporter asked how Soares, a socialist, could participate in a government then headed by former Nazi collaborator General Spínola, and further inquired how Soares reconciled socialism with the strike-breaking and corporatist policies that he is personally forcing on the Portuguese working class. Soares paused for a long moment, then announced that he did not understand the question.

When the IPS reporter began to expand on the details of Spínola's unsavory past, Soares nervously broke in, "Oh, oh, I get your question." His answer: "You can't hold a man's past against him....Anyway, Spínola was not really a fascist; at that time he was a military man, and as a soldier was only following orders." With this sickening display, Soares brought the press conference to an abrupt close.

While "progressive democrats" Soares and Mavros embraced for the press photographers, Soares' aides rushed to the IPS correspondents for more information. "Where did you get your information about Spínola?" asked one. Another grabbed for New Solidarity and asked anxiously, "What do you think will happen in Portugal? Will it be another Chile?"

### INTERNATIONAL BRIEFS

#### DAVID ROCKEFELLER ORGANIZING FOR FASCIST TRILATERAL COMMISSION

Oct. 4 (IPS)--IPS has just received confirmation (from David Rockefeller himself) that Leonard Woodcock's membership on David's own supranational planning body, the Trilateral Commission, marks him as a leading fascist organizer, almost one of the family. The proof comes from the transcript of David Rockefeller's Sept. 17 speech to Canadian bankers on "Why Foreign Banks Want to Settle in Canada." David wound up his presentation of capitalist tasks and perspectives as follows:

*"In advocating active collaboration with the aim of resolving these serious problems, the Trilateral Commission took a great step forward. Made up of leaders from the industrial, university, and political world in North America, Western Europe, and Japan, the Commission, under the skillful direction of Professor Zbigniew Brzezinski, has begun to actively look into what measures to take in view of the elaboration of general ideologies and strategies. I have confidence that the Commission, by putting together organisms which will execute its concepts and strategies, will play a primary role in eliminating the traditional obstacles to multinational collaboration."*

IPS wonders why Woodcock and his friends on the Trilateral Commission--I.W. Abel of the U.S. Steelworkers union and West German union bureaucrats Eugen Loderer and Hans Vetter--bashfully play down the importance of the Tri-

lateral Commission when asked about it. Why be shy when David Rockefeller has such confidence that you will play a primary role in establishing world fascism?

### SPINOLA STAGES "LEFTIST VICTORY" IN PORTUGAL

Oct. 3 (IPS)--Stating that "new forms of slavery are being prepared under the flag of a false freedom" and predicting the oncoming of a period of leftist anarchy, Portuguese president Antonio de Spino-la has resigned as head of state. He has left political power in the hands of the semi-amorphous "Armed Forces Movement" (MFA) and its principal ally, the Portuguese Communist Party (PCP). Together with his top collaborator, the newly appointed stand-in president General Francisco da Costa Gomes, Spino-la is now preparing to first discredit and then annihilate the Portuguese left along Chilean lines.

General Spino-la, having achieved the necessary populist stature, has little use for the leftist forces which were instrumental in bringing him to power. Initially, Spino-la engaged in "tactical" collaboration with Portuguese leftists (and actually nurtured their recent revival) as the popular support which has turned him into Portugal's unrivalled fascist figure. With relative success he has involved the PCP and other left forces in promoting "self-policing style" strike-breaking austerity and other anti-labor activities.

But growing political opportunism on the part of numerous left and certain right political groupings has become an obstruction to the efficient intensification of the "New Portugal" fascist regimentation policies as well as to the initiation of labor-intensive "development" projects along similar popular participation lines in the African territories of Angola and Mozambique.

#### Part of the Plan

The so-called "political crisis" which led to Spino-la's abrupt, theatrical resignation this past weekend was in fact planned from the outset by the expert counterinsurgent himself. Over the past two weeks, Spino-la has intentionally instigated open confrontation with both the PCP and the MFA. In the case of the former, he began by implicitly referring to the PCP as "totalitarian extremists," while in the case of the latter, he, as well as Armed Forces head Gomes, began calling for the dissolving of the Coordinating Committee of the MFA, saying that it has completed its function.

Swallowing the bait, the PCP, in collaboration with the MFA, launched a renewed campaign to "guard against the returning forces of reaction." Overnight, the so-called "silent majority" group, composed of rightists allegedly supporting Spino-la and the MFA factions against growing PCP influence, sprang up. An initial rally held by the "silent majority" group in Lisbon led to massive PCP counterorganizing and subsequent confrontations between left and right groups. After this incident, Spino-la pushed for further provocations by supporting a similar "silent majority" rally the following week, although there were clear signs that mass public disorder would occur. "Despite" Spino-la's last minute banning of the rally, there erupted violent street fighting incidents between rightists and leftists. Rumors of assassination plots against MFA member Prime Minister Goncalves and a rightwing takeover raced through the city. These precipitated an eventual leftists' condemnation of reactionary maneuvers by Spino-la, which resulted in his resignation as well as the dismissal of several conservative junta generals and ministers.

## The Next Stage Towards a Chile

Needless to say, the new leftwing government is not expected to last long. Predicted rises in rightwing violence, deepening economic problems partly through manipulations by Spínola, and an increasingly chaotic situation in Angola since the resignation, are urgent issues facing the new regime. The MFA itself is undergoing internal splits between the majority Spínolista and moderate officers and the radical officers who dominate the leadership. Prime Minister Goncalves has gone so far as to hint that something might happen to prevent elections planned for March.

Goncalves has also noted the possibility of civil war, and is now calling on all workers to "produce more"--a call which the PCP is supporting! Now, one of the people holding things together is Spínola's co-conspirator President Costa Gomes. On cue from Spínola, Costa Gomes will let the PCP house of cards collapse at the opportune moment of chaos, paving the way for the return of the fascist "liberator."

The Spínola-planned leftwing "takeover" has not accidentally prompted an hysterical anti-communist press campaign throughout Western Europe, equating communism with mass chaos. Pulling no punches, a recent London Daily Express editorial begins with the statement, "Portugal faces anarchy" after the "leftist takeover," and concludes by saying, "The only certainty about anarchy is that it never endures." The West German press in particular has played the anti-communist campaign to the hilt.

Far from the leftist victory insanely being proclaimed by several European Communist Parties, notably the CPs of France and Italy, the PCP can only discredit itself through willingly accepting the role of austerity implementer in the new, "more progressive" Portuguese government. The "deposed" Spínola will be organizing rightist forces and generating confusion from the sidelines in order to effect his long-planned Chilean-style annihilation of the left, and subsequent fascist cannibalization of a demoralized working class.

### CIA HEATING OIL HOAX TO A BOIL; THREATS AIMED AT SOVIETS

Oct. 3 (IPS)--In the past two weeks the CIA has brought the simmering oil crisis to a boil. While Arabian ministers made menacing references to their "oil weapon," the CIA laid the groundwork in the Middle East for a new political crisis amid rising press-orchestrated anti-Arab hysteria in the U.S.

The oil issue, until recently confined to the economic sphere, is being increasingly linked to the issue of Palestine and a new Arab-Israeli war threat. Saudi Arabia's Oil Minister said yesterday in Washington that "the conditions are right for another Middle East war" and explicitly linked oil prices and production cuts to a solution to the Palestinian problem. "I assure you if we solve the Israeli problem, the price of oil will come down," declared Yamani.

Since the Vienna meeting of the Organization of Petroleum Exporting Countries (OPEC) last month, Rockefeller and the CIA have orchestrated an international campaign to blame the Depression on the Arabs. In public speeches around the world, Rockefeller agents the Shah of Iran, Egypt's Sadat, and King

Faisal of Saudi Arabia have gradually escalated their rhetoric. However, the staged nature of the new oil crisis was exposed by a mock serious remark of Henry Kissinger's at a fun-filled dinner Kissinger gave for Arab diplomats at the UN. Henry turned to Saudi Arabian Oil Minister Yamani and said, amid laughter, "My friend Omar has told me he has prepared a crushing reply" (to the attacks which Kissinger has been levelling at the Arabs).

Radio Moscow and the French newspaper Le Point reported that all the CIA station chiefs from the Middle East met in Teheran, Iran, with former CIA head and current Ambassador to Iran Richard Helms to plan the next phase of the psychological warfare campaign around the new "Arab oil crisis." According to Le Point, Helms called the station chiefs together to develop a rumor network about "armed U.S. intervention into the oil crisis." When IPS called CIA headquarters for a comment, the Public Relations officer said, "As far as we're concerned the meeting never took place." Helms' rumor campaign is direct psychological brinkmanship against the Soviet Union.
