PRESIDENTIAL STATEMENT ON ASSASSINATION ATTEMPT AGAINST FORD

SEPT. 5 -- TODAY'S ASSASSINATION ATTEMPT BY A MEMBER OF THE CHARLES MANSON CULT AGAINST PRESIDENT GERALD FORD MUST HASTEN THE IMMEDIATE CLOSING-DOWN OF THE ROCKEFELLER-CREATED BRAIN-WASHING NETWORK THROUGHOUT THE UNITED STATES.

WHILE IT IS NOT CLEAR WHO, IF ANYONE, ORDERED THE ATTACK OF FORD, THE FACT THAT THE ATTEMPTED MURDERESS IS A MANIFEST ZOMBIE LEADS US TO CONSIDER JUST WHERE SUCH ZOMBIES ARE CREATED. IT IS A MATTER OF PUBLIC KNOWLEDGE THAT THE MAIN SOURCES OF ZOMBIFIED PSYCHOTICS IN THE UNITED STATES ARE METHDONE MAINTENANCE CENTERS, PRISON REHABILITATION CENTERS, TRANSACTIONAL ANALYSIS GROUPS AND OTHER SO-CALLED COMMUNITY MENTAL HEALTH, DRUG OR BEHAVIORAL THERAPY INSTITUTIONS — MOST OF WHICH ARE ADVISED, FUNDED OR ADMINISTERED BY PERSONS OR INSTITUTIONS (LIKE THE LAW ENFORCEMENT ASSISTANCE ADMINISTRATION) CONNECTED WITH THE MANSON CULT, WAS OPEN TO THE INFLUENCES OF ONE SUCH NOTORIOUS BRAINWASHING INSTITUTION, THE ESALEN INSTITUTE.

THE LABOR PARTY IS NOT AN ADMERENT TO THE "LONE ASSASSIN" THEORY, BUT THE POSSIBILITY OF SUCH CRIMINAL ACTION CANNOT BE ELIMINATED AS LONG AS THE ROCKEFELLER-CREATED BRAINMASHING NETWORK REMAINS INTACT. MEMBERS OF THE LABOR PARTY HAVE BEEN SUBJECTED TO A WAVE OF RAPE ATTACKS FROM LEAA-CONNECTED PRISONER AND DRUG REHABILITATION CENTERS.
