U.S. LABOR PARTY PROPOSES EMERGENCY EMPLOYMENT ACT
TO SOLVE ECONOMIC CRISIS

OCT. 20 (IPS)—THE U.S. LABOR PARTY TODAY SUBMITTED TO CONGRESS A DRAFT "EMERGENCY EMPLOYMENT ACT OF 1975." THE PROPOSED BILL, AUTHORED BY LYNDON H. LAROUCHE, JR., THE USLP'S 1976 PRESIDENTIAL CANDIDATE WOULD DECLARE A "GRAVE NATIONAL ECONOMIC EMERGENCY," AND ADOPT "APPROPRIATE AND ACCEPTABLE ALTERNATIVE MEANS TO FULL ECONOMIC RECOVERY" WHICH ARE IMMEDIATELY ACCESSIBLE.

THE DRAFT EMERGENCY EMPLOYMENT ACT CONDEMNS CURRENT ATTEMPTS TO SALVAGE BILLIONS OF DOLLARS OF BAD DEBTS THROUGH NAZI-MODELLED AUSTERITY MEASURES - A POLICY WHICH NECESSARILY DEMANDS THE IMPLEMENTATION OF THE NAZI'S MASS SLAVE LABOR POLICIES ON THE U.S. AND OTHER POPULATIONS, AND CALLS ON THE CONGRESS TO JOIN WITH LEADING FORCES WITHIN THE DEVELOPING SECTOR, THE EUROPEAN COMMON MARKET, AND THE COMECON SECTOR IN ESTABLISHING A "NEW WORLD ECONOMIC ORDER." THE CUTTING AWAY OF EXISTING BANKRUPT FINANCIAL STRUCTURES AND THE CREATION OF NEW NATIONAL AND INTERNATIONAL CREDIT INSTITUTIONS UNDER SUCH AN ARRANGEMENT, THE ACT STATES, WILL CREATE A WORLD MARKET FOR U.S. INDUSTRIAL AND AGRICULTURAL EXPORTS "SUFFICIENT TO REQUIRE FULL EMPLOYMENT OF THE NATION'S LABOR FORCE," PLUS "SUBSTANTIAL RENEWAL AND AUGMENTATION OF THE PRODUCTIVE CAPACITIES."

UNDER THE HEADING "EMERGENCY SHORT-TERM MEASURES," THE ACT WOULD REPLACE EXISTING, BANKRUPT FINANCIAL INSTITUTIONS WITH NEW INSTITUTIONS OF NATIONAL AND INTERNATIONAL CREDIT, WHILE MAINTAINING THE INCOMES OF THOSE DEPENDENT ON SUCH BANKRUPT PENSION FUNDS, INSURANCE COMPANIES, ETC. THE ACT WOULD ALSO CREATE AN EMERGENCY SOCIAL SECURITY AGENCY IN THE DEPARTMENT OF LABOR, WHICH WOULD GUARANTEE AND EXPAND ESSENTIAL SOCIAL SERVICES FOR THE POPULATION, INCLUDING ALL FORMS OF WELFARE. THE AGENCY WOULD BE CHARGED TO PROMOTE THE ASSIMILATION OF HARD-CORE UNEMPLOYED INTO REGULAR FULL-TIME SKILLED AND SEMI-SKILLED EMPLOYMENT.

UNDER THE HEADING "EMERGENCY PRICES CONTROL," THE ACT PROPOSES DIRECT PRICE CONTROLS FOR THE DURATION OF THE EMERGENCY. THE CONTROLS ARE TO BE USED TO SQUEEZE OUT "OF EXISTING PRICE-STRUCTURES THOSE MARGINS WHICH ARE ATTRIBUTABLE TO BURDENS OF THE CATEGORIES OF INDEBTEDNESS BEING CUT AWAY FROM THE CURRENT OPERATIONS OF THE NATIONAL ECONOMY." THE ACT WOULD ALSO REPEAL THE "EMPLOYMENT ACT OF 1946," CITING THE FAILURES OF THE LATTER'S INSTITUTIONS SUCH AS THE COUNCIL OF ECONOMIC ADVISORS.

"PROJECT INDEPENDENCE," CHARACTERIZED BY THE ACT AS A "WASTEFUL PORKBARREL," WOULD BE IMMEDIATELY TERMINATED. IMMEDIATE TO LONG-TERM NATIONAL ENERGY POLICY "SHALL BE FOCUSED ON THE DEVELOPMENT OF CONTROLLED THERMONUCLEAR REACTIONS TECHNOLOGY, IN FULL COOPERATION

(MORE)

WITH OTHER NATIONS."

AS THE NATION'S "LABOR FORCE POLICY," THE ACT ESTABLISHES THE PRINCIPLE OF PROVIDING "THE IMPROVED OPPORTUNITIES AND CONDITIONS OF EMPLOYMENT, LEISURE, AND ESSENTIAL SOCIAL SERVICES" WHICH LEAD TO RISING STANDARDS OF LIVING AND "SUBSTANTIAL ADVANCES IN THE COGNITIVE POWERS OF THE POPULATION." SUCH EMPLOYER PRACTICES AS FORCED DRUG MAINTAINENCE PROGRAMS, BEHAVIOR MODIFICATION PROGRAMS, AND HARASSMENT OF EMPLOYEES BECAUSE OF POLITICAL OR TRADE UNION PARTICIPATION, WILL BE MADE FELONIES.

IN ITS FINAL SECTION, TITLED "EMERGENCY EMPLOYMENT MEASURES," THE ACT WOULD "AUTHORIZE SUCH SPECIAL PROJECTS OF CONSTRUCTION IN DEVELOPMENT OF URBAN AREAS, IN RAIL TRANSPORT AND MASS TRANSIT WHICH BOTH COUNTERACT CYCLICAL UNEMPLOYMENT AND BENEFIT THE DEVELOPMENT OF THE NATION AND ITS LABOR FORCE." "MAKE-WORK" TYPE PROJECTS ARE SPECIFICALLY PROHIBITED UNDER THE ACT.

USLP TO TESTIFY BEFORE
ELECTION COMMISSION TODAY

OCT. 21 (IPS)—U.S. LABOR PARTY SPOKESMAN ARTHUR LEADERMAN WILL OUTLINE THE PARTY'S OBJECTIONS TO THE CAMPAIGN FINANCING REQUIREMENTS OF THE FEDERAL ELECTION COMMISSION (FEC) AT HEARINGS TODAY AT 3:30 P.M.

LEADERMAN'S TESTIMONY CALLS FOR AN IMMEDIATE INVESTIGATION OF OPERATIONS COORDINATED BY U.S. INTELLIGENCE AGENCIES TO DESTROY THE ELECTORAL PROCESS IN THE UNITED STATES. LEADERMAN WILL CITE RECENT INSTANCES OF VOTE FRAUD DIRECTED AT THE USLP IN BOSTON, SEATTLE, WASHINGTON, AND GREENSBORO, N.C. INCLUDING THE USE OF FBI-SPAWNED COUNTERGANGS AGAINST THE USLP CAMPAIGNS.

WITHOUT SUCH AN INVESTIGATION, THE USLP TESTIMONY STATES, THE SPECIFIC REVISIONS OF FEDERAL LAW BECOME IRRELEVANT.

LEADERMAN WILL TESTIFY IN PARTICULAR THAT THE FEC FINANCING REQUIREMENTS FOR THE DISCLOSURE OF THE NAMES OF INDIVIDUALS WHO CONTRIBUTE MORE THAN \$10.00 OPENS POTENTIAL USLP CONTRIBUTORS TO THE KIND OF HARASSMENT AND INTIMIDATION BY FEDERAL AGENCIES PRESENTLY DIRECTED AT THE LABOR PARTY. THE TESTIMONY ASSERTS THAT THIS VEHICLE IS A CONVENIENT APPARATUS TO CHILL FIRST AMENDMENT RIGHTS OF ASSOCIATION AND TO FORM A "BLACK-LIST" OF POTENTIAL CONTRIBUTORS TO THIRD PARTIES, ESPECIALLY THE USLP.

ADDITIONAL USLP TESTIMONY TO THE COMMISSION WILL OUTLINE THE HISTORY OF THE FEDERAL ELECTION CAMPAIGN ACT AND THE ROLE OF COMMON CAUSE AND ITS CHAIRMAN, JOHN GARDNER, IN INSTITUTING THIS LEGISLATION AS PART OF THE "INVISIBLE GOVERNMENT" THAT RUNS THE U.S.
