KISSINGER ORDERS PRESS COVERUP OF ECONOMIC SUMMIT

NOV. 17 (IPS) — MAJOR U.S. NEWS MEDIA, INCLUDING ASSOCIATED PRESS (AP), UNITED PRESS INTERNATIONAL (UPI) AND THE NEW YORK TIMES HAVE IMPLICATED THEMSELVES IN A COLOSSAL COVER-UP OF SIGNIFICANT DEVELOPMENTS AROUND THE "BIG SIX" ECONOMIC SUMMIT MEETING AT RAMBOUILLET OUTSIDE PARIS. THEIR COMPLETELY FALSE COVERAGE INDICATES THAT THEIR STORIES WERE PROBABLY WRITTEN DIRECTLY BY THE OFFICE OF U.S. SECRETARY OF STATE HENRY KISSINGER.

THE NEW YORK TIMES HAD ORIGINALLY SUGGESTED THAT NO SERIOUS DISCUSSION OR CHANGES WOULD EMANATE FROM THE SUMMIT MEETING. YESTERDAY'S EDITORIAL TOOK ITS CUE FROM KISSINGER'S RANTING SPEECH LAST WEEK BEFORE THE PITTSBURGH WORLD AFFAIRS COUNCIL AND QUOTED HIM AS STATING THAT THE SUMMIT WOULD HAVE TO INDICATE A CONTINUING SYSTEM OF "COOPERATIVE DECISIONS." THE TIMES COVERAGE REVOLVED AROUND FORD'S STATEMETS ASSURING THE EUROPEANS THAT THE U.S. ECONOMY WAS IN THE PROCESS OF A STRONG AND DURABLE RECOVERY.

TODAY THE TIMES REPORTED A "BROAD AGREEMENT ON ECONOMIC ISSUES" AND THE PLEDGE OF "INCREASED COOPERATION ACROSS A SPECTRUM OF ECONOMIC PROGRAMS" ON THE PART OF THE PARTICIPANTS AT THE SUMMIT. IN ADDITION, IT REPORTED THAT AN AMERICAN OFFICIAL RESPONSIBLE FOR THIS ESTIMATE HAD SAID THAT ONE RESULT OF THE MEETING SO FAR "WAS THE CONCESSION BY ALL OTHR PARTICIPANTS THAT THE EXPANSION OF THE UNITED STATES ECONOMY WAS NOT THE ANSWER TO THE RECESSION IN OTHER COUNTRIES."

WHAT ACTUALLY OCCURRED

THE MOST SIGNIFICANT DEVELOPMENT AT THE SUMMIT WAS THE OPEN JAPANESE BREAK WITH ROCKEFELLER'S POLICY AS SPELLED OUT IN THE SPEECH OF JAPANESE PRIME MINISTER MIKI LEAKED IN THE JAPANESE DAILY YOMIURI ON NOV. 12. MIKI DEVELOPED THE FOLLOWING POINTS AMONG OTHERS. 1) THE TIME HAS COME FOR NEW RELATIONS BETWEEN THE U.S. EUROPE AND JAPAN IN WHICH THE RECOVERY AND GROWTH OF IMPORTS OF THE ADVANCED NATIONS IS REQUIRED. 2) IN DEALING WITH THE PROBLEM OF INSURING THE SAFETY OF MARKETS IN WORLD TRADE. THE STABLE BUT ADJUSTABLE (GISCARD-U.S. 5 PER CENT BAND COMPROMISE) RATES SYSTEM IS TOO DIFFICULT TO IMPLEMENT UNDER PRESENT INTERNATIONAL ECONOMIC CONDITIONS. 3) THE ADVANCED NATIONS MUSH HAVE REALISTICALLY POSSIBLE PROGRAMS AND SEEK COOPERATION WITH THE LESS DEVELOPED COUNTRIES, ESPECIALLY THE DEC. 16 INTERNATIONAL ECONOMIC DEPRESSION CONFERENCE 400 INSPECIALLY WOOTHLIST WEEDLINGS BROADENINGS OF

DEVELOPMENT AID. IN ADDITION, NATIONS SHOULD POSITIVELY PARTICIPATE IN THE SOLUTION OF THE NORTH-SOUTH PROBLEM BY THE MORE MODERN APPROACH OF THE ASIAN NATIONS IN UNCTAD TOWARD THE ASIAN DEVELOPMENT BANK. 4) THE PROMOTION OF INTERNATIONAL COOPERATION ON RESEARCH ON THE TOTALLY NEW SOURCE OF ENERGY CALLED FUSION POWER IS NECESSARY SINCE IT IS AN INTERNATIONAL PROBLEM. 5) THE EXPANSION OF EAST-WEST TRADE IS NECESSARY BEYOND THE ABILITY OF PRIVATE CAPITAL. IN THIS REGARD IT IS NECESSARY TO EXAMINE THE INTEGRATION OF THE WEST ON A BASIS THAT WOULD PLAN ECONOMIC COOPERATION WITH THE EAST AND TO STUDY CREATING A BODY FOR SUCH COOPERATION WHICH WOULD PERMIT FORMALIZED AGREEMENTS ON THE EXCHANGE OF CAPITAL GOODS AND EXPORT CREDITS FROM THE WEST AND THE RELAXATION OF THE STRUCTURES IN THE COMECON SECTOR. (SUCH RELAXATION OF STRUCTURES IN THE COMECON SECTOR COULD ONLY REFER TO THE INTERNATIONAL USE OF THE TRANSFER RUBLE.)

THE MENTION OF THE MODERN APPROACH TAKEN BY UNCTAD CAN ONLY BE ASSUMED TO REFERENCE THE PROPOSALS THE GROUP OF 77 ADOPTED RECENTLY AT GENEVA WHICH CALLED FOR DEBT CANCELLATION FOR THE LEAST DEVELOPED COUNTRIES AND DEBT MORATORIA FOR THE OTHER DEVELOPING COUNTRIES.

IN TOTO, MIKI'S PROPOSALS CONSTITUTE ALL THE ESSENTIAL FEATURES OF THE INTERNATIONAL DEVELOPMENT BANK PROPOSED BY THE U.S. LABOR PARTY, INCLUDING THE DEVELOPMENT OF FUSION POWER AS THE BASIS FOR TRADE WITH THE OIL-PRODUCING NATIONS.

FURTHER, IN MARKED CONTRAST TO THE FORD SPEECH REPORTED BY THE MEDIA WEST GERMAN CHANCELLOR HELMUT SCHMIDT EMPHASIZED IN A SPEECH AT MANNHEIM SHORTLY BEFORE THE SUMMIT THAT IN THE PRESENT COLLAPSED STATE OF THE INTERNATONAL ECONOMIC SYSTEM, NO RECOVERIES WERE IN SIGHT AND THE ONLY BASIS FOR RECOVERY RESTED ON GLOBAL SOLUTIONS BASED ON A DEVELOPMENT POLICY.

ROCKEFELLER CONTROL OF MAJOR U.S. MEDIA IS ALSO EXEMPLIFIED IN THE LYING COVERAGE OF THE SUMMIT FEATURED IN THE SUD DEUTSCHE ZEI-TUNG, NOTORIUS FOR GIVING THE U.S. STATE DEPARTMENT LINE. THE SDZ STATES THAT THE ROCKEFELLER CONTROLLED JAPANESE FINANCE MINISTRY HAD CHANGED MIKI'S PLANS. REFUTING TO THIS LIE, LE FIGARO IN FRANCE, CORRIERE DELLA SERA IN ITALY, AND THE FRANKFURTER ALLEMEINE ZEI-TUNG IN GERMANY GIVE THE JAPANESE PROPOSALS STRAIGHI COVERAGE.

THE JAPANESE POSITION AT RAMBOUILLET SIGIFIES A FINAL BREAK BY JAPAN WITH ROCKEFELLER POLICY AND COMMITTMENT TO CONCRETIZE AN IDB TYPE ARRANGEMENT FOR A NEW INTERNATIONAL ECONOMIC ORDER.
