WAR, WAR EVERYWHERE

NEW YORK, Dec. 6 (IPS) -- Following last week's spate of planning meetings both in this country and in Europe, the Rockefeller international financier cabal this week declared open economic warfare against any and all potential enemies. Backed up by the mobilized military might of NATO and related police agencies, the Rockefeller drive is aimed at installing as rapidly as possible top-down police state control of the world economy and trade. Such control would enable Rockefeller to guarantee the repayment in tens of billions in outstanding dollar denominated debt that comes due in the next several months and weeks.

While the immediate focus of this unprecedented economic warfare deployment is to defuse "breakaway" motion in the Third World and elsewhere towards the establishment of a New World Economic Order prior to the Dec. 16 beginning of the Paris North-South Conference.

However, independent studies taken by New York-based bank analysts have confirmed IPS estimates which indicate a total collapse of the New York and Eurodollar banking network by no later than the end of January, 1976. Third World debt rollover pressure on the Eurodollar markets is already causing near panic conditions - and the peak pressure period Dec. 14-15 is still more than a week away. Similarly, the Basel-based Bank for International Settlements (BIS) this week took emergency measures to bail out Eurodollar banks in much the same way that the Federal Reserve is being forced to do for stateside banks.

With the pressure on his banks continuing to grow, Rockefeller must have accomplished this militarization of the world's commodities, oil, food supplies, or the whole shebang goes by the end of January. This is the context of the current HILEX 75 NATO maneuvers (see special report) and the current drive for a nuclear showdown with the Soviets. It also explains why Rockefeller is unlikely to back down.

A NEW OIL HOAX IN THE OFFING

Clement Mallin, a top aide to Federal Energy Administration (FEA) chief Frank Zarb, indicated to IPS yesterday that if someone wanted to wreck the North-South talks, a good ploy would be to get the Arab countries to threaten a new oil embargo. This is purely "hypothetical" Mallin added after realizing that he had inadvertently let a key Rockefeller policy conception slip out.

A New York banking source revealed that Rockefeller allies are now maneuvering both inside and outside the oil producers cartel, OPEC, to give them leeway for action. The source indicated

that Britain - a key force in the oil energy hoax wrecking operation - would move to join OPEC on the strength of its status as an oil producer garnered from its North Sea Oil fiasco.

The purpose of a new oil hoax and the British wrecking maneuvers would be to isolate and intimidate the pro-development and pro-Soviet governments of Iraq and Algeria. The banking source openly admitted as much.

The British are not confining their activities to OPEC. They were deployed this week to wreck the pre-North-South Conference deliberations of the Common Market in Rome. British representatives attempted to rope the Europeans into supporting the Rockefeller-controlled International Energy Agency (IEA) emergency sharing scheme "which would be activated in the event of another oil embargo." The share the misery plan would effectively give Rockefeller fingertip control over oil supplies to the advanced sector.

In a related development, the pro-Rockefeller government of French President Giscard d'Estaing has effectively overridden Gaullist opposition to the "energy sharing" scheme. France is now a member of the IEA, FEA aide Mallin reported.

U.S. IMPLEMENTS FOOD CONTROL POLICIES

U.S. State Department spokesmen admitted this week that the U.S. is prepared "to use food as a weapon in the event of another Arab oil embargo" - an embargo which Rockefeller is now trying to provoke.

Such a policy is consistent with previously stated positions outlined by spokesmen for the Rockefeller cabal dating back to spring 1974. At that time Rockefeller spokesmen, including among others Lester Brown and Henry Kissinger, had pushed for implementation of food control mechanisms on a massive scale to solve the world hunger problem. Last winter, the Rockefeller family's supranational planning apparatus, the Trilateral Commission meeting in secret sessions pushed food control as useful in keeping Third World countries in line, United Nations Ambassador Daniel Patrick Moynihan delivered a speech prepared by Secretary of State Kissinger informing the United Nations special session on development of U.S. support for the establishment of a "World Food Bank" - the central feature of a global food control program.

Now the food control policy - one of the cornerstones of the HILEX 75 maneuvers - is operational to be used for economic warfare purposes. Atlantic Richfield President Robert O. Anderson gleefully told the mis-named Pacem in Terris Conference in Washington, D.C. this week that "the U.S. has politicized food in much the same way that OPEC has politicized petroleum."

IPS learned this week that a special commission of the Paris-based, Rockefeller-controlled OECD has been set up to implement world food control policies. Not coincidentally, the same meeting that set up the OECD commission last May also mapped out the HILEX "exercise."

CREDIT STRANGULATION

Over the last two weeks, Rockefeller has used his fingertip control over dollar-based credit institutions to wreck havoc with the economies of his enemies. Singled out for special treatment

were the Japanese and the Italians, the two countries that had shown dangerous signs of breaking away from the dollar at the Rambouillet summit, and the Soviet Union.

Japanese Prime Minister Takeo Miki had taken the most forthright position at Rambouillet in favor of the creation of an International Development Bank-type credit issuing institution and the development of fusion power. Rockefeller therefore attempted to show Miki the error of his ways.

According to banking sources in New York, all trade credits to Japan have been shut off for two weeks. With no refinancing available, the mass of \$30 billion in dollar-denominated loans being repaid by Japan to its creditors has put the yen under considerable pressure. Over this period the Bank of Japan has been forced to spend upwards of \$70 million per day of its currency reserves to support the sagging yen. To prevent a wholesale collapse of its currency, the Bank of Japan is being forced to deplete its dollar currency at the phenomenal annual rate of \$19 billion.

Meanwhile, the EEC imposed severe austerity conditions on a loan to Italy aimed at preventing that country's economic collapse. Italian Premier Moro had made moves at Rambouillet to support the Miki position.

In addition, World Bank statistics reveal that while the Soviet Union had received \$500 million in Eurodollar credits during the second quarter of 1975, they received zero credits during the third quarter.

This credit strangulation poses an immediate direct threat to the East-West and three-way trade deals on which the Japanese and Western European economies are so dependent.

The move may have already forced the Soviets to cutback in their grain purchases from the U.S. - a move which would force cutbacks in food consumption by the Soviet people and the unnecessary slaughter of Soviet livestock.

EURO-MARKET ON VERGE OF COMPLETE COLLAPSE

Rockefeller is now facing imminent breakdown of the entire Euro-dollar market, the pillar of his financial empire.

Over the past two quarters the New York banks have attempted to prop the market up via a massive refinancing of the unpayable Third World debt, at the expense of credits to U.S., European, and Japanese industrial production. During the third quarter of 1975, \$3.4 billion went out to seven or eight major Third World debtors - a 40 per cent jump over 1974. Advanced sector borrowers received only \$1.3 billion, East bloc borrowings dropped by 2/3 and the Soviets received nothing.

Not a penny of these Third World credits will go to production, only to refinance old debt, and each loan is tied to mandatory import controls, currency devaluations, first lien on export revenues, and brutal austerity.

On the other hand, the credit strangulation of the advanced sector has already precipitated a second collapse of world production and trade beginning this October. To cite a few representative Japanese figures: Japan's export orders fell 85 per cent in October from the previous month, its plant exports fell 94 per cent, while domestic orders for industrial machinery were down 64.3 per cent.

Under such conditions, Rockefeller's refinancing gimmicks are predestined to fail. The idling of the advanced sector's industrial capacity only undermines the ability of the entire world economy to pay its debt. This truth was brought home with a vengeance on Friday when the Federal Reserve and Swiss banks were forced to intervene massively to prevent a collapse of the dollar, despite the heavy seasonal demand for dollars to repay debts and the aforementioned credit cut-off to the advanced sector. Foreign exchange traders reported on Friday that the confidence in the Euro-dollar market has been irrevocably shaken and investors are rushing into Swiss francs instead. Although the New York banks and their London subsidiaries have attempted to rig the foreign exchange markets by simply refusing to carry out "speculative" transactions -- effectively curbing currency trading -- a dollar collapse is now on.

To fill out this picture, Loeb Rhoades analysts have issued a study on the exposure of New York banks in the Euro-dollar market. They conclude: "We view the purchase of shares of these large (new York) banks as an ACT OF FAITH." The analysts estimate that the five largest N.Y. banks have an average 52 billion in foreign loans outstanding, and will be unable to survive the inevitable debt defaults and moratoria resulting from the collapse of world trade.

Other sources estimate that Chase Manhattan, Marine Midland, Bankers Trust, and Chemical have bad loans ranging from 50 to 70 per cent of their outstanding assets.

Federal Reserve Chairman Arthur F. Burns has notified the New York banks that they cannot survive beyond January 1976 via Fed Funds alone, and hence would have to raise equity capital early next year. Bankers Trust and Chemical Bank, both of New York, tried it earlier this year under much better circumstances, and were totally unsuccessful.

As one top New York bank analysts put it: "Can you imagine Marine Midland being able to sell equity?" adding, "It's a terrifying prospect!"

IDB MUST BE IMPLEMENTED NOW: LAROUCHE

Speaking at a press conference in Bonn, West Germany this week, U.S. Labor Party Presidential candidate Lyndon H. LaRouche, Jr., warned that "if nothing is done to implement the International Development Bank, the center piece of a new world economic order, then a third world war and nuclear annihilation of the human race is likely in a matter of weeks."

Mr. LaRouche indicated that the IDB is "precisely the mechanism necessary to provide orderly bankruptcy proceedings... The can no longer be any question of the bankruptcy of the capitalist system, the question is what form will it take."

"Should the upcoming North-South talks not produce the required explicit discussion of debt moratoria and the IDB," Mr. LaRouche stated, "then I advise the Soviets to go ahead and push (a proffer) a transfer ruble. The risk involved (to the Soviets) was minor compared to the imminent danger of a third world war."

Mr. LaRouche has been in Europe since last week for meetings on the IDB with socialist leaders and representatives of Third World governments.

THE DEAD END ECONOMY

Dec. 6 (IPS) -- New statistical reports released last week by the Conference Board and the Federal Reserve Bank of Chicago dashed all thoughts about a "U.S. recovery" and confirm once again that the domestic economy has entered a bottomless collapse.

The reports indicate that a major source of present corporate liquidity is not only third quarter profits (based on record increases in productivity), but a dramatic slash in capital spending and appropriations.

According to the Conference Board, a private economic research group based in New York, capital appropriations in the third quarter were down 5 per cent from the second quarter. This marks a significant drop, particularly adjusting for inflation. However, coming at a time when corporate profits were skyrocketing, the drop has even more devastating implications, corporations are now using their earnings almost entirely to pay off debt, rather than reinvest in the maintenance and improvement of plant and equipment. The third quarter downturn in capital appropriations indicates that the downturn in actual spending will continue through at least the first half of 1976.

In a release on Wednesday the Federal Reserve Bank of Chicago pointed up the impact of the collapse of capital spending on the capital goods sector:

The longest and sharpest decline in economic activity since World War II ended last spring and a pronounced recovery has occurred since then. The Midwest has not fully participated in the upswing, primarily because of its emphasis on durable goods, especially producer equipment... The five states of the seventh Federal Reserve District - Illinois, Indiana, Iowa, Michigan, and Wisconsin - with 16 per cent of the nation's population turn out about one-third of its producer equipment. The region accounts for 40-60 per cent of the nation's output of motor vehicles, engines and turbines, farm equipment, construction equipment, and metalworking machinery." (emphasis added)

While the "economic recovery" is clearly pabulum designed to assuage the nervous stomachs of bankers and corporate officials, the dispatch contains a grim and accurate picture of the capital goods collapse.

The industries named by the Chicago Fed are, not coincidentally, experiencing a collapse of profits. On Wednesday it was reported that International Harvester ended its 1975 fiscal year with loss of \$40.9 million - its largest yearly loss in recent history. Without an increase in sales - an impossibility at this point without the implementation of the International Development Bank - Midwestern industrialists and bankers will desperately try to maintain

profit margins through self-defeating productivity drives and wage gouging and cutbacks on capital spending.

DEBT REFINANCING - THE LAST TIME AROUND

The liquidity generated by the collapse of Department I (producer goods) is being used to refinance outstanding debt. The continuing decline of production-related loans primarily by the Rockefeller-controlled New York banks has "freed" liquidity for massive refinancing operation of the upwards of 50 per cent bad loans in those banks' portfolios.

The collapse of the airlines, which broke into the press this week, clearly illustrates bank policy on refinancing. The airlines' creditors, primarily banks and insurance companies, are in the process of finalizing plans to restructure the debt of Pan Am, Eastern, and TWA - the three major airlines which face default on loans in January.

According to industry analysts, the banks and insurance companies simply had no other choice, the alternative being the Hobson's choice of either major defaults or major write downs. With on-going operating losses continuing, there is no hope for recovery in airline profits, which means the creditors are apparently throwing more money down a sinkhole.

In the case of the Eastern bail out, where banks and insurance companies last week tentatively agreed to defer debt repayment of about \$75 million due in early 1976 until 1977, the financial plans are tied to an extensive cost-cutting program, including a pay freeze for 1976 and deferral of one of three giant Lockheed Corp. L-1011s scheduled for delivery in the fourth quarter of this year. The deferral of the leasing of this \$20 million aircraft, of course, means more bad news for bankrupt Lockheed as well.

In the Pan Am "crisis" 13 of the original 36 creditors who gave the airline a "last gasp" of \$125 million in October 1974 have jumped ship and are refusing to go along with a new bail out. Likewise, the smaller members of TWA's creditor group have been the slowest to assent to that airline's two-year debt restructuring plan. The point here is clear: the smaller banks are in no position to refinance the loans.

FORD IN THE VICE: "DAMNED IF I DO, DAMNED IF I DON'T"

The ultimate solution for the Rockefeller standpoint for airlines, railroads, and other bankrupt sectors is precisely federal bailout, which would secure the banks' loan assets. This is the same solution the banks have been fighting for with respect to their New York paper. Credit infusions into the banks, as Federal Reserve Chairman Burns has been doing, can only be a short-term solution for the banks, one which will clog the banks with a lot of reserves which the cannot turn into profit making assets.

On Thursday the Senate passed a \$9.5 billion Conrail bill, on direct specifications from the Rockefeller banks. Not only does the bill include loans, grants and asset valuation \$10 billion in excess of what the Administration has stated as acceptable, but it includes deregulation (of freight rates) which is even more unacceptable to the Ford Administration. Ford has been set up for

thorough discreditation by Rockefeller forces over the rail legislation.

If Ford vetoes the bill, he will bring down the wrath not only of the Rockefeller-allied liberal Republicans and Democrats (similar to the banks' "New York bail out" allies), but also of the creditors. To convince Ford to change his mind the creditors have threatened to "pull the plug" on the Northeast rail lines through Chapter 11 liquidation, if they don't get what they want.

If Ford accepts the Senate Commerce Committee bill, he will, as the Wall Street Journal states, bring down the wrath of conservative Republican layers around Presidential aspirant and former California Gov. Ronald Reagan and likely lose early primaries to the latter.

Ford finds himself in an identical "damned if I do - damned if I don't" position on two other fronts, energy and taxes. If he signs the oil price rollback bill now before Congress, as inside Rockefeller man Federal Energy czar Frank Zarb is urging him to do, then Ford is set up for a two-pronged destabilization by the Reagan forces and the direct Rockefeller oil interests. The head of Standard Oil of Ohio (Soho) made this clear in stating that if Ford signed the bill, domestic and foreign demand for U.S. oil would jump dramatically while production would drop. This would lead to massive energy shortages and create the potential for an effective Arab oil embargo.

If Ford doesn't sign the bill, accepting Simon's counsel, the results will be automatic decontrol and price increases and the wrath of liberal democrats and the nation's industrial interests. The shock of the energy price rise would send the economy into an immediate tailspin, comparable to the economic collapse set off by the original October 1973 oil hoax.

The House this week approved legislation that will continue through next year \$13 billion in tax reductions for individuals and corporations and simultaneously defeated Ford's demand for a budget ceiling of \$395 billion. If Ford vetoes the bill, as Simon and Council of Economic Advisers head Greenspan are advising, there will be an instant increase in withholding taxes of upwards of \$15 billion starting Jan. 1. Such an increase would collapse stagnating retail sales and set Ford up for discrediting on yet one more account.

The President's track record under similar conditions of stress in the New York City situation makes it likely that he will attempt to compromise his way out of each of the above predicaments. Whatever bailout and tax cut legislation finally emerges, it will do little save postpone disaster while alienating Ford from at least some of his "friends." Ford and his advisers have no idea how to restart the economy. When the plug is finally pulled, his political career will quickly go down the proverbial drain.

THE EMPEROR'S NEW CLOTHES

As each of the pieces of the so-called New York City bailout package are put together in Albany and Washington, the New York banking community is growing more, not less anxious over the New York situation and its ramifications.

Evidently, the leading bankers are not all satisfied with

the status of their glutted portfolios of New York State and City paper. As one leading financial source stated this week, "There's nothing to feel good about. We haven't been paid back yet. Certainly with all the iron-clad assurances about the austerity to be imposed on the New York City and State, there is every reason to believe that the more than \$20 billion in outstanding New York paper will be paid back... or will it."

As most bankers are quick to point out, despite the austerity measures now in effect and those promised, there is still a long way to go before the banks can feel easy. Significantly, there is a growing opposition among broad sectors of the population to the "let's cut out throats for the sake of the debt" attitude being demanded by the New York bankers.

At the recent session, no one has wanted to swallow the bankers' bitter pill; loyal allies of the banks including Gov. Carey have simply been unable to deliver the votes and the whole austerity question has been put off until January. Even the \$205 million city tax increase passed by the legislators requires additional action before it goes into effect.

And then of course there is still the problem of the debt moratorium that the legislator went ahead and passed on \$1.3 billion city notes. Each time the words are brought up with the nervous bankers, they produce the same reaction: "Don't talk about that. It's just a formality." The banks are clearly nervous that some one may get the idea to extend the moratorium and junk the whole austerity package.

The banks had thought they could encourage people to accept a voluntary swap for high yielding MAC notes and avoid the precedent of having a substantial moratorium go into effect next week. Some financial sources report that less than 5 per cent of all note holders have agreed to the swap. Other sources put the number agreeing as less than 1 per cent.

With this overwhelming affirmation of the inherent valueness of MAC and city paper, no one is talking - even under their breath - about the possibility of marketing any new city or State paper.

Despite this, many bankers greeted the near passage of the Ford Plan with hosannas. However, in public the bankers tell a different story. "The city and state are on their way toward a sound fiscal policy. There is no chance of a default now the danger is over," and so on.

At this point the New York banks are hanging on by a thread. They are severely overexposed - and not just on actual bankruptcies. Almost anything, any tremor, could trigger a total collapse.

In such an environment, the distraught bankers tend to psychologically console themselves by lying that "a collapse could never occur" - while they gaze over the precipice.

"It's just like the children's fairy tale the Emperor's New Clothes," an analyst said yesterday, "You know that one. Everybody knew the Emperor had no clothes on, but nobody had the guts to say so. Well, everyone know how bad shape the New York banks are in and everyone knows that the bailout plan won't help. I'm afraid that we're going to be found out soon."

WORLD WAR III IS UNDERWAY

Dec. 6 (IPS) -- "World War III is already underway and it is a war for Western Europe... The Fourth World War may have to begin soon and that will be a war for the United States itself."

With this assessment, former State Department official, Eugene Rostow, yesterday gave a New York reporter the most sobering and accurate evaluation of the Rockefeller faction's strategic position to date.

In the span of approximately 48 hours, other public spokesmen for the Rockefeller interests made statements converging on Rostow's World War III formulation.

The Rockefeller cabal has thus battened down its hatches and been put on a full-war mobilization; since these spokesmen for World War III had in recent weeks offered views askew from "dead center" Rockefeller policy, their sudden convergence on critical policy matters indicate that all elements of the cabal have received identical marching orders and told to carry them out - or else.

These extraordinary actions are provoked by the Rockefellers' fear of an impending demise of their dollar based empire triggered by developments surrounding the upcoming North-South conference in Paris: If the Third World puts forward proposals for debt moratoria and the creation of a new non-dollar based credit financing arrangement to finance development-oriented triangular trade, the Rockefeller empire will collapse and with it the Rockefeller hegemony over the post-war world.

U.S. Labor Party Presidential candidate Lyndon H. LaRouche, Jr., warned this week in a Bonn press conference that Rockefeller can perceive no choice short of surrender other than to push for a thermonuclear confrontation with the Soviet Union over the next 90 days. Rockefeller has already initiated a process leading toward a hot World War III, LaRouche said. Unless the Rockefellers and their collaborators are removed from all positions of economic and political power within the next several weeks at the latest, the USLP candidate continued, the world will be engulfed in a thermonuclear holocaust possibly as early as Christmas and certainly no later than the end of February.

THE DECLARATION OF WAR

The sense that war has been declared is unmistakable from the aforementioned series of defacto policy pronouncements being disseminated by Rockefeller spokesmen this week. The virulent anti-Communist tone of their statements is reminiscent of the "coldest" 1947-54 period of the so-called Cold War. More significantly, the aggressive and provocative nature of their proposed remedies to current hotspot foreign policy areas are an indication that the

confrontation-war scenario has in fact been set in motion.

In an interview with a New York-based reporter, Eugene Rostow, aside from his World War III pronouncements, detailed a plan to use black operations and black propaganda to magnify the revolutionary threat in Portugal (i.e., that posed CIA provocateurs on the left and the right). This could then be used both as bludgeon against other Western European communist parties and as a rallying point around which to pull together a unified Europe. Obviously reflecting on the current Rockefeller faction predicament, Rostow also warned, "War comes when people get desperate and they begin losing control."

*Maoist Sen. Scoop Jackson (D-Wash), at a Chicago press conference yesterday, called for an economic boycott of the Soviet Union and declared that the time would soon be ripe in the USSR for "a revolution against the leadership."

*Right-wing Georgetown thinktanker Ray Cline warned of Cuban troops in Portugal and cited the U.S. subversion of European communist parties immediately after World War II as an appropriate model to use in Portugal.

*Long-time Vietnam dove and former Defense Secretary Clark Clifford who called in Congressional testimony yesterday for cover operations modelled on the U.S. intervention into the 1948 Italian elections.

*Dissident former State Department official Morton Halperin, testifying at the same hearings, called for an open economic boycott of Portugal should the Communists gain in influence.

THE INTERNATIONAL DEPLOYMENT

Simultaneous with the meeting of David Rockefeller's Trilateral Commission in Paris on Nov. 29-Dec. 1, Secretary of State Henry Kissinger was convening an operational war cabinet with him in Peking. With Kissinger on the supposedly "unimportant" China visit, were the following: National Security Advisor Gen. Brent Scowcroft, Assistant Secretary for Political Affairs Joseph Sisco, Assistant Secretary for Far Eastern Affairs Phillip Habib, Director of Policy Planning Winston Lord, and senior National Security Council Staff Advisor Richard Soloman.

While President Ford went to badminton games, Kissinger and his war cabinet discussed "issues of mutual concern" with the Chinese -- issues such as Soviet "hegemonism" in Europe, Angola and the Indian subcontinent.

From China, Kissinger and his chief hatchetman Sisco will take a side trip to Japan to try and bludgeon Prime Minister Miki away from the pro-IDB, pro-fusion-power posture that the Japanese took at the Rambouillet summit. After a brief stopover in the U.S., Kissinger will head for meetings of NATO Foreign Ministers and U.S. Ambassadors in Western Europe -- all just prior to the Paris North-South conference.

Coinciding with Kissinger's European trip will be the execution of the HILEX 75 NATO maneuvers. HILEX 75 involves unprecedented wargames including not only military, but civilian personnel from European countries' domestic ministries, in a simulated collapse of the economies of Western Europe coupled with a communist insurrection. (See special report.)

With operational control of the U.S. government increasingly in the hands of a few loyal Kissinger NSC'ers, it is no surprise that regular White House channels and most of the regular military reached over the last two days were uninformed of the maneuvers.

"WORLD WAR IV" - THE BATTLE FOR THE U.S.

IPS estimated this week that in order for the Rockefellers to roll over their current outstanding second quarter debt the living standards of the U.S. working class must be reduced by 30 per cent within the coming months. The rapid passage of several pieces of legislation, the provocation of strikes in upcoming contract negotiations and the lack of resistance from potentially factional right-wing layers led by Treasury Secretary William Simon provides the economic basis for carrying out these policies. The implementation of such austerity measures and the concomitant decline in living standards can only be accomplished by the imposition of a police state.

Attorney General Edward Levi sounded the keynote for such a development in a private, heavily guarded speech at Columbia University on Dec. 2. Levi openly threatened that any attempt by the House Committee on Intelligence (the Pike Committee), or any other Congressional body to call into question the illegal covert activities of the Executive branch would immediately destroy the constitution and the government.

Simultaneously, FBI Director Clarence Kelley and outgoing CIA director William Colby warned of the danger of internal subversion and pleaded that the intelligence and security services not be hamstrung by unnecessary restrictions of the freedom of operation. Kelley called directly for the establishment of sane guidelines that would effectively "legalize" covert COINTELPRO-type operations - thus dovetailing with statements calling for such guidelines to be incorporated into the fascist criminal code reform legislation, S.1.

Parallel with Levi's speech, a wave of terror was unleashed against the working-class allies of the U.S. Labor Party, against Congress and against industrial opponents of Rockefeller.

On Dec. 3, Levi ordered an illegal gestapo-style raid by Levi-controlled Immigration and Naturalization Service (INS) agents against a Chicago factory employing a large number of Mexican American immigrant workers and of USLP supporters. A Labor Party network captain was taken into custody along with 10 other Mexican American workers. They were grilled by INS members on Labor Party activity.

Only two days earlier 80 of the plant's 140-man workforce had signed a Labor Party petition calling for an end to National Security Council ordered invasion against the People's Republic of Angola.

The Chicago-based industrialist opponents of Rockefeller are being threatened with "official secrets"-style prosecution if they take information from the USLP. While privately arranging to open up major lines of credit to Japan and privately agreeing for a need for a debt moratorium, these layers have yet to publicly organize for such proposals. As such they are increasingly vulnerable to Rockefeller attack.

Congress, led by the Pike Committee, has temporarily collapsed in the face of the Levi onslaught. Pike has withdrawn 2 out of 3 contempt motions against Kissinger. The rest of Congress is reportedly succumbing to a behind-the-scenes "reds under the beds" campaign.

NOV. 29 (IPS) THE WORLD'S SOVEREIGN NATIONS SHOULD "REDOUBLE" THE PROTECTION OF THEIR NATIONAL LEADERS TO AVOID CIA-LED ASSASSINATION ATTEMPTS, THE LEFT-WING INDIAN DAILY, PATRIOT, WARNED IN A NOVEMBER 23 EDITORIAL. THE PAPER CHARGED THAT THE CIA HAS A "MURDER PHILOSOPHY" WHICH IS THE PRODUCT OF A "DECAYING POLITICAL SYSTEM." 

SIGNS OF NATO PROVOCATION IN ARABIAN GULF AREA

NOV. 29 (IPS)—THE BRITISH COMMANDER OF THE ARMED FORCES OF THE SOUTHEAST ARABIAN STATE OF OMAN, MAJ. GENERAL KENNETH PERKINS, HAS PREDICTED THAT HIS COUNTRY'S TEN-YEAR WAR AGAINST MARXIST GUERRILLAS WILL BE OVER BY CHRISTMAS, ACCORDING TO YESTERDAY'S DAILY TELEGRAPH OF LONDON.

CALLAGHAN THREATENS NORTH-SOUTH TALKS SABOTAGE

DEVELOPMENT DEBATE SABOTAGED IN WEST GERMAN PARLIAMENT

**PCI SABOTAGES JAPANESE PLANS TO EXPAND PRODUCTION
AT BANKRUPT ITALIAN FIRM**

NOV. 29 (IPS)—JAPANESE PLANS TO PURCHASE THE BANKRUPT INNOCENTI ITALIAN SUBSIDIARY OF BRITISH LEYLAND IN MILAN HAVE BEEN THOROUGHLY SABOTAGED BY AN ALLIANCE OF FORCES OF THE ITALIAN COMMUNIST PARTY (PCI), THE CIA-CONTROLLED LEADERSHIPS OF THREE TRADE UNION FEDERATIONS, AND FIAT, THE GIANT ITALIAN AUTO MAKER CONTROLLED BY LEADING ROCKEFELLER AGENT GIANNI AGNELLI.

WHILE LEYLAND HAS ANNOUNCED IRREVOCABLE PLANS TO CLOSE DOWN THE INNOCENTI PLANT AND LAY OFF ITS 4,500 WORKERS DUE TO THE PLANT'S UNPROFITABILITY, THE JAPANESE HAD STATED THEIR DESIRE TO PURCHASE THE PLANT, IMPROVE ITS MACHINERY AND EXPAND OUTPUT.

BUT, ACCORDING TO OUTBURSTS IN BOTH THE PCI AND THE AGNELLI-CONTROLLED PRESS, THE JAPANESE PROPOSAL—WHICH WAS UNDER DISCUSSION AT THE GOVERNMENT LEVEL BY BOTH JAPAN AND ITALY—RAN COUNTER TO AGNELLI'S PLANS FOR A FASCIST "RESTRUCTURING" OF ITALIAN INDUSTRY BY CANNIBALIZING SMALL AND MEDIUM SIZED FIRMS SUCH AS INNOCENTI.

THE TRADE UNION FEDERATIONS, THE COMMUNIST-LINKED CGIL, CISL AND UIL, HAVE FIRMLY SUPPORTED AGNELLI'S RESTRUCTURING PROPOSALS AND HAVE BEEN USING THE SPECTRE OF UNEMPLOYMENT IN ORDER TO FORCE THEIR MEMBERS TO FOREGO WAGE INCREASES. THEY FEARED THAT THE JAPANESE PLAN, BY MAINTAINING AND EVEN POSSIBLY INCREASING JOBS, MIGHT SPARK WIDESPREAD DEMANDS FOR WAGE HIKES. TO DEFEND THEIR POSITION, THE UNIONS ARE SAYING THAT THE INNOCENTI CASE MUST BE A TEST CASE OF THE GOVERNMENT'S OWN ABILITY TO ACHIEVE THE "RESTRUCTURING OF INDUSTRY."

DEVOLUTION SPLITS BRITISH PARLIAMENT

NOV. 29 (IPS)—THE PUBLICATION OF THE BRITISH GOVERNMENT'S WHITE PAPER ON DEVOLUTION (SELF-GOVERNMENT FOR SCOTLAND AND WALES) HAS SUCCESSFULLY SPLIT THE BRITISH PARLIAMENT, DEFLECTING DISCUSSION FROM BRITAIN'S CRITICAL ECONOMIC CRISIS.

ACCORDING TO THE LONDON TIMES, "ALL OPPOSITION PARTIES AT WESTMINSTER ROUNDLY AND IN DETAIL CONDEMNED THE GOVERNMENT'S PROPOSALS." WHILE CONSERVATIVE PARTY LEADERS CLAIMED THE PROPOSALS WOULD "DESTROY THE BASIC UNITY OF THE UNITED KINGDOM," LIBERAL LEADER JEREMY THORPE SAID THE WHITE PAPER REPRESENTED "THE VERY LEAST WHICH THE GOVERNMENT BELIEVES IT CAN GET AWAY WITH TO SATISFY...NATIONALIST EMOTION IN SCOTLAND AND WALES."

JAPANESE PUBLIC WORKERS MOVE TO DEFEND STRIKE

NOV. 29 (IPS)—THE MASSIVE STRIKE OF JAPANESE PUBLIC EMPLOYEES, LED BY THE WORKERS OF THE JAPANESE NATIONAL RAILWAYS, HAS BEEN EXTENDED AFTER A DECISION BY THE UMBRELLA UNION OF PUBLIC WORKERS, KOROKYO, YESTERDAY. ACCORDING TO UPI, KOROKYO DECIDED TO MAINTAIN THE FULL SHUTDOWN OF THE JAPANESE PUBLIC RAIL SYSTEM, REVERSING PREVIOUS PLANS TO HAVE THREE DAYS OF LIMITED STRIKES AND RESTORE SERVICE ON THE TOKYO AND OSAKA COMMUTER TRAINS AND THE NATIONAL "BULLET TRAIN" LINE.

THE RAIL STRIKE IS ALREADY THE LONGEST IN JAPANESE HISTORY, SURPASSING THE PREVIOUS RECORD OF 62 HOURS. PARTIAL SHUTDOWNS OF OTHER SERVICES, INCLUDING POSTAL, TELEGRAPH AND TELEPHONE, WILL ALSO CONTINUE, AS THE UNIONS SEEK TO WIN FROM THE GOVERNMENT THE LEGAL RIGHT TO STRIKE BY PUBLIC WORKERS.

II. CONTINENTAL

SECOND EXPLOSION IN WAVE OF BOMBINGS IN MEXICO

NOV. 29 (IPS)—A BOMB EXPLODED EARLY THIS MORNING IN THE DOOR OF THE COMMERCIAL OFFICE OF THE SOVIET EMBASSY IN MEXICO CITY. ACCORDING TO EARLY DISPATCHES FROM PRENSA LATINA, THE CUBAN WIRE SERVICE, NO ONE WAS HURT IN THE POWERFUL BLAST.

THE EXPLOSION FOLLOWED BY LESS THAN 24 HOURS THE BOMBING OF THE CAR OF THE CUBAN AMBASSADOR IN MEXICO. RESPONSIBILITY FOR THE EARLIER EXPLOSION HAS BEEN TAKEN BY A GROUP OF ANTI-CASTRO CUBAN EXILES LINKED TO THE ALPHA-66 GROUP.

PHILADELPHIA INQUIRER BOOSTS SWP PRESIDENTIAL CAMPAIGN

NOV. 29 (IPS)—YESTERDAY'S PHILADELPHIA INQUIRER CARRIED AN ARTICLE ON THE VARIOUS DEMOCRATIC AND THIRD PARTY PRESIDENTIAL CANDIDATES WHICH FOCUSED MOST OF ITS ATTENTION ON PETER CAMEJO, THE CANDIDATE OF THE FBI-CONTROLLED SOCIALIST WORKERS PARTY (SWP). THE INQUIRER STATES THAT CAMEJO IS "NOT JUST ANOTHER CANDIDATE" AND THAT THE SWP IS "THE MOST ACTIVE SOCIALIST POLITICAL GROUP IN THE COUNTRY."

ASKED ABOUT RECENT FBI CLAIMS THAT IT HAD SUCCESSFULLY INFILTRATED THE SWP UNDER ITS COINTELPRO PROGRAM, CAMEJO SMILED AND SAID, "J. EDGAR HOOVER IS, IN AN ODD WAY, PRIMARILY RESPONSIBLE FOR A NEW-FOUND PUBLIC INTEREST IN SOCIALISM."

THE INQUIRER DID NOT MENTION THE CANDIDACY OF LYNDON H. LAROCHE, JR., OF THE U.S. LABOR PARTY. LABOR PARTY CANDIDATES POLLED AN ESTIMATED 30 PER CENT OF THE VOTE IN THE RECENT, FRAUDULENTLY COUNTED PHILADELPHIA MAYORAL ELECTION.

KISSINGER BEGINS WORLDWIDE TRIP TO WRECK NORTH-SOUTH MEETING

WASHINGTON, D.C., NOV. 29 (IPS)—SECRETARY OF STATE HENRY KISSINGER'S VISIT TO PEKING IS ONLY THE FIRST LEG OF A WHIRLWIND INTERNATIONAL TOUR BY THE SECRETARY, WHOSE AIM WILL BE TO WRECK THE NORTH-SOUTH ECONOMIC CONFERENCE SCHEDULED TO BEGIN IN PARIS DEC. 16.

KISSINGER LEFT FOR PEKING TODAY ACCOMPANIED BY PRESIDENT FORD.

AFTER MEETING WITH THE CHINESE, WHO HAVE BEEN WORKING CLOSELY WITH KISSINGER'S NATIONAL SECURITY COUNCIL IN ATTEMPTING TO SET UP A CONFRONTATION WITH THE SOVIET UNION ON THE INDIAN SUBCONTINENT, KISSINGER WILL PROCEED TO JAPAN, WHERE HE WILL CONTINUE HIS EFFORTS TO BULLY THE JAPANESE INTO WITHDRAWING THE PRO-DEVELOPMENT PROPOSALS ADVANCED BY PREMIER MIKI AT THE RAMBOUILLET ECONOMIC SUMMIT EARLIER THIS MONTH.

KISSINGER WILL THEN HEAD FOR EUROPE TO PRESIDE OVER A SERIES OF HIGH-LEVEL MEETINGS, INCLUDING A CONFERENCE OF NATO FOREIGN MINISTERS IN BRUSSELS ON DEC. 10-11 AND A MEETING OF U.S. AMBASSADORS TO EUROPE IN LONDON ON DEC. 12-13.

KISSINGER IS SEEKING TO PREVENT THE THIRD WORLD GROUP OF 77 FROM FORCING INTERNATIONAL DEBT MORATORIA AND A NEW NON-IMF WORLD LENDING INSTITUTION.

"FATHER" OF THE LEAA IS TOP ADVISER TO SENATOR BAYH

BOSTON, NOV. 29 (IPS)—JAMES VORENBERG, A FOUNDER OF THE LAW ENFORCEMENT ASSISTANCE ADMINISTRATION (LEAA), IS A TOP ADVISER TO THE PRESIDENTIAL CAMPAIGN OF INDIANA SENATOR BIRCH BAYH, ACCORDING TO BAYH'S BOSTON CAMPAIGN MANAGER.

VORENBERG, WHO MODELED THE LEAA ON HITLER'S GESTAPO, LAST YEAR DEFIED A SUBPOENA FROM THE BOSTON CITY COUNCIL DEMANDING THAT HE TESTIFY ON CIA INFILTRATION INTO THE BOSTON POLICE DEPARTMENT AND CITY GOVERNMENT.

POLITICAL OBSERVERS FEEL THAT VORENBERG MAY WELL HAVE HAD A HAND IN BAYH'S DECISION TO BACK OFF FROM HIS ORIGINAL OUTRIGHT SUPPORT FOR THE PROPOSED FASCIST REVISION OF THE FEDERAL CRIMINAL CODE, S. 1, AND SEEK TOKEN AMENDMENTS TO THE BILL WHICH LEAVE ITS BASIC VIOLATIONS OF CIVIL LIBERTIES INTACT.

VORENBERG'S PRESENCE ON THE BAYH CAMPAIGN STAFF IS PART OF AN EMERGING PATTERN OF ROCKEFELLER AGENTS ACTING AS KEY ADVISERS TO DEMOCRATIC PARTY PRESIDENTIAL CANDIDATES.

NOV. 24 (IPS)—AN EMERGENCY ORGANIZATION OF AFRICAN UNITY (OAU) MEETING ON ANGOLA HAS BEEN SCHEDULED FOR NOV. 28-30 AT ADDIS ABA-BA, ETHIOPIA, ACCORDING TO YESTERDAY'S BRITISH OBSERVER. THE MEETING WAS CALLED BY SOMALIA, WITH THE BACKING OF ALGERIA AND ETHIOPIA, TO DISCUSS AN ALTERNATIVE TO THE PROPOSAL OF UGANDAN LEADER IDI AMIN, CURRENT PRESIDENT OF THE OAU, TO SEND "PEACE-KEEPING FORCES" TO CLEAN OUT THE PRO-SOVIET POPULAR MOVEMENT (MPLA) GOVERNMENT.

TODAY'S WASHINGTON POST REPORTS THAT THE OAU MEETING MAY SCUT- TLE AMIN HIMSELF ALONG WITH HIS "PEACEKEEPING FORCE" PROPOSAL. ALREADY, PRESIDENT MARIEN NGOUBI OF THE PEOPLE'S REPUBLIC OF THE CONGO AND PRESIDENT SEKOU TOURE OF GUINEA-CONAKRY HAVE RECEIVED SUPPORT FOR THEIR PUBLIC STATEMENTS DEMANDING THE RESIGNATION OF HIS EXCELLENCY FIELD MARSHALL AL-HADJ IDI AMIN DADA FROM HIS POST AS OAU PRESIDENT.
