## DEMAND DISCLOSURE OF INVESTIGATION ON DEATH THREATS AGAINST CONGRESSMAN

DEC. 23 (IPS)—LARRY FREEMAN, SPOKESMAN FOR THE BALTIMORE BRANCH OF THE U.S. LABOR PARTY, DEMANDED TODAY THAT THE BALTIMORE CITY POLICE DEPT., THE FBI AND THE SECRET SERVICE MAKE FULL DISCLOSURE OF THE STEPS THEY HAVE TAKEN TO INVESTIGATE TELEPHONED DEATH THREATS AGAINST REPRESENTATIVE PARREN MITCHELL (D-MD.).

AN ARTICLE IN THE BALTIMORE AFRO-AMERICAN TODAY INDICATED THAT THE BALTIMORE CITY POLICE DEPT. HAS A PHOTO AND DOCUMENT FILE ON THE PERSONS WHO IDENTIFIED THEMSELVES WHEN THEY WENT UP ON CONGRESSMAN'S MITCHELL'S STEPS AT HIS HOME SUNDAY. IT ALSO INDICATED THAT MITCHELL BELIEVED THESE PERSONS TO BE THE SAME PERSONS WHO CALLED HIM TWICE ON SUNDAY AFTERNOON WITH DEATH THREATS. THE POLICE PHOTO FILE UNDOUBTEDLY CONTAINS PICTURES OF THE LABOR PARTY DELEGATION WHICH TRIED TO VISIT MITCHELL ON SUNDAY TO DISCUSS HIS ACTING AGAINST THE IMMINENT NUCLEAR THREAT REPRESENTED BY THE INSURRECTIONARY ACTS OF SECRETARY OF STATE HENRY KISSINGER AND HIS BOSS NELSON ROCKEFELLER. SINCE THESE INDIVIDUALS WERE NOT INVOLVED IN THREATENING MITCHELL'S LIFE, IT WOULD BE IN THE PUBLIC INTEREST FOR THE POLICE TO RELEASE ANY OTHER PHOTOS OF ALLEGED THREATENING PERSONS, AND ANY OTHER AVAILABLE EVIDENCE.

ANY IMPLICATION THAT THE LABOR PARTY WAS INVOLVED IN THESE DEATH THREATS TO MITCHELL, DESPITE THE STATEMENTS WHICH THE TERRORIZED MITCHELL HIMSELF IS MAKING, IS NOTHING BUT A COVERUP FOR A MASSIVE COINTELPRO OPERATION BEING WIELDED BY HENRY KISSINGER AND ATTORNEY GENERAL LEVI AGAINST OPPONENTS OF NUCLEAR WAR. THE LABOR PARTY HAS ALREADY MADE AVAILABLE TO THE AUTHORITIES IN BALTIMORE A PATTERN OF HARASSING AND ASSAULT INCIDENTS AGAINST MITCHELL AND OTHERS WHICH EXCEED IN SERIOUSNESS THOSE RECENTLY REVEALED OPERATIONS AGAINST THE LATE MARTIN LUTHER KING AND HIS ASSOCIATES. FULL DISCLOSURE BY THE AUTHORITIES OF THE EXTENT OF THEIR INVESTIGATION IS NOW DEMANDED TO ASSURE THAT MITCHELL AND OTHER CONGRESSMEN WILL INDEED BE PROTECTED, AND FREE TO ACT AGAINST THE MASSIVE NUCLEAR THREAT WHICH HENRY KISSINGER HAS NOW VOWED TO CARRY OUT AGAINST HIS THIRD WORLD, SOVIET AND EVEN CAPITALIST OPPONENTS.
