## Momentum Builds For Obama's Ouster

June 4—When LaRouche Democrat Kesha Rogers won the Democratic primary election in the 22nd Congressional district in the Houston, Texas area with 51% of the vote, the message resonated at the Obama White House and in every part of the Democratic Party nationally. Rogers had campaigned for the nomination, explicitly calling for the immediate impeachment of President Obama, on the grounds of his repeated Constitutional violations.

The White House and the Obama campaign had squeezed the Texas Democratic Party to use every dirty trick in the book to defeat Rogers—and they failed miserably. That failure highlighted the fact that, throughout the country, those so-called Democrats who have stood by Obama, in spite of his "high crimes and misdemeanors" against the Constitution, and his slavish subservience to Wall Street and London speculators, have presided over the erosion of the party, to the point that unless Obama is removed by impeachment or invoking of the 25th Amendment, sometime between now and the Democratic Convention this Summer, GOP nominee Mitt Romney could very well walk away with the Presidential election in November.

Not surprisingly, a secret poll conducted by U.S. intelligence circles, and reported to *EIR*, showed that only 19% of the people polled were satisfied with the November choice between Obama and Romney.

The only viable option for the Democratic Party is to oust Obama before August and return the party to its Franklin Roosevelt and John F. Kennedy tradition.

#### **Obama's Kill Lists**

Things have gone from bad to worse for Obama in recent weeks. A recent lengthy *New York Times* report on the President's weekly meetings in which he personally updates the list of assassination targets—including of American citizens—has caused an enormous backlash.

As revealed by the *Times*, Obama presides over a meeting every Tuesday, involving as many as 100 officials from the White House, the Pentagon, the CIA, and the Justice Department, where target lists of alleged terrorists are reviewed, and decisions are made to carry out assassinations. According to the account, Obama relishes these gatherings, and has no qualms about ordering extra-judicial assassinations. A DOJ memo from the Office of Legal Counsel, providing a jaded rationale for the Presidential hit-list, has been kept from Congress and the American people.

Moreover, the *Times* revealed that David Axelrod, who heads the Obama reelection campaign, frequently attends these meetings—despite the fact that he does not have the requisite security clearances, and is clearly attending for reasons of the campaign.

The criminal folly of the desperate Obama reelection campaign was further highlighted later, when a second *Times* story by David Sanger revealed classified details of the Obama Administration's cyberwarfare campaign against Iran's nuclear sector. The article, derived from a just-published book by Sanger on Obama's national security accomplishments, indicated that the U.S. was responsible, in league with Israel, for the Stuxnet computer virus that damaged Iran's nuclear centrifuges at Natanz. In the Sanger account, President Obama personally made the decision to go ahead with the cyber attack.

Sen. John McCain (R-Ariz.) went ballistic over the *Times* leak and demanded an FBI investigation into who at the White House or the Obama campaign jeopardized U.S. national security in a blatant election stunt.

### A 'Watergate Moment'?

The FBI has announced the launching of an investigation of the *Times* leak, and this could be another "Watergate moment" for Obama, as the clock is already ticking on the Fast and Furious scandal, in which the Obama Administration ran guns into Mexican drug cartels in a massive sting operation that went sour, and resulted in the assassination of at least one U.S. law enforcement officer.

Both the Justice Department and the White House are caught up in a coverup of that botched program, and House Government Reform Committee chairman Darrell Issa (R-Calif.) has already drafted a contempt of Congress bill against Attorney General Eric Holder for refusing to turn over vital DOJ documents, revealing the role of top Department and White House officials in

the coverup of Fast and Furious.

That contempt of Congress citation is expected to be brought before the House before the end of June.

Then, on June 6, the House Oversight Committee obtained evidence that will up the pressure on the White House. It obtained copies of sealed wiretap applications which revealed that, contrary to sworn testimony by Holder, three top officials of the DOJ Criminal division, including its head Lanny Breuer, knew about the gunwalking policy in March, April, May, June, and July of 2010. This revelation means that the top levels of the DOJ were involved, and Holder and the Department have lied again to Congress.

#### **The Clinton Factor**

As the Obama campaign lashes out in desperation, an old rift within the Democratic Party is once again bubbling to the surface. Former President Bill Clinton, while nominally campaigning for Obama's reelection, is being increasingly spotlighted as a sharp Obama critic.

A recent unauthorized biography of Obama by conservative writer Edward Klein contained detailed accounts of efforts by Clinton to press his wife, Hillary Clinton, to resign as Secretary of State, and challenge Obama in the Democratic primaries. The meeting, over a year ago, where the proposal was first spelled out, was reported in detail by Klein, and sources close to the author indicate that the account was provided to him by people who attended the meeting at the Clinton home in New York.

When the Obama campaign launched a frontal media assault on Romney for his job-slashing tenure as head of Bain Capital, a bevy of top Democrats, including Newark, N.J. Mayor Corey Booker, Massachusetts Gov. Deval Patrick, and financier Steve Rattner, all defended Romney and Bain. Rattner was devastating in his public remarks, observing that it is the job of the President—not the head of an investment fund—to create hundreds of thousands of jobs.

The final blow to the Obama-versus-Bain gambit was an CNN interview with Bill Clinton, in which he firmly defended Romney's tenure at Bain, and overall vetted him as qualified, as a successful businessman and former governor of Massachusetts, to be President.

Following the CNN interview, several leading Republican pundits, from Charles Krauthammer to ex-Clinton White House aide Dick Morris, noted with glee that Clinton is working behind the scenes to defeat Obama.

Clinton also personally campaigned against two Obama-preferred Congressional candidates in the June 5 primaries; in both cases—that of Rep. Bill Pascrell of New Jersey, and of Brad Sherman of California—Clinton's candidates won.


Infighting aside, it is clear that President Obama is a menace to the survival of the United States and he must be removed from office on Constitutional grounds before the United States self-destructs. Both Rep. Walter Jones (R-N.C.) and Sen. Jim Webb (D-Va.) have put bills before the Congress that set a framework for Obama's impeachment.
