# Fraud #1

# Doc. Nos. 01-88 are removed/missing.

Doc. Nos. 1-88 from 9/12/1984 to at least 12/28/1987 are missing. These documents would have shown the progress of the case filings from the beginning: the filing by attorney Deval Patrick of the original complaint on behalf of ACORN.

This is fraudulent since court documents are an official public record.

If confidentiality circumstances dictate that the judge seal or redact the record, the presence of the documents must nonetheless be acknowledged with a clerk of court's entry explaining why they are not available. They have attempted to cover this up with an obscure and meaningless "Docket Modification (Utility Event)" entry. Perhaps only "old boy" insiders know what this means, but the record is evidently meant to throw off the corruption dog's scent.

# Fraud #2

# Deval L. Patrick's public biographies say he sued Bill Clinton representing the NAACP Legal Defense Fund (LDF), yet no court record exists showing that he was Plaintiffs' attorney

# Fraud #3

# Deval L. Patrick's public biographies say he *settled* with Bill Clinton before trial, however, no settlement entries are shown

This is fraudulent since court cases that settle must have "Settlement Entries"

Settlement Entries are normally submitted by the Plaintiffs' attorney (in this case that would be **Deval Patrick representing the NAACP and ACORN.** 

This record has **no Settlement Entry**, not even a redacted or sealed one.

In confidential settlements, the clerk would still be required to make an entry disclosing the date and existence of a Settlement Entry.

In this case, the records have been removed unceremoniously.
