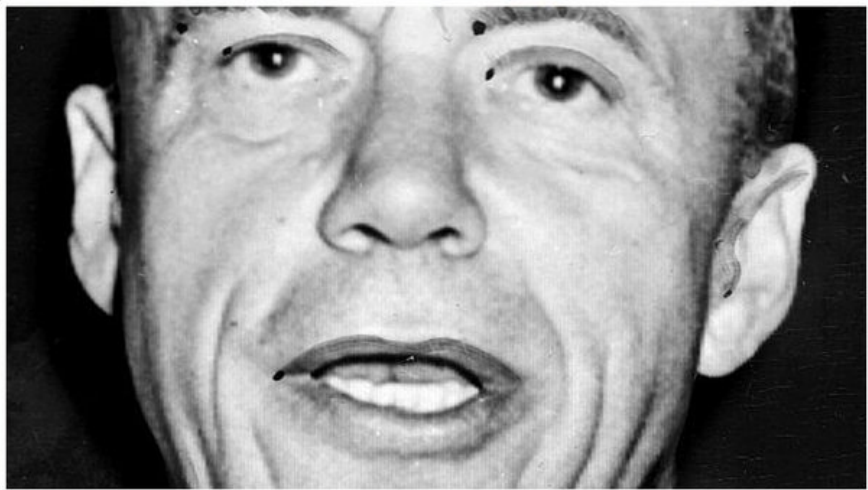


Fig. 2—Robert P. Patterson (b. 1891-d. 1952): Harvard Law (1915); Patterson Belknap Webb & Tyler (1915-1916); Judge, South District of New York (1930-39); Judge, 2nd Circuit (1939-1940); Under Secretary of War (1940-45); The Manhattan Project (1940-45); Secretary of War (1945-47); Marshall Plan Committee chairman (1947-48); New York Bar Association president (1952-); Council on Foreign Relations, president (1952-).




Fig. 3—Edward Geary Lansdale. *Stimson's and Acheson's go-to plumber* used to consolidate the stolen German and Japanese gold, silver, platinum, jewels, gems, paintings and other valuable treasurers. Lansdale arranged the transfers to the Bank of International Settlements (Bern). Allen W. Dulles was the Office of Strategic Services (OSS) Bern station chief at [Herrengasse No. 23, Bern, Switzerland](#) (ca. 1943-45).

In 1951, Allen W. Dulles, Lansdale's crime boss, was appointed director of the C.I.A. (1951-53) by Harry Truman. The C.I.A. was the successor to the OSS (and therefore British Pilgrims Society / MI6 founded and led). Among its over 30,000 people were many "stay behind" racketeers who were actually working for the Pilgrims Society / MI6 secretly. These stay behinds included many who were notoriously known for running private gold smuggling and money-laundering operations. These criminal operations did not stop when the OSS was formerly disbanded on [Sep. 20, 1945](#) by President Truman by Executive Order 9621. They continue to this day. For example, the [United Fruit Company](#) (now Chiquita Brands).

Lansdale's was attached to the U.S. Army during his OSS work for Donovan and Dulles during WWII. This placed him in the middle of the OSS seizure and transfer of the stolen Nazi and Japanese gold, silver, platinum, art, jewels, diamonds and other treasure, including gold ingots smelted from victims' teeth in the death camps.

From 1945-1948, after the end of the war, Lansdale was reassigned by the OSS to Air Force intelligence in South East Asia, most especially the Philippines. This was where the Japanese had hidden their stolen gold and other treasures from China and other captured countries in specially constructed caves. According to the Japanese general who oversaw construction of the caves, the engineers and laborers were all murdered to preserve the secrecy of the gold stores.

In 1953, Lansdale started "advising" the French forces in Indo-China, then was transferred to Saigon in 1954-56, during which time he "advised" the South Vietnamese forces, including in psychological operations. His primary role to *create* Pilgrims Society conflicts in "communist" hot spots in Cuba and Southeast Asia is evident in hindsight. (Remember: Communism was a *creation* of the [British Pilgrims Society in London](#) (PDF) as a way to enslave the masses inside their imperial corporatist new world order) He and Secretary of State Dean Rusk, also a Pilgrim, are materially responsible for pressing the Vietnam War through the Kennedy and Johnson administrations. Lyndon B. Johnson was a Pilgrim, Kennedy was not.

Some of Lansdale's colleagues believe that Lansdale was the C.I.A. agent who coordinated the assassination, perhaps to preserve the Pilgrims Society's Nazi gold secrets at the Bank of International Settlements (which would have been destroyed by the break up of the C.I.A.).

The Bank of International Settlements was the heart of the Stimson-Dulles-Donovan Marshall Plan that used the hoards of stolen gold to help finance their 200-year Anglo-American (British) Pilgrims Society agenda by enriching their insider group of banks, companies and organizations through secret Swiss bank accounts. 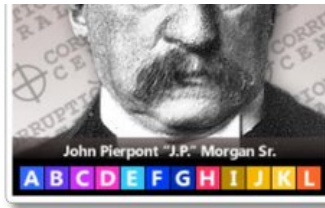


Fig. 9—J.P. Morgan. Pilgrims Society co-founder (1902) with Cecil Rhodes, Henry de Worms, Lord Rosebery, Andrew Carnegie, Elihu Root, Henry Wellcome, Sir Harry Brittain, Lord Burnham, Lord General Roberts, Viscount Milner, Lord Northcliffe, Winston Churchill, Guglielmo Marconi, Lord Rothschild, and MP Philip Whitwell Wilson (Vladimir Lenin, Joseph Stalin handler) et al.

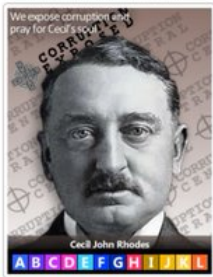


Fig. 10—Cecil John Rhodes. See AFI (Jan. 24, 2019). So you thought Rhodes Scholarships Were Good? Americans for Innovation.

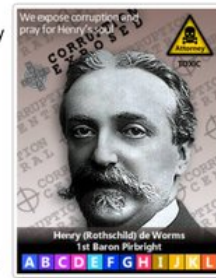


Fig. 11—Henry (Rothschild) de Worms, 1st Baron Pirbright (Coronavirus weaponization land, Pirbright, UK).

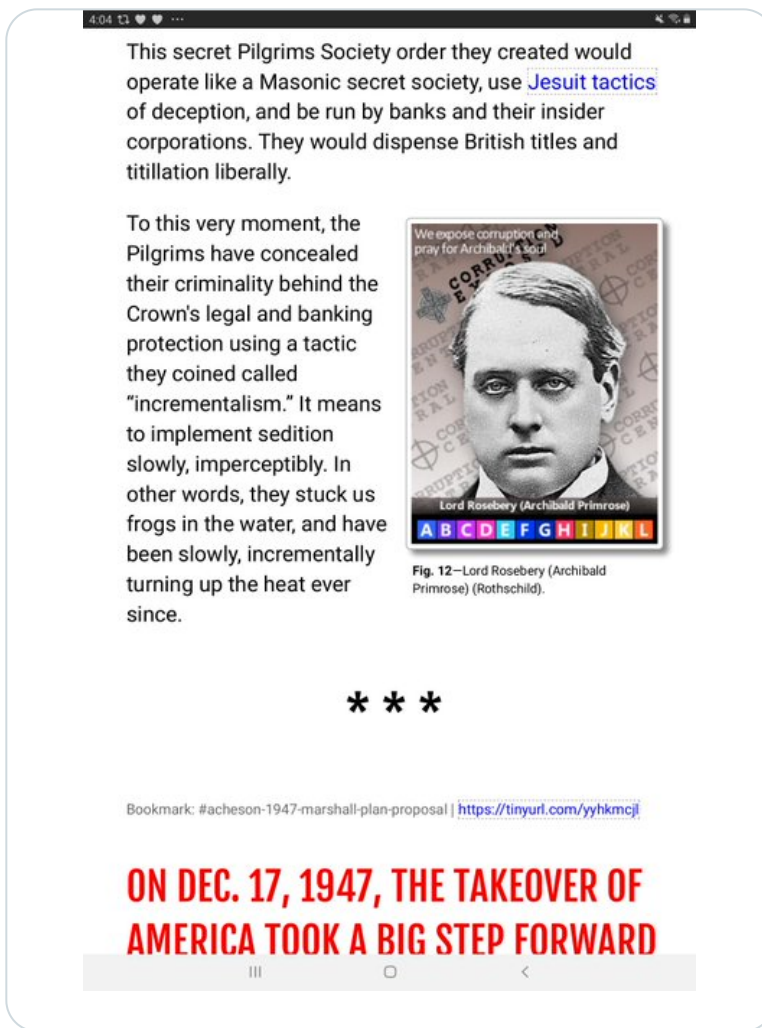

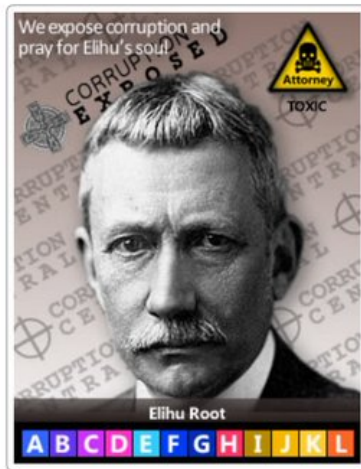


Fig. 15—Elihu Root. Attorney for Andrew Carnegie (ca. 1890-); Co-founder of the Pilgrims Society (1902); Secretary of State (1905-1909); Secretary of War (1899-1904); U.S. Senator (NY, 1909-1915); President of the Carnegie Foundation for International Peace (1910); President of the Council on Foreign Relations (1921)

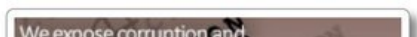

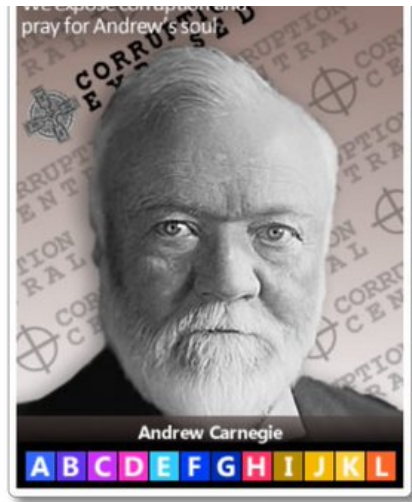


Fig. 17--Andrew Carnegie.

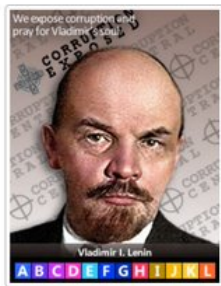


Fig. 20—Vladimir I. Lenin was a fabrication of the Anglo-American (British) Pilgrims Society. Here's the proof (PDF).

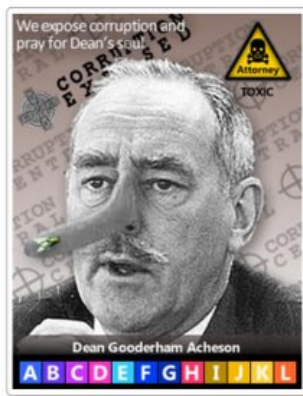


Fig. 21—Dean G. Acheson. Introduced the Marshall Plan Committee to Congress on Dec. 17, 1948—the scene of the Pilgrims Society crime against humanity.

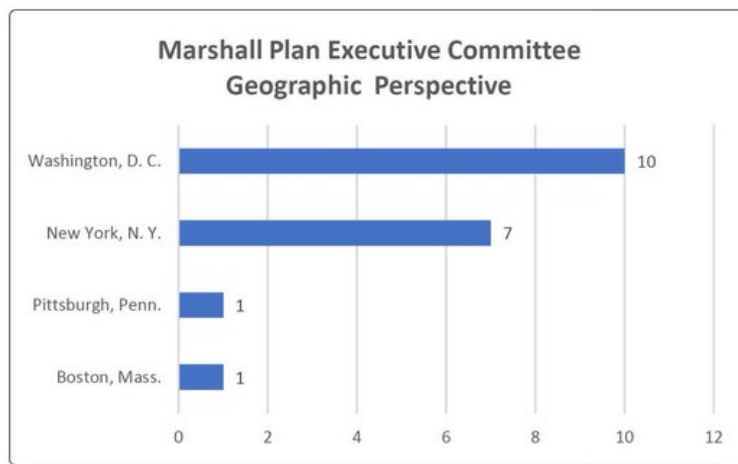


Fig. 22—GEOGRAPHIC REPRESENTATION ON THE MARSHALL PLAN EXECUTIVE COMMITTEE - DEAN ACHESON Statement. (Dec. 17, 1947). H.R. 480, H.R. 4579, Pt. 1, Dec. 17, 1947 to Feb. 12, 1948, US Foreign Policy For A Post-War Recovery. Marshall Plan funding. U.S. House, 80th Cong., 1st and 2nd Sess, pp. 689-694, p. 84 of ANALYSIS. GPO.

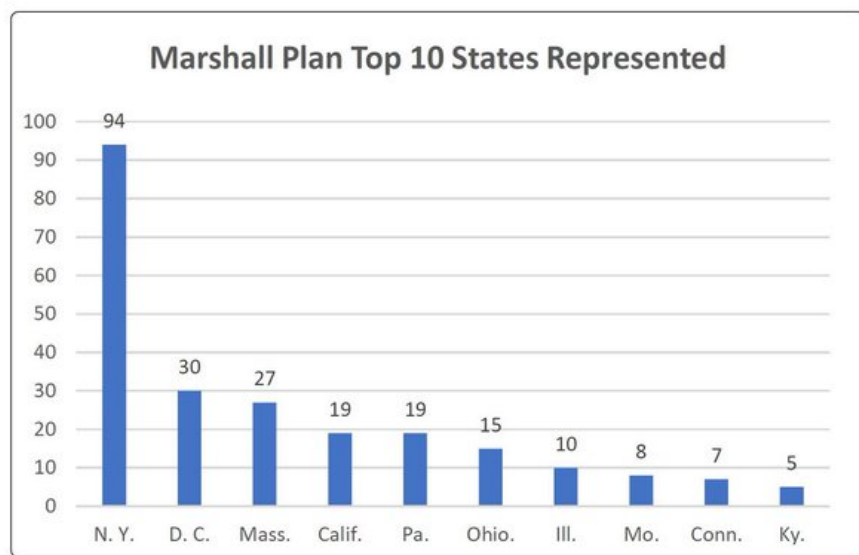


Fig. 23—U.S. STATES REPRESENTED ON THE MARSHALL PLAN COUNCIL - [DEAN ACHESON Statement. \(Dec. 17, 1947\)](#). H.R. 480, H.R. 4579, Pt. 1, Dec. 17, 1947 to Feb. 12, 1948, US Foreign Policy For A Post-War Recovery. Marshall Plan funding. U.S. House, 80th Cong., 1st and 2nd Sess, pp. 689-694, p. 85 of ANALYSIS. GPO.

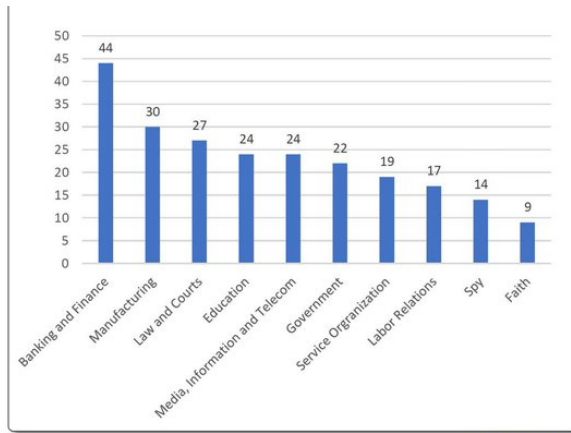


Fig. 24—U.S. STATES REPRESENTED ON THE MARSHALL PLAN COUNCIL - DEAN ACHESON Statement. (Dec. 17, 1947). H.R. 480, H.R. 4579, Pt. 1, Dec. 17, 1947 to Feb. 12, 1948, US Foreign Policy For A Post-War Recovery. Marshall Plan funding. U.S. House, 80th Cong., 1st and 2nd Sess, pp. 689-694, p. 85 of ANALYSIS. GPO.

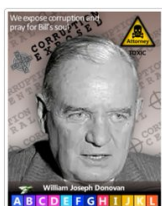
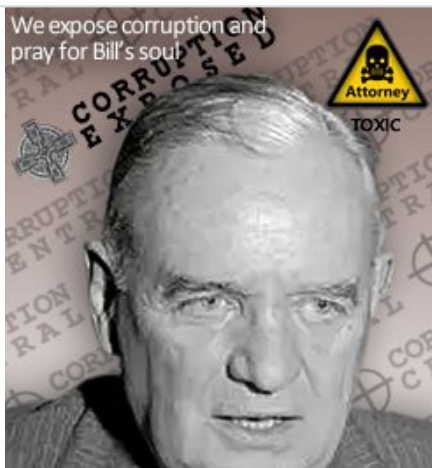



Fig. 25—William Jacob Donovan, Mafia boss of the OSS, CIA and the Anglo-American (British) Pilgrims Society

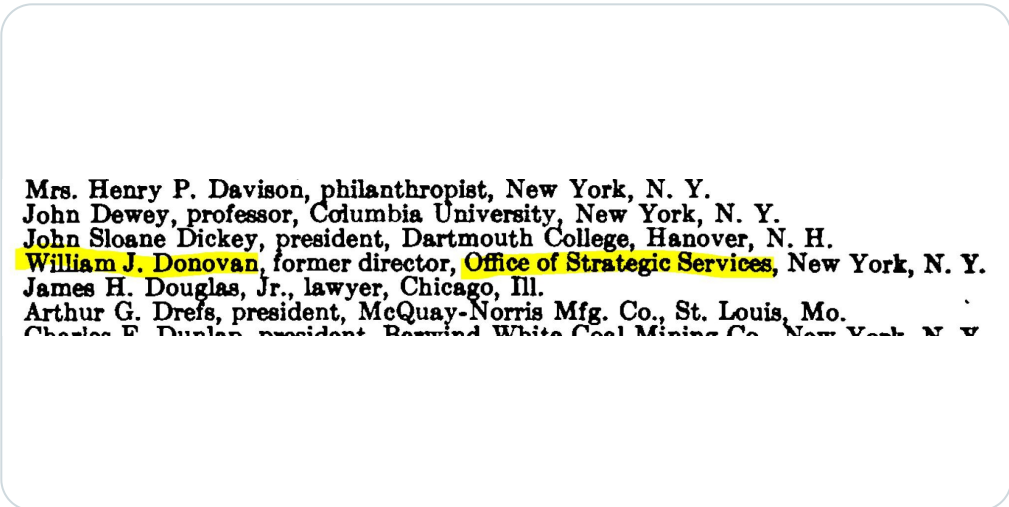

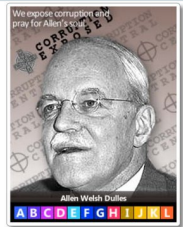


Fig. 27—Allen Welsh Dulles. "A RESUME TOO LONG TO BE REAL without being a groomed member of the Pilgrims Society"

Under these circumstances, it is scarcely surprising that implementation of Safehaven measures depended largely on the personalities of the OSS Chiefs of Station and the conditions under which they operated. In Bern, the heart of the Swiss banking and German gold transfer activity, the OSS chief was Allen W. Dulles, later to become Director of Central Intelligence from 1953 to 1962. An East Coast Brahmin with extensive prewar ties to European banking circles, Dulles spent his tenure in Bern constructing an "Old-Boy" network of sources that extended throughout neutral and Axis-occupied Europe. It was an astonishingly successful system, ideally suited to his situation in neutral Switzerland and well-conceived to gain access to European government and business circles. For example, Dulles counted among his close personal friends no less than Thomas B. McKittrick, President of the Bank for International Settlements (BIS) in Basel. McKittrick also was an OSS source who provided Dulles with "comfortable access" to the thinking of the bankers most responsible for moving German assets throughout Europe.³

Fourth, the United States lent its military, material, and moral might to the free world's fight against Nazi tyranny and led the magnanimous effort to rebuild post-war Europe through the landmark Marshall Plan. It is fair to conclude that on the Nazi gold and assets issues addressed by this report, the role of the U.S. was also positive. The U.S. Government took the lead in economic warfare against the Axis by initiating the Safehaven program with our Allies. The U.S. scored significant successes in blocking German assets from leaving this country and in tracking the flow of Nazi assets, particularly looted gold, to prevent any Nazi resurgence after

Truman, Churchill, and Attlee also reached agreement at Potsdam on a common policy for the disposition of the monetary gold found in Germany (estimated to be at least \$250 million in the U.S. Zone alone, some \$2.4 billion today), as well as the gold that Germany had sold abroad to finance its war machine. They adopted an American proposal to establish a "gold pot" into which the Allies would collect all the looted monetary gold from Germany and from the neutrals, and distribute the resulting amount to the former occupied nations from whose central

banks monetary gold had been looted. (By "monetary gold," the Allies had in mind gold that had been wrongfully removed from central banks—as distinct from "non-monetary" gold owned by individuals). **Stalin unilaterally abandoned all claims to the gold found** by his Western Allies (but of course the Soviet Union controlled and plundered much of the remaining wealth of the countries the Red Army occupied).

To force Swiss cooperation in these matters, Treasury Assistant Secretary **Harry Dexter White** insisted that Swiss funds remain blocked in the United States until the Swiss provided iron-clad guarantees that they would identify and seize all accounts under German control. He **estimated at \$500 million** the sum of German assets in Switzerland, **excluding numbered accounts and cloaked assets.**¹

American negotiators had the benefit of two comprehensive appraisals of German gold movements during World War II including the sales of gold to and through Switzerland. A summary chart by Otto Fletcher, Special Assistant to the Division of Economic Security Controls of the State Department, demonstrated from information in captured Reichsbank ledgers that Germany, whose estimated gold reserves at the beginning of the war was **\$120 million,**² **acquired another \$661 million** in monetary gold during the war most of which was looted. According to the Fletcher chart, **all of the gold sold by Germany after early 1943 was looted gold.** The amount of **\$276 million in gold** was sold to the Swiss National Bank during the war, and **"the larger part was looted gold."** An additional **\$138 million** was **"washed through"** the Swiss National Bank and eventually sold to Portugal and Spain. This made a total of **\$414 million in looted gold sold or transferred to the Swiss National Bank by the Nazis.** A separate analysis prepared by James Mann of the Treasury Department estimated the total monetary gold looted by Germany at **\$579 million out of a total of \$785 million available to Germany after June 30, 1940.** Mann determined, from available ledgers of the Reichsbank, that Germany exported "at least" **\$398 million** worth of gold during the war, and of this amount "an absolute minimum" of **\$185 million** must have been looted. Mann concluded that "on the fairest assumptions, the amount of loot [gold] taken by the Swiss from Germany can be estimated at 289 million dollars."³

Fifth, the report also deals with the hotly debated issue of whether some victim gold was sent to Switzerland and other neutral countries, and whether it was also included in the **TGC Gold Pool.** This was the Pool into which looted central bank gold was **placed for redistribution by the TGC to the governments from which it was stolen during the War.** This study concludes that both occurred. **The Reichsbank or its agents smelted gold taken from concentration camp internees, persecutees and other civilians, and turned it into ingots.** There is clear evidence that these ingots were **incorporated into Germany's official gold reserves,** along with the gold confiscated from central banks of the countries the Third Reich occupied. Although there is no evidence that Switzerland or other neutral countries knowingly accepted victim gold, the study provides clear evidence—on the basis of the pattern and practice of Reichsbank gold smelting, the **co-mingling of monetary and non-monetary gold,** gold transfers and an analysis of a shipment of looted Dutch gold—that at least a small portion of the gold that entered Switzerland and Italy included non-monetary gold from individual civilians in occupied countries and from concentration camp victims or others killed before they even reached the camps.

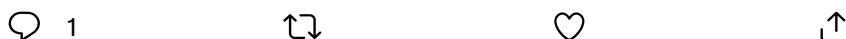




Fig. 28—Paul Adolph Volcker, Jr.





Fig. 29—Henry Alfred Kissinger.

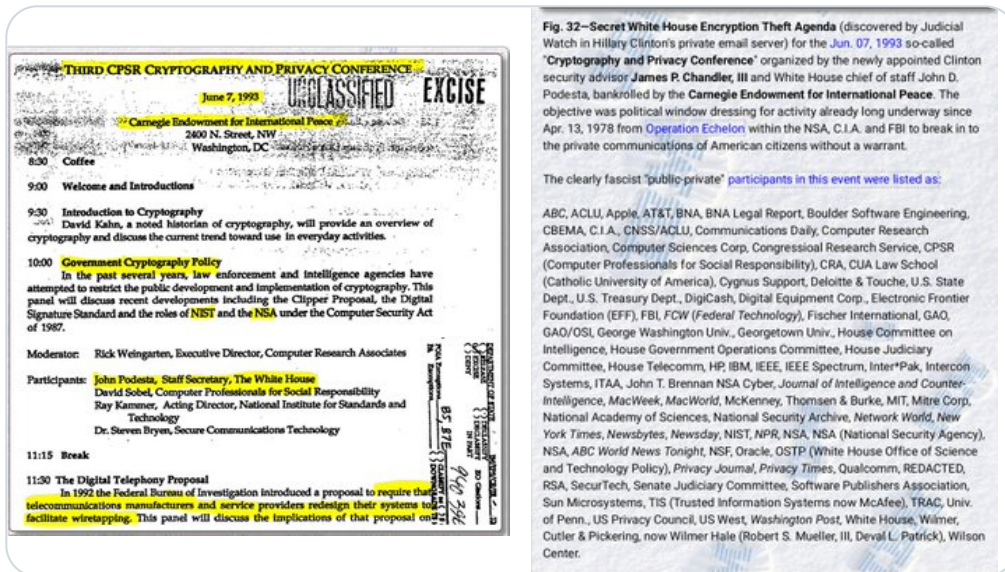

Previous to these positions Podesta had been Counselor to Democratic Leader Senator Thomas Daschle (1995–96—while he worked for Clinton); Chief Counsel for the Senate Agriculture Committee (1987–88); Chief Minority Counsel for the United States Senate Judiciary Subcommittee on Patents, Copyrights, and Trademarks; Security and Terrorism; and Regulatory Reform; and Counsel on the Majority Staff of the Senate Judiciary Committee (1979–81).

On Jun. 07, 1993, Podesta and White House security advisor James P. Chandler, III organized a program to approve an FBI backdoor key to all encryption on the Internet. Volcker attended the London School of Economics (1951-52) which is a notoriously known training ground for British communists. He also worked in various positions up to vice president and director of Chase Manhattan Bank (Rockefellers, J.P. Morgan, Rothschild) from 1957-62, 65. His roles in gold manipulation are legion.
