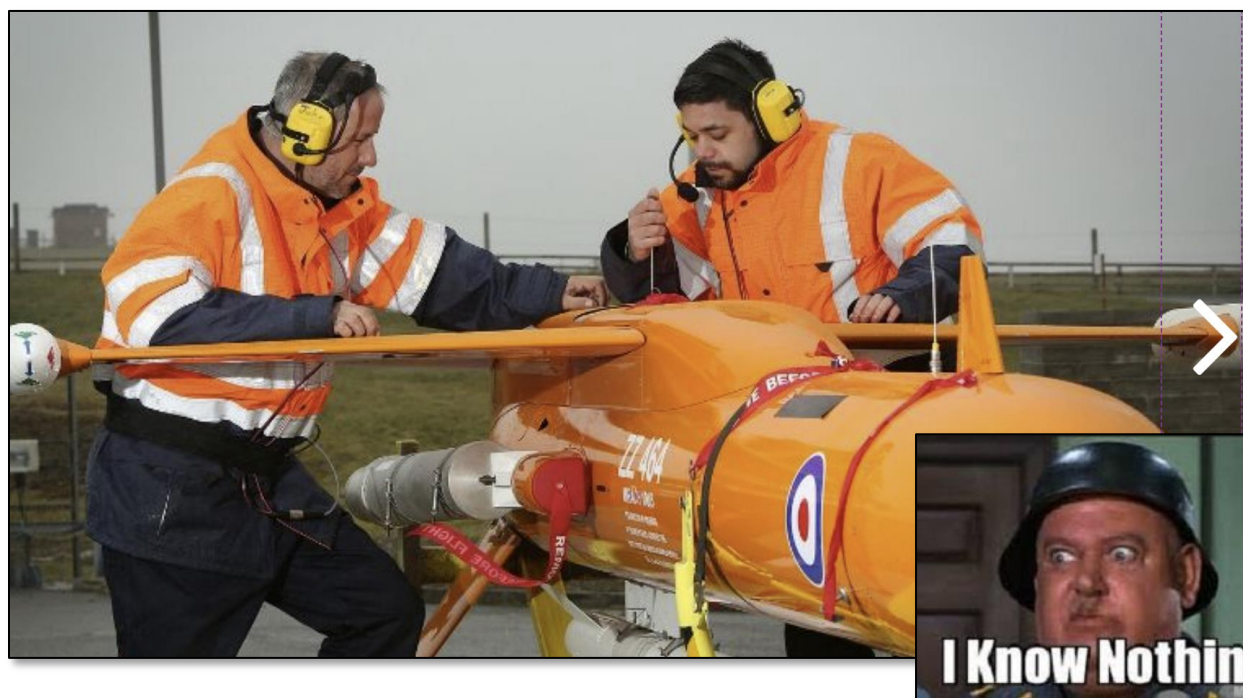


## Judicially-recognizable evidence that the American government is lying about an inability to track US military assets being shuffled to the Ukraine

The U.S. Army can track every piece of equipment in their inventory. They do it through a subcontract with a British company controlled by the British Crown—QinetiQ.<sup>2</sup>

“Keeping track of US Army equipment

Under the contract, QNA [QinetiQ North America] continues to meet the challenges of collecting data on all US Army equipment – ground combat systems, tactical wheeled vehicles and aviation systems – from across the US and all areas overseas in which the US Army has a presence QNA then provides the Army with timely and accurate logistics data for comprehensive studies and analyses.”<sup>3</sup>

[QinetiQ \(Co. No. 4586941\)](#) was founded on Nov. 11, 2002 on the Cobbett Hill Earthstation premises of The Pirbright Institute outside west London.

62% of QinetiQ’s shares were issued to the British Ministry of Defence [sic] and 34% went to US Carlyle Group who provided the initial capital. Nonetheless, on paper [sic] Carlyle seems to have been awarded 51% of the voting shares, yet the British Crown held one (1) super share sometimes called the “Golden Share” that could veto any policy or action in the company. The Pirbright property was donated to the government by Baron Henry de Worms (Lord Pirbright), a maternal Rothschild. Baron de Worms was a member of the Privy Council with Cecil Rhodes who co-founded DeBeers Gold and Diamond Mines with N.M. Rothschild and the Rhodes Scholarship at Oxford. Lord Pirbright was teamed with his relative Lord Walter Rothschild and Lord Rosebery (who inherited the N.M. Rothschild fortune and became prime minister (1894-1895)).

The Pirbright complex is now controlled by UK Government’s Biotechnology and Biological Research Council ([BBSRC](#)). In turn, [UK Research and Innovation](#) oversees BBSRC. BBSRC was created by SERC in 1994.

Earlier, in 1986, SERC was defunded as a public entity by [Sir Geoffrey E. Pattie](#) who: (1) formed SERCO as an ostensible private entity, (2) merged RCA and Marconi military and telecommunications assets into SERCO, (3) took control of Marconi Wireless who had taken control of RCA, AT&T, Western Electric, Westinghouse and the United Fruit Company in 1919, and (4) merged Marconi Wireless into General Electric Company (UK).

Sir Geoffrey was at that time the Minister of Trade and Industry, and thus the overseer of the Crown's "Golden Share" controls over all key British industries. Sir Geoffrey is also a leader within the British Pilgrims Society, teamed with [Lord Mark Malloch-Brown](#), the infamous owner of Dominion Voting Systems and George Soros' ubiquitous partner.

On Aug. 02, 2007, the Merial Animal Health Institute at Pirbright [dumped foot-and-mouth pathogens](#) into a Pirbright storm drain on the property. This act triggered a 5km lockdown and the incineration of 50 cattle. After this release (judged "sloppy" by a subsequent inquiry), Merial moved its facility to Nanchang, China--just 233 miles from Wuhan.<sup>4</sup>

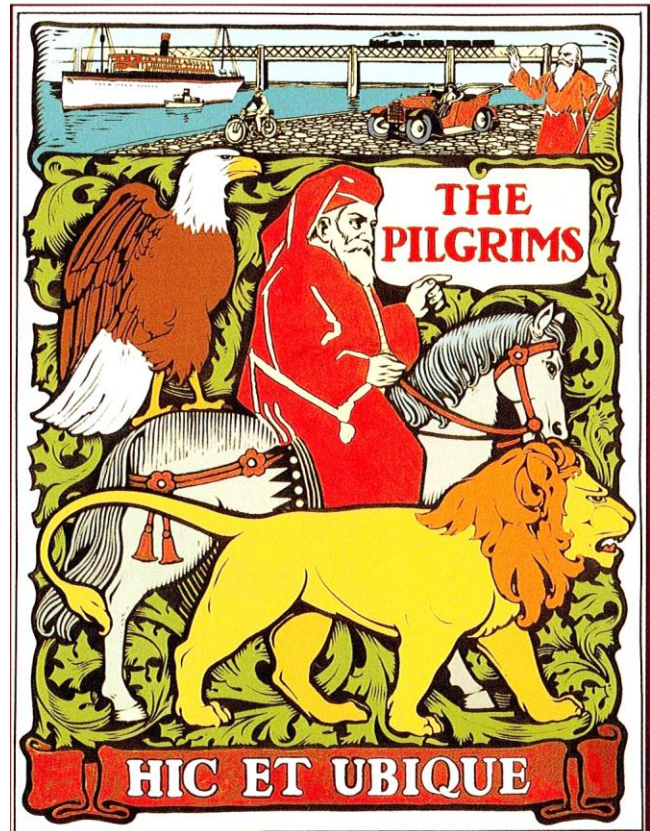
Was the Merial release a false flag excuse to move its manufacturing facility to China? Hindsight is 20-20. That is what they did.

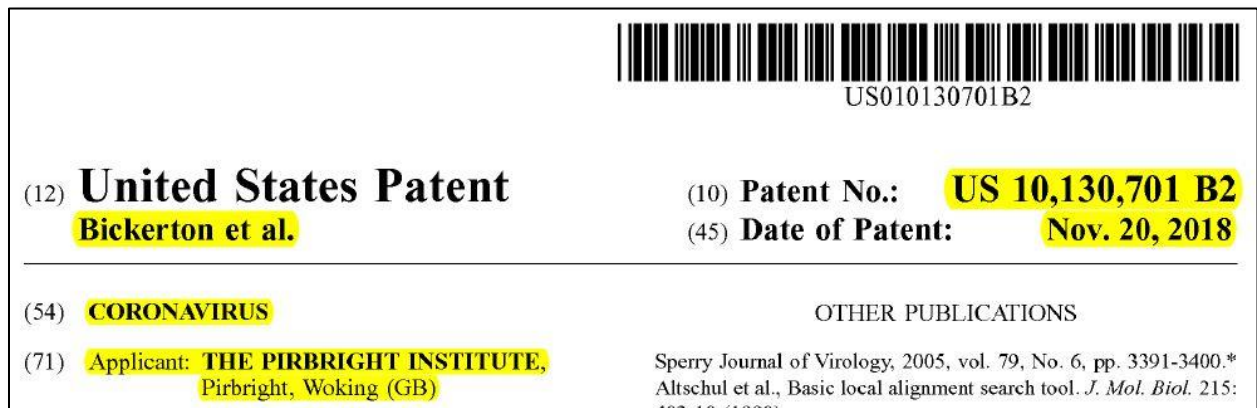
Pirbright's online obfuscation plays on the public's ignorance about patenting requirements, namely an applicant's duty of candor and good faith during the patenting process, or omitting

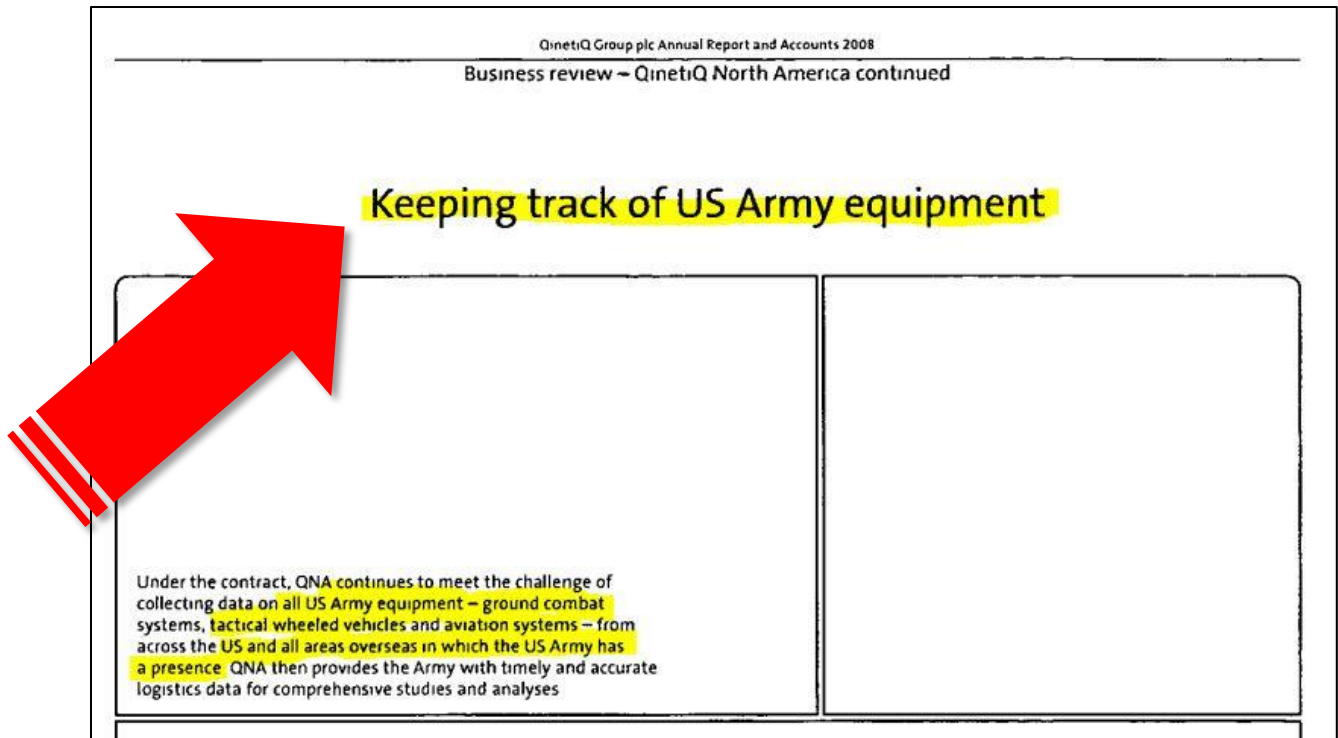


Fig. 28—[QinetiQ Group Plc, Co. No. 4586941. \(Aug. 07, 2008\)](#). Annual Report and Accounts, p. 17 (PDF p. 21), Keeping track of US Army equipment worldwide. Companies House (UK).
