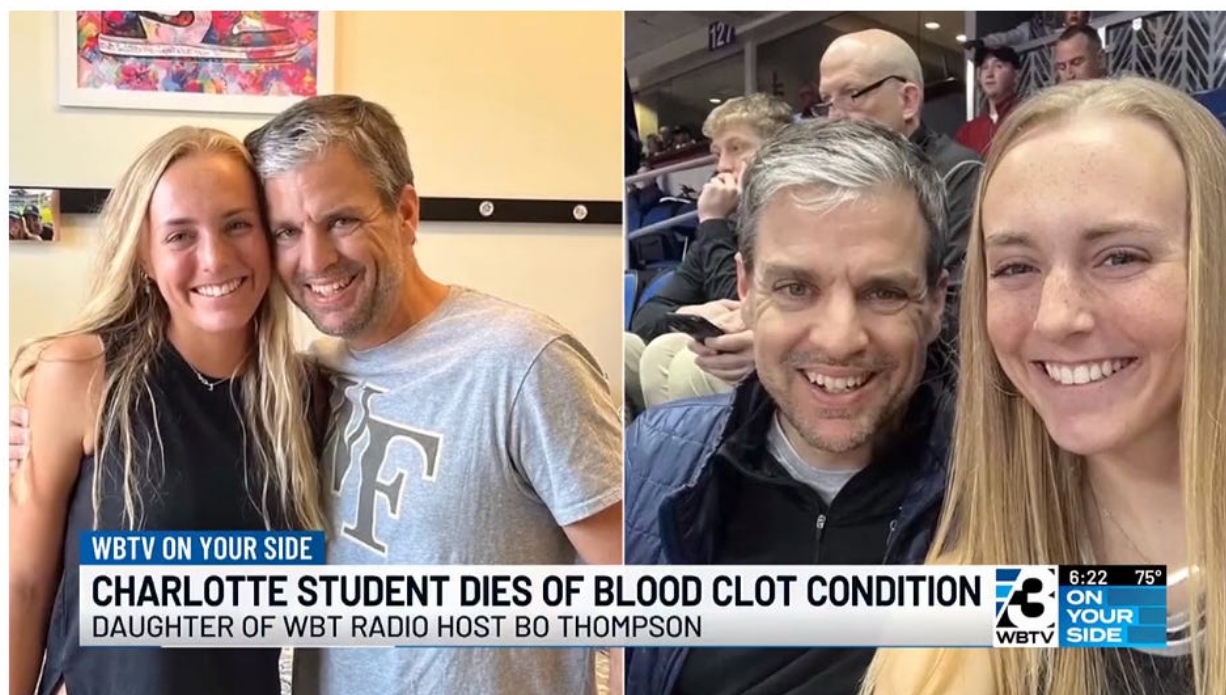

CHARLOTTE, N.C. (WBTV) – Janey Thompson, the daughter of WBT Morning Show Radio Host Bo Thompson, has passed away after suffering complications from a blood clot, according to the radio station.

Janey died on Tuesday, April 9. She was a sophomore at Wake Forest University and was a biophysics major.

While at Wake Forest, she was a member of the National Society of Physics Students, Sigma Pi Sigma, and Delta Delta Delta sorority.

She was a 2022 graduate of Myers Park High School where she played varsity basketball and softball.

The radio station released the following statement regarding the passing of Janey:

The WBT and Radio One family is deeply saddened by the tragic passing of Bo Thompson's daughter, Janey. There are no words to provide adequate comfort under these circumstances, but we are committed to supporting Bo and his family in any way possible during this difficult time. Update on COVID-19 vaccine guidelines

April 20, 2023

The Campus Health Committee has announced a change in Wake Forest's vaccination requirements: Effective May 12, 2023, Wake Forest will strongly recommend that all faculty, staff and students remain up to date with COVID-19 vaccines, including variant-updated boosters. **The University will no longer require proof of COVID-19 vaccination status.** This change aligns with the expiration of the federal Public Health Emergency for COVID-19 on May 11, 2023. 18 year old Janey Thompson was a fit, high level athlete who played varsity basketball and softball. In the fall of 2022, she was accepted to Wake Forest University (biophysics major) and was required to produce proof of COVID-19 Vaccination Status to attend University.

The COVID-19 Vaccine Mandate was dropped as of May 12, 2023.

Janey, a high level athlete, died less than a year after the mandate was dropped, from a blood clot that "traveled from her leg to her heart", blood clots being one of the more common side effects of COVID-19 Vaccines.

Bryce Stanfield: Cause of death released for football player from Acworth

COBB COUNTY, Ga. - The official cause of death has been released for the football player from Acworth who died after a medical emergency during a workout at Furman University in South Carolina.

21-year-old [Bryce Stanfield](#), a junior defensive lineman, died Feb. 9 after he collapsed at Paladin Stadium.

An autopsy revealed that Stanfield's cause of death was a **pulmonary embolism and it was not related to football**, according to [The Post and Courier in Greenville](#).

Stanfield, who was a health sciences major, reportedly had no signs of sickness or injury besides a strained back muscle before the workout, according to the school's head coach.

After he collapsed on Feb. 7, he was placed on life support at Greenville Memorial Hospital. He passed away on Feb. 9.

Stanfield attended Harrison High School in Kennesaw. He had 25 college offers before he chose Furman. He played in all 13 games of the Paladins' 2023 season that included a SoCon championship, eight consecutive victories, and FCS quarterfinal round playoff appearance.

Wofford College and Furman University are the only colleges in South Carolina mandating COVID-19 vaccinations for students enrolling for fall classes. For state-supported institutions, there is no such requirement despite the American College Health Association's recommendation that colleges implement COVID-19 vaccination directives for all on-campus students, barring those with medical exemptions.

In The State, Clinton Colmenares, Furman's director of news and media strategy, said, "We saw what was happening nationally and took into consideration the advice from the CDC and the state. We want to get back to normal operations and really the best way for us to do that is to require vaccinations." The State reported that students may request an exemption from the requirement for religious or medical reasons, or due to a "strong personal objection," Colmenares added.

The State reached out to other schools in South Carolina, both public and private. A subscription is required to view the full article.

COLORADO SPRINGS, Colo. (KCTV) - A nursing student passed away on the campus of the University of Colorado Colorado Springs (UCCS) this week.

A message went out to the UCCS community from Chancellor Jennifer Sobanet on the passing of Mia Brown.

I am writing to share the sad news of a loss to our campus. UCCS senior Mia Brown died on Monday, February 12 following a medical emergency at the Recreation Center. She was a dedicated nursing student who was highly involved on campus, and she will be very missed. Memorial services are still pending, but more information will be available in the days to come."

A spokesperson for the college said many staff and students immediately provided first aid before paramedics arrived.



Tragically, Mia's life was cut short just before her 22nd birthday which would have been celebrated on Feb. 25.

The university's COVID-19 vaccine requirement for students, faculty, and staff **ended effective May 15, 2023**, but we continue to strongly recommend COVID-19 vaccinations for all in our campus community as a safe, effective tool for minimizing the effects of COVID-19.

4/12/23: SUNY Announces the End of the Emergency COVID-19 Vaccine Mandate

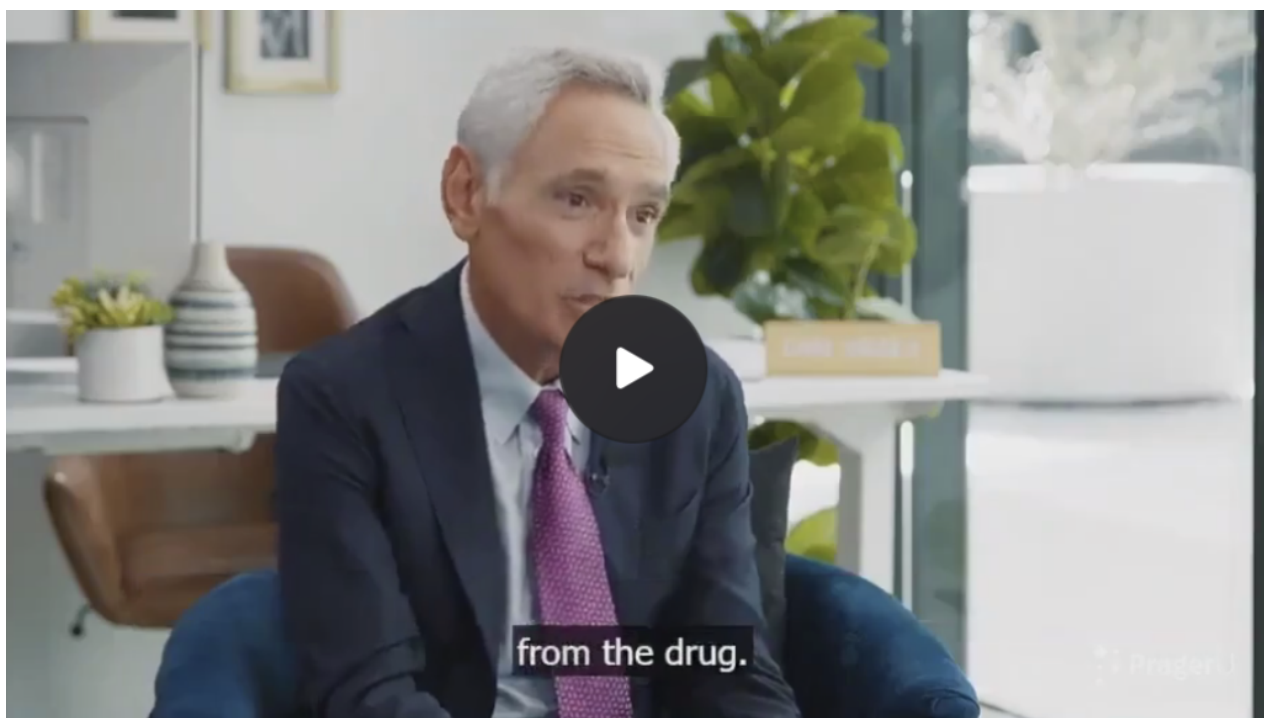
