

JOHN WAYNE GACY

ANOTHER CLOWN PSYOP

John Wayne Gacy, a.k.a. “the killer clown”, is famous for raping, torturing, and murdering **33** boys and stuffing their bodies in the crawl space beneath his house. That numerology marker alone is enough to expose Gacy’s story as another shabby Intelligence script, which is what I assumed going into this one. Like *every other serial killer story* we’ve studied – including [the Tate murders](#), [the Zodiac killer](#), [the World’s Fair serial killer](#), [the Cheshire murders](#), [Henry Lee Lucas](#), [Aaron Schaffhausen](#), [Lizzie Borden](#), etc. – this one’s another big fake designed to make you more fearful, to split the sexes, and to make you suspicious of everyone, especially the unassuming man who lives next door. You should trust politicians, doctors, pharmaceutical execs, bankers, celebrities, and every bobblehead on TV, but your own neighbor you should hold in extreme suspicion, never letting your kids play outside and keeping your doors locked at all times.

So let’s make quick work of this one. Aside from that conspicuous 33, we’re also told Gacy spent **18** months in jail beginning in 1968 for sodomizing a teenage boy. Those two numbers – 33 and 18 – appear within the first few paragraphs of his Wikipedia page and then get repeated several times, just to make sure you don’t miss them. We also get **March 13** as the date of his death sentence, a date we have tripped across before, including the fake assassination of Czar Alexander II and the fake shooting of [Breonna Taylor](#). Anyhow, you should find it odd that Gacy only spent 18 months in jail for sodomizing a minor. He was sentenced to 10 years but made parole after just a year and a half? The victim’s name was Donald **Vorhees**. That name is a huge red flag in this case, since [Voorhees have been involved in several of these projects](#), including the Black Dahlia murders and the Catholic sex abuse scandal. The Voorhees go back to the founding families of New York in the 1600s and include Daniel Wolsey Voorhees, chair of the Senate Finance Committee in the 1880s. His son was Charles Stewart Voorhees, which links us to Gacy,

whose father was John **Stanley** Gacy. Remember the Stanleys and Stewarts of the peerage are essentially the same family. Daniel Wolsey Vorhees links us to the prominent Woolseys, another founding family of New York that spawned many politicians, military officers, a Yale president, and a **director of the CIA**.

What they conveniently fail to mention on Gacy's Wikipedia page is that his first victim was not some no-name kid, but in fact the son of an Iowa Congressman, Don Vorhees Sr. Here's where the story begins to fall apart. Gacy met Don Sr. through the Waterloo, Iowa chapter of the Jaycees (Junior Chamber), where they were both members. Gacy was vice president and served on the Board of Directors. The Junior Chamber is a civic club founded in 1920 by Henry Giessenbier, a **banker of Swiss ancestry**. It appears to be a major spook feeder club, with past members including Bill Clinton, Gerald Ford, Bill Gates, Al Gore, Howard Hughes, Charles Lindbergh, Richard Nixon, Elvis Presley, and Ronald Reagan. The Waterloo chapter was apparently just a hangout for perverts and druggies, as Wikipedia tells us:

Gacy and other Waterloo Jaycees were also deeply involved in wife swapping, prostitution, pornography, and drug use.... Gacy lured Voorhees to his house upon the promise of showing him heterosexual stag films regularly played at Jaycee events.

Say what?? I hope you see the problem here. If Don Sr. the Congressman was part of this club, he would have been carousing in these orgiastic club meetings, too, and potentially "wife-swapping" and participating in circle jerks with the likes of Gacy and others. But suddenly Gacy touches his son and Don Sr. is outraged? Also, do you think Don Sr. would have involved police in the incident, since it would risk exposing the Jaycee club's lascivious doings and thus tarnish his own public image? I'm sorry, but if you don't want your son molested by a pervert, don't hang out with a bunch of perverts.

Let's be clear, Gacy probably was a pervert. That's what these spook clubs are mostly about – they're modern gymnasiums where older gay elites "mentor" younger gay elites. They want us to believe the Jaycees sat around watching straight porn and swapping wives, but you can bet it was strictly a sodomite gathering. If Gacy did have an encounter with Don Jr., I'm sure it didn't happen the way we're told. Wikipedia tells us Gacy

...persuaded him to engage in mutual oral sex, adding "You have to have sex with a man before you start having sex with women." ... Gacy tricked several teenagers into believing he was commissioned to conduct homosexual experiments in the interests of scientific research, and paid them up to \$50 each.

Again, what? As a straight man, I can't make any sense of that. I don't know any straight guys who would be "tricked" into performing "homosexual experiments", nor could I ever be persuaded to perform gay acts. Mind you, that is the word used here – it says that Don Jr. was "persuaded" to go down on Gacy, not that he was forced or coerced into it. In any event, all this encounter proves is that Gacy was a pervert who hung out with a bunch of elite perverts.

Which prompts the obvious question: was Gacy also from an elite family? We're told his father was an auto mechanic and the son of poor Polish immigrants. Gacy himself allegedly never finished high school. Yet by his mid-20s he was the third-ranked Jaycee in the state of Illinois and was rubbing shoulders (and possibly other body parts) with a Congressman. By his mid-30s

he was **getting his picture taken with First Lady Rosalynn Carter** – see the picture at the top of this paper, which was taken just seven months before his final arrest. Sort of curious, don't you think?

We are told that, despite failing high school, Gacy somehow enrolled at Northwestern Business College and graduated at age 21. We're later told that Gacy completed 16 high school courses in less than one year while he was in jail for assaulting Vorhees. Why go back and complete high school if you already had a business degree? More sloppy Intelligence writing.

But back to the question – did Gacy have elite family connections? Tim Dowling has done [Gacy's genealogy](#), admitting he and Gacy are distant cousins, which itself is a huge red flag since Dowling is related to all the top peerage families – particularly the Stewarts. We get some big hits starting with Gacy's mother, Marion Elaine **Robison**. Robison is just a variant of Robinson, who we saw in both the Salem Witch and Lizzie Borden hoaxes. Also, Walter Voorhees Robinson of the Catholic sex scandal already mentioned – which may link Gacy to his alleged first victim. We also get Richardson, Corey, **Drake**, Savage, Hicks, **Gray**, Bailey, Taber, Smith, Manchester, Waite, Wood, Wheaton, and Hillard. Gray appears in two separate family lines, one of which we can trace back to Plymouth, Massachusetts. These Grays are related to Bradfords, Anthonys, Winslows, Southworths, Hungerfords, Arnolds, Littles, **Gates**, Bosworths, **Spencers**, **Cones (Cohens)**, Watermans, Walkers, Dunbars, Peabodys, Ladds, and **Lettices**. Lettice is a prominent peerage name – think Lettice Knollys, mother of Robert Devereux, 2nd Earl of Essex. Gacy's ancestor Thomas Lettice [is actually in the peerage](#), where we find out his wife's name is Anne **Savoy**. These Lettices are related to Jenneys, Bonhams, Barlows, Jacksons, Shurtleffs, Lothrop, Barnes, Kimballs, Cookes, Bartletts, Smiths, and Coles. Through his ancestor Thomas Drake, Gacy is related to Sir Francis Drake. Through his Savage line, he is related to Sir John Savage, whose wife was a Stanley, daughter of Lord Thomas Stanley.

At Geni.com we can take his Bailey line even further back, hitting Parsons, Langestons, Hydes, Yates, Lyons, and Booths, including his ancestor Sir Robert Booth. These Booths are related to the Savages and Stanleys above, as well de Venables, Barons of Kinderton, Houghtons, Traffords, and Radcliffes.

So yes, Gacy did have family connections to the very top levels of the British peerage. He also had Jewish blood, being a Cohen. But being connected to the top of the peerage is also proof of his Jewish ancestry, since all the top peers are also Jewish, as Miles has shown again and again.

But I want to focus on [his Gates relatives](#), who are related to Hungerfords, Spencers, Fullers, Cones, Brainerds, Olmsteads, Stewarts, Footes, Ushers, and Bigelows. The Spencers here are the same that spawned William Spencer Churchill and Lady Diana, so yes, they are *those* Spencers. This connects Bill Gates to Spencers, and both the Gates and Spencers to Cohens, meaning they are all Jewish. But notice the similarity between the names Gacy and Gates. Could the Gacys have been Gates further back, or vice versa? Gacy's paternal line dead-ends after his grandfather. In fact, we are supposed to believe they don't even know what Gacy's father's name was, with his middle name being given variously as Stanley, Samuel, and Wayne. Some sources say John Wayne Gacy was a junior, having his father's full name, while others deny this. Strange that such basic information on such a notorious person is still disputed...or not. We do learn that Gacy's [grandfather](#) was originally Nicholas **Gatza** from Poznan, Poland. Gatza is even closer to Gates. [According to WikiTree](#), the first two “related surnames” to Gatza are...Gates and Katz. And guess where the name [Katz comes from](#)? It's a diminutive of **Cohen**! So Gacy's family tree gives us a tight circle here, since it includes all of them: Gatza, Gates, and Cohen.

This is a huge revelation, and you should file it away for future research: **Gates = Cohen**. They also admit Gates and Yates derive from the same surname, and [Yates is a known Jewish name](#). Ditto for Yeats, as in William Butler. Miles has already hit Yeats several times.

Back to the story. We are told Gacy was released from Iowa prison on probation under the condition that he had to move in with his mother in Chicago. Have you ever heard of such a thing? No, because a standard rule of probation is that you cannot move out of state. You have to apply for something called an interstate compact transfer, and even then it can be rejected. While still on probation in Chicago, Gacy was charged with two accounts of sexual assault, both of which were dismissed in court, and “the Iowa Board of Parole did not learn of these incidents”, according to Wikipedia. Shortly after, his parole ended and “records of Gacy's previous criminal convictions were sealed.” How convenient. But the story makes little sense, since court records in this case would be sealed to protect the identity of an underage victim, not to protect the sex offender's identity.

By this time Gacy had already divorced his first wife, Marlynn **Myers**, with whom he allegedly had two children, and in 1972 he married his second wife, Carole **Hoff**. Interesting that both his wives have Jewish last names, isn't it? As usual, they throw these Jewish names at you without ever admitting these people are Jewish. You're not supposed to realize that Gacy was actually a Katz/Cohen who married a Myers and a Hoff. Anyhow, this was just months after his first murder, according to the timeline. Gacy, Carole, and her two daughters lived together for several years at the house where Gacy allegedly raped, killed, and buried all his victims. The obvious question is, how did he get away with all these murders while his wife and two stepdaughters were living in the house? According to Wikipedia:

By 1975, Gacy had told his wife that he was bisexual. After the couple had sex on Mother's Day that year, he informed her this would be “the last time” they would ever have sex. He began spending most evenings away from home only to return in the early hours of the morning with the excuse he had been working late. His wife observed Gacy bring teenage boys into his garage and found gay pornography and men's wallets and identification inside the house. When she confronted Gacy about who these items belonged to, he informed her angrily that it was none of her business.

It is ridiculous to believe any of that, so don't. If all Gacy wanted to do is molest and kill teenage boys, why did he go through the trouble of marrying a woman? You might say it was because he got a thrill out of the possibility of being caught, but then why would he get angry when she started questioning things? And why would his wife continue to live with Gacy after finding out he was bisexual and wouldn't have sex with her anymore? By the way, being bisexual means you're still interested in women, so the whole story is nonsense. Worst of all, we are supposed to believe Carole didn't do anything after finding out her husband was gay and frequently hosted teenage boys in their garage. You might argue it was because she was in love with him and didn't want him to go to jail. But nothing about their marriage suggests there was any love lost there. This was her second marriage, they had gotten married quickly and had only been married a few years, and – oh yeah – they weren't even having sex anymore.

The more likely story is that they were never really married. She was just his beard for this project. Here's Gacy and Carole Hoff on their wedding day:




Notice how drastically the light exposure changes between his face and hers, indicating one or both of them were pasted in. That's why they had to blur the edges where their shoulders meet. There's no other explanation for that blur.

Then there's the whole problem of the smell of dozens of decomposing bodies in the crawlspace. You don't think Carole or her daughters would have noticed that? We'll be told he buried the bodies so there would have been no odor, except that they later claim the bodies did produce a noticeable smell. During the investigation, one of the detectives who was using Gacy's bathroom allegedly noticed "a smell he suspected could be that of rotting corpses emanating from a heating duct." Then we're told that "the officers who had searched Gacy's house previously had failed to notice this, as the house had been cold." Oh, okay. So they only smelled in summer. But Carole and her daughters lived at the house for several summers while these murders were happening. I guess they all had Covid and lost their sense of smell.

Also, when did Gacy have time to bury his victims in their crawlspace? Carole and her daughters never noticed all that time he spent down there? And what about the blood and other bodily fluids – did Gacy just have really good carpet cleaner? Again, none of this is feasible in the least. I can't eat a piece of chocolate without my wife smelling it on my breath. Yet Gacy carried out 33 rapes and murders under his family's nose? Absurd.

Given all this, we must assume the victim list was cobbled together from existing death lists or just fabricated entirely. For the sake of time, let's just look at his most publicized victim, Robert Jerome Piest.



He was allegedly 15 years old when he was killed. Does that look like a 15-year-old to you? That dude could easily walk into a gas station and buy beer. He was an honor-roll student who worked part-time at Nisson Pharmacy. This connection to a pharmacy is an inside joke, as you're about to see. At findagrave.com, we find out Robert's paternal grandmother was named Anna Gajewski. Look at that name again. Ga-JEW-ski. Kidding aside, the name may link him to Nazi businessman [Fritz Gajewski](#), an executive at IG Farben during WWII. He was arrested and prosecuted in the 1947 IG Farben trial, but like all the other crypto-Jews who ran the Nazi military-industrial complex, he was acquitted and went right back to chairing the boards of several pharmaceutical corporations. Fritz's wife was a Seckler, an Ashkenazi surname, though apparently that didn't bar him from joining the Nazi party. I don't think it's a coincidence that we're told Robert Piest worked at a pharmacy. It's a clue the scriptwriters inserted to link him to his great-grandfather Fritz, who also started as a "poor apprentice" at a pharmacy and later became a Nazi pharma exec.

The Piests come from La Porte County, Indiana, and [if you trace them back](#), you get a link to Glassmans (Jewish). [These Glassmans](#) come from Posen, Germany, a.k.a. Poznan, Poland. Same city that Gacy's grandfather comes from. Just another clue that everyone involved in this project was working for the same side and were probably all related.

I can't resist doing one more victim. This one is easy, since his name is [William George Bundy](#). Do you get it? Two of the top dogs in the CIA during the 50s and 60s were brothers William and McGeorge Bundy. Either Intelligence inserted this name as a joke, or they really did use one of their kids or nephews for this project. I'm actually inclined to believe the latter, given how similar they look:



I took the first two photos from Miles' [paper on Ted Bundy](#), where he noted a close facial match between William (left) and Ted (center). On the right is Gacy's victim William Bundy, who is a *very* close match to Ted. Aside from the part in their hair being reversed, William's picture would easily pass as a photo of a teenage Ted.

Moving on, Gacy's attorney was Gregory Adamski, which is a Polish-Ashkenazi name. Was everyone assigned to this project a Polish Jew? Anyway, he may link us to George Adamski, the first person to have claimed contact with UFOs, sparking the ufology craze of the 1950s. George Adamski came out of the military and pushed the fake theosophy movement, starting a cult outside San Diego, which just happens to be stiff with military bases. He once told friends that the year 1933 was when he "had to get into this saucer crap". Had to—as in, assigned to it. Gacy's other attorney was Adamski's wife, Karen Conti, photographed here with Gacy:




We're told Conti and her husband decided to defend Gacy because they were both strongly against the death sentence, not because they believed he was innocent. So tell me, if you knew this guy was a serial rapist and brutal murderer of underage boys, would you sidle up that close to him for a picture? And looking that happy? Of course not.

Here is Gacy's mugshot from his final arrest in '78. Actually, here are his *two* mugshots:



Yes, there are apparently two versions of his mugshot – just check the dates. One set was taken on 12/21, and another was taken on 12/22. The booking number is different, too – so I guess he was arrested twice. Or they’re just messing with us.

Now look at these photos from the crime scene investigation. Do you notice something amiss?





Why are they carrying out decomposing body parts in bedroom sheets? Without any gloves or facemasks? And why is that man wearing a football jersey? If they're assisting in a crime scene investigation, shouldn't they be wearing some sort of official garb? Did they just grab the next door neighbor and ask him to lend a hand? The next one's even more absurd:



You really think it was standard procedure to handle a corpse's dental remains with bare hands? This was 1978. And do you really think that guy would *want* to handle them with his bare hands? And who are all these other plainclothes jokers standing around? No uniforms, no badges or IDs of any kind? This was not a crime scene, it was a film set.

Now let's see what the people search engines turn up. At Intelius, a search on John Gacy in Illinois turns up two results, which I've screen captured in case they scrub it after this:

The first result shows Gacy at the age he was when he was allegedly executed in 1994. The second result shows the same Gacy, except that he's 69, which would have been his age in 2011. You could argue that the databases had a duplicate that didn't recognize he died and kept

counting his age. In that case, why did it stop counting his age in 2011? Somebody named John Wayne Gacy must have died in 2011, or it would still be counting his age. The simple answer is that they manually created a duplicate to show him dying in 1994 but never scrubbed his original file. What this means is that Gacy actually did die...in 2011. Where was he? Best guess is Los Angeles or Birmingham, since his duplicate file shows him living in those places even though he never did according to his official biography. If you happen to live in LA or Birmingham and ever saw someone who looked suspiciously like Gacy, well, you probably did see the real him.

To close out, we should ask ourselves: why the clown theme? Other than the creepy factor, why did Intelligence put it in the script? I think it's a marker linking us to the hidden elites who script out most of our history. Just read one of the first things Wikipedia mentions about [clowns](#):

The most ancient clowns have been found in the Fifth dynasty of Egypt, around 2400 BC. Unlike court jesters, clowns have traditionally served a socio-religious and psychological role, and traditionally the roles of priest and clown have been held by the same persons.

How fitting, then, that Gacy is really a Katz/Kohen, meaning he was from the corrupt priestly caste of Israel. Priests and clowns seem like opposites at first, one representing the sacred and the other the profane. But they are two sides of the same Phoenician coin, the stage left and stage right of the same theater, and they are played by the same actors. Both priests and clowns have always been the domain of Jews/Phoenicians. A look at the history of modern clowns confirms this. The modern clown traces back to Joseph Grimaldi, an English actor and comedian from the early 1800s.



Amazingly, they don't admit he was from the infamous House of Grimaldi, a Genoese noble family known for **banking and maritime trade**, a.k.a. Phoenician Navy. Wikipedia tries to tell us his great-grandfather was a dentist named "John Baptist Grimaldi" who emigrated to England from Italy, [but at Wikitree](#) his grandfather is listed as Giovanni Battista Grimaldi, pretty much admitting it's [this Giovanni Battista Grimaldi](#), Doge of Genoa. So much for hiding his tracks. The Grimaldis have ruled Monaco for centuries now; Grace Kelly's husband Rainier III was a Grimaldi.

The next famous clown in history was **George Washington Lafayette Fox**. Fox is a variant of Fuchs, a well-known Jewish name.



After Fox, we get Bozo the Clown, created by NBC executive Alan **Livingston**, and *Times of Israel* [admits Livingston was Jewish](#). So Livingston is really Levinson, from the tribe of Levi – a.k.a. the priestly tribe. Bozo was famously portrayed on TV by Frank Stevens, a.k.a. Frank Avruch, also Jewish.



So, what is the clown figure all about? It's a form of the [trickster](#), a common archetype in mythology and folklore. Tricksters “violate principles of social and natural order, playfully disrupting normal life and then **re-establishing it on a new basis**.” By contrast, the priestly role is meant to establish and promote order. It's their age-old game of *ordo ab chao*, where the priest signifies order and **the clown signifies chaos**. In other words, Gacy was just another agent of Operation Chaos.
